#### **SECTION A**

#### 1. BACKGROUND

The Social Housing Regulatory Authority ("SHRA") was established in August 2010 by the Minister of Human Settlements in terms of the Social Housing Act, No. 16 of 2008. The SHRA is classified as a public entity in terms of Schedule 3A of the Public Finance Management Act.

#### 1.1 MISSION

To ensure there is quality housing for lower to middle-income households in integrated settlements by investing in, enabling, regulating and transforming the social housing for rental market.

#### 1.2 VISION:

To create an integrated south Africa where citizens live a good quality life in well-located and affordable, quality rental homes.

#### 1.3 FUNCTIONS

- Promote the development and awareness of social housing by providing an enabling environment for the growth and development of the social housing sector.
- Provide advice and support to the Department of Human Settlements in its development of policy for the social housing sector and facilitate national social housing programmes
- Provide best practice information and research on the status of the social housing sector
- Support provincial governments with the approval of project applications by social housing institutions
- Provide assistance, when requested, with the process of the designation of restructuring zones
- Enter into agreements with provincial governments and the National Housing Finance Corporation to ensure the co-ordinated exercise of powers

#### 2. RFB SUBMISSION CONDITIONS AND INSTRUCTIONS

Documents submitted on time by bidders shall not be returned.

#### 2.5 LATE BIDS

2.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder.

Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

- 2.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)
- 2.5.3 Bids sent to SHRA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SHRA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

#### 2.6 DIRECTIONS TO SHRA OFFICE FOR DELIVERY OF BIDS.

2.6.1 Bidders should allow time to access the premises due to security arrangements that need to be observed.

#### 2.7 FORMAT OF BIDS

- 2.7.1 Bidders must complete all the necessary bid documents and undertakings required in this bid document. Bidders are advised that their bid should be concise, written in plain English and simply presented.
- 2.7.2 Bidders are to set out their bid in the following format:

Bidders must complete and submit the Invitation to Bid document.

#### Part 2: Pricing Schedule

Bidders must complete and submit the pricing schedule document.

The appointed Service Provider will:

- Claim travel costs applicable to this contract as per the AA rates
- Book only economy class flight and preferably Group A hire cars, otherwise Group B are to be used for Service Providers outside of Gauteng.
- Book only hotels, or other equivalent accommodation up to a Rand value of R1 400 per night per person (including dinner, breakfast and parking).

The value of this bid is estimated not to exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable

#### 2.10 REASONS FOR REJECTION

- 2.10.1 SHRA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 2.10.2 SHRA may disregard the bid of any bidder if that bidder, or any of its directors:
  - 2.10.2.1 have abused the Supply Chain Management systems of SHRA.
  - 2.10.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
  - 2.10.2.3 have failed to perform on any previous contract and the proof exists.
- 2.10.3 Such actions shall be communicated to the National Treasury.

#### 3. TERMS OF REFERENCE

#### 3.1 INTRODUCTION AND BACKGROUND

The Social Housing Regulatory Authority ("SHRA") was established by Parliament as prescribed by the Social Housing Act (16 of 2008). The SHRA is classified as a national public entity in terms of Schedule 3A of the Public Finance Management Act (1 of 1999) ("PFMA").

The SHRA's mandate is to invest in and regulate the social housing industry. The primary intention of the Social Housing Act is to deliver affordable rental housing to the low to medium income groups. The main aim of the SH Act is to achieve spatial, economic, and social integration of the urban environments in South Africa.

The SHRA is further mandated to approve projects and disburse the Consolidated Capital Grant (CCG) which is provided for in the Social Housing Act (16 of 2008).

#### 3.2 PURPOSE OF THE ASSIGNMENT

The SHRA seeks to appoint a panel of professional service providers to provide independent assessments of Organisational Due Diligence (QSA) for ODA project accreditations.

#### 3.3 CONTEXT

Accredited Social Housing Institutions, accredited Co-operatives and Other Delivery Agents (ODA) submit social housing project applications for the award of the Consolidated Capital Grant (CCG) to the SHRA. The application process in the case of, Other Delivery Agents (ODA) requires that an Organisational Due Diligence tool referred to as the Quick Scan A (QSA) be completed and assessed on a project basis.

Based on the outcome of the assessment and evaluation of the QSA, the service providers will present the outcome as invitees to both the Compliance, Accreditation and Regulations Management Committee (CAR MANCO) and the SHRA Executive Committee (SHRA EXCO) who recommends the ODA Project Accreditation to the Compliance Accreditation and Regulations Committee (CAR Committee) Committee to make a final recommendation to the SHRAs Council for their final approval.

The CCG award application process requires applicants to complete the following tool:

#### **QSA: ORGANISATIONAL DUE DILIGENCE**

The QSA tool examines the ability of the ODA to deliver social housing by assessing: the appropriate legal form, founding documents/main business and objective, good governance, financial stability, property management capacity and transformation profile. The long-term strategic business plan is a critical guiding document for each applicant.

#### 3.4 SCOPE OF WORK

- a) Review due diligence application (QSA) and supporting documents;
- b) Develop a query list of outstanding/incorrect documents and/or questions to be clarified - send the list to the SHRA;
- c) SHRA will liaise and forward the query list to the applicant;
- d) SHRA will forward the documentation received from the applicant to the service provider;
- e) The service provider to ensure that all new information and supporting documents from applicants are saved for review;
- f) Prepare a preliminary social housing project assessment report that includes a summary of the reasons for the outcome and detailed conditions needed to be developed per project highlighting what the applicant needs to address within a set timeframe;
- g) Receive feedback from the applicant and prepare a final social housing project assessment report and presentation;
- h) Liaise with the CAR Project Accreditation team regarding any concerns and provide regular updates on the status of the process and progress per project assessment;
- The service provider may need to engage with SHRA to justify the contents of the query list and assessment report;
- j) Be available to present the report with findings and recommendation to the Compliance, Accreditation and Regulations Management Committee (CAR MANCO) and if necessary at the SHRA Executive Committee (SHRA EXCO) and project owners;
- k) Be available for a feedback session post the ODA Accreditation award phase;
- I) The EXCO and or other SHRA committees may request that the service providers undertake further work on the ODA QSA Assessment, to ensure that any outstanding conditions are met or to review any new information and/or documents and update the assessment report, and m)Be available for telephonic, or email verification of queries.

#### 3.5 DELIVERABLES

#### 3.6 TIMEFRAMES

The service providers will be allocated work relating to projects that need to be finalised within a period of 7-10 days in preparation for a (CAR MANCO) meeting and subsequently within one week before an EXCO meeting.

The timeframes stated in the above table may run concurrently.

## 3.7 REQUIRED LEVEL OF EXPERIENCE, QUALIFICATIONS AND EXPERTISE

The ideal service providers need to have within their team, working knowledge in the following areas:

- Organisational Due Diligence (in line with the Social Housing Regulations)
- Legal Compliance
- Corporate Governance Principles
- Assessment of Financial Statements and Annual Audited Financial Statements
- Understanding of Organisational structures
- Property management
- Tenant management
- Property Development
- Transformation and B-BBEE Compliance

The service provider's team composition must have any of the following qualifications and experience:

- Bachelor's degree in finance, economics, business administration, law, and/or commerce
- ii. CA(SA) and/or CFA or similar

The team leader must have a minimum of five (5) years experience in any of the following:

- Organisational Due Diligence,
- analyzing and assessing long-term strategic business plans, property management policies, tenant management policies, property development policies, company operational policies, finance and governance provision.
- Bidder has done at least Five (5) similar assignments/projects successfully in the past. (Attach reference letters) **NB: Appointment letters will not be considered.**
- Members of the team are registered with a professional body (attach valid professional certificates) e.g., SAICA

\*The appointed service provider will be required to work under intense pressure / short turnaround timeframes.

#### 3.8 ACCOUNTABILITY AND REPORTING

The Service Provider will report administratively to the Accreditation Manager of the SHRA and be accountable to the CAR Executive for the duration of the contract period. The service provider will report progress made at mutually agreed timeframes (to be established once the service provider has been contracted).

#### 3.9 PRICING

The fixed bid price for the Assessment of QSA is R35 543.74 per project (inclusive of VAT and excluding disbursements) and increased annually thereafter by the CPI as indicated by Stats SA (inclusive of VAT) on 1<sup>st</sup> April every year.

Service providers must confirm that the above costing is acceptable to them if appointed by SHRA on this project.

Disbursements should be in line with the National Treasury Cost Containment Measures Instruction notes No.7 of 2022/2023 related to Travel and Subsistence which will be reimbursed to the appointed service provider based on the pre-approval by the SHRA and a disbursement invoice is to be always submitted separately proof of payments for all disbursements must be attached to the disbursement invoice claimed.

The Bid will be evaluated on Functionality and B-BBEE status only as this is a panel with a pre-determined fee per assessment.

#### Please note that service providers:

- May be required to travel to the grant applicants during this process.
- All communication with grant applicants will be channelled via SHRA.
- The rate above is an all-inclusive rate that SHRA will pay to the successful service provider including printing, telephone, car hire, mileage, flights, parking, accommodation, meals, and any other incidentals.

#### 3.10 CONTRACTING PERIOD

The contracting period will be for three (3) years from the date of appointment and specifically for the assessment of the social housing projects. During the contracting period, there might be multiple assessment assignments. The confirmed timeframe for each assignment is dependent on the number of proposals/submissions received for the CCG award application. Service providers need to ensure that the scope of work is completed within each given assignment period. There will be no extensions of time granted for each assignment due to subsequent approval processes. Delay in submitting the deliverables to SHRA may be considered as non-performance and may lead to future work not being allocated to the service provider. Lastly, the service provider may be excluded from the panel.

Service providers will be appointed on a rotational basis subject to their availability and performance. If the service provider is found to have committed a misconduct, they will be removed from the panel.

#### 3.11 DISCLAIMER

The SHRA has not appointed external consultants to liaise with service providers on any matter and all matters regarding this bid will be channeled in writing via supply chain. It is also to be noted that SHRA will not at any given time solicit money from service providers.

#### 3.12 SUBMISSION REQUIREMENTS

Service providers are required to submit the following consolidated proposal in response to this Bid:

Proposal to include the following documents:

- a) Consolidated proposal (detailed below).
- b) Company Profile.
- c) Detailed CVs of team members.
- d) Copy of qualifications, professional registration certificates and professional indemnity insurance cover; and
- e) All other SCM bid documents and attachments

#### a) Consolidated Proposal (document):

#### Technical Approach and Methodology

- Understanding of the scope of the work/project as per the ToR above (Deliverables, Timeframes/Milestones, etc.)
- Detailed approach and methodology to the project to ensure that the scope of work and deliverables are met (approach, methodology, detailed workflow process Steps and actions, points of contact with SHRA, etc.)
- Specifically outline anticipated programme risks and concerns and how they will be mitigated
- Resources/ Experience and Skills of Team summary of each service provider outlining previous work experience in the Housing Field, undertaking similar work (organisational due diligence, technical feasibility and financial viability analysis) including detailed CVs highlighting similar work done.
- <u>Timeframes</u> Confirmation of availability for the period of project and ability to deliver within these timeframes. Note that no extensions will be granted.

#### 4. EVALUATION PROCESS

#### 4.1 COMPLIANCE WITH MINIMUM REQUIREMENTS

4.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further adjudication.

#### 4.2 PRE-QUALIFICATION CRITERIA FOR PREFERENTIAL PROCUREMENT

4.2.1 As per the preferential Procurement Regulations (PPR) 2017, the SHRA is applying Pre-Qualification Criteria for this bid in an effort to advance certain designated groups.

#### 4.3 FUNCTIONALITY, PRICE AND PREFERENCE POINTS

- 4.3.1 All remaining bids will be evaluated as follows:
- 4.3.2 The functionality calculation will be done based on the defined criteria and weighting thereof. Functionality will be scored out of a 100. If it is deemed necessary, presentations may be held with Bidders who have met the minimum functionality criteria. If presentations are held, the functionality score will be adjusted whereby 80 percent will be awarded to during the bid evaluation and 20 percent will be for presentation score. If a bidder fails to score a minimum of 70% out of 100% for functionality, the bid will be disregarded from further consideration.
- 4.3.3 The second part will then be done on the 80/20 split whereby (80) points will be awarded for price and 20 points will be awarded for B-BBEE Status Level Contribution.

#### 4.4 ELIMINATION OF BIDS ON GROUNDS OF FUNCTIONALITY

- 4.4.1 Bids that score less than 70% of the 100% available for functionality will be eliminated from further consideration. Points will therefore not be awarded for their cost bids or for B-BBEE Status Level of Contribution
- 4.4.2 The percentage scored for functionality should be calculated as follows:
- 4.4.3 Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score. The following formula should then be used to convert the total score to a percentage for functionality:

$$Ps = \frac{So}{Ms} X Ap$$

where

Ps = percentage scored for functionality by bid/bid under consideration

So = total score of bid/bid under consideration

Ms = maximum possible score

Ap = percentage allocated for functionality

The percentages of each panel member shall be added together and divided by the number of panel members to establish the average percentage obtained by each individual bidder for functionality.

After calculation of the percentage for functionality, the prices of all bids that obtained the minimum score for functionality should be taken into consideration.

#### 4.5 PRESENTATIONS

- 4.5.1 SHRA may decide to have compulsory presentations made by Bidders who met the minimum functionality criteria once the functionality score has been calculated.
- 4.5.2 Presentations shall only affect the marks awarded for functionality. If SHRA wishes to use presentations as an additional selection criterion between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme.
- 4.5.3 If the date of the presentation meeting is not indicated in the bid document, at least three days' notice will be given to bidders required to attend a presentation.
- 4.5.4 Presentations will be made to the full Evaluation Committee.
- 4.5.5 Points determined by the presentation will be awarded to each bidder by each member of the Evaluation Committee and then an average calculated.

#### 4.6 AWARDING OF PREFERENCES POINTS

4.6.1 Points for B-BBEE Status Level of Contribution will be awarded according to the table indicated in the preference points claim form(s).

#### 4.7 COMBINING PRICE AND PREFERENCE POINTS

- 4.7.1 The B-BBEE Status Level of Contribution marks for each bid will now be added to the price points for that bid
- 4.7.2 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 4.5.1 or to a lower scoring bid based on firm, verifiable and justifiable grounds.

#### 4.8 ADJUDICATION OF BID

4.8.1 The Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid based on firm, verifiable and justifiable grounds or no award at all.

#### 5. EVALUATION CRITERIA

#### **Functionality Evaluation**

All proposals will be evaluated on the criteria provided in the table below. The proposals of all training providers will be rated on a scale of 1 to 5.

- 1: Unacceptable, does not meet set criteria
- 2: Weak, less than acceptable. Insufficient for performance requirements
- 3: Satisfactory should be adequate for stated element
- 4: Very good, above average compliance to the requirement
- 5: Exceptional mastery of the requirement should ensure extremely effective performance.
