Dube TradePort Corporation (DTPC), a provincial public entity (Schedule 3C) in terms of the Public Finance Management Act) is a multi-modal development situated 30 kilometres north of the Durban city centre.

This is an invitation to prospective companies/individuals to submit proposals to DTPC for the purchase of AgriZone and LunchZone canteen assets and other equipment that DTPC intends to dispose of. All assets have been defined in the call for proposal document.

The successful company/individual will make their own arrangements with transport as well as labour to remove the items from the DTPC site.
