QUESTION AND ANSWERS OF COMPULSORY BRIEFING SESSION

Q1: Is the 30% local consultancy needed at the bidding stage or after the appointment?

RESPONSE: 30% will be done after the appointment as bidders are not allocated in terms of the provinces they will be servicing.

Q2: Regarding the reference letters, must it be stamped or will the company letterhead suffice?

RESPONSE: The reference letters must be stamped on a letterhead.

Q3: Regarding the bidder's experience – how can we best present the work done that include the services that are required for this project?

RESPONSE: Well, it is difficult to obtain appointment letters for this kind of work so in absence of the appointment letter, the reference letter will be accepted. Do mention specifically that you did work on projects and reported on EPWP component, taking into account that all public sector projects are subjected to 30% CPG and consultants report monthly on that component.

Q4: Should the Senior Construction Engineer have only the Pr Eng and Pr CPM, if the nominated Engineer is Pr Tech and Pr CPM

RESPONSE: Pr Tech will also be accepted. An addendum will be issued to correct that.

Q5: On Project management only, Pr CPM is mentioned so PMP will not qualify?

RESPONSE: PMP will not qualify for this project as we are looking for construction project-related activities. Only the *Pr Eng, Pr CPM and Pr Tech will be accepted.*

Q6: Clarity on what Form A4 entail.
