Material	Glass of hydrolytic class not lower than HGB3 according to ISO 719 or Borosilicate glass 3.3 according to ISO 358
Graduation lines	Graduation lines shall be clean, permanent, uniform lines of thickness not exceeding 0,3 mm
Type and minimum nominal capacities	Gay-Lussac: 5mL, 10mL, 25mL, 50mL and 100mL, or Lipkin: 5mL and 10mL, or Ground-in thermometer: 5mL, 10mL, 25mL, 50mL 100mL
