1. INTRODUCTION AND PURPOSE

The purpose of the tender is to obtain valves in control chambers of reservoirs to regulate the inflow and outflow of reservoirs, the valves required in this tender are butterfly valves, air release and vacuum control valves, resilient seal valve, wedge gate valve, tilting/ swing disc non- return valve, and control valves. Most of these valves have exceeded their functional life span and should be replaced to keep the bulk water system operable.

2. BACKGROUND

The age of the CoT's bulk pipelines, and valve systems are in excess of 40 years. High maintenance and repair costs are experienced to keep these line valves operable and the water supply to vast areas is interrupted when water leaks on bulk pipelines have to be fixed.

At this stage, very little stock is kept for emergency repair situations which possess a very high risk on the Water and Sanitation Division of serious service disruptions if valves break down and cannot be replaced as a result of the long lead time to manufacture such valves and the long period required to procure these.

3. PROJECT SCOPE

This tender is for the supply of different valves as and when required, for a period of three years effective from the date of appointing the tenderer. The tenderers will be adjudicated based on what they are able to provide; thus, the tenderers shall tender only on individual items. The tender will therefore be awarded per item.

Proof of compliance with the relevant specifications for each tendered item category must be submitted with the original tender documents. Failure to submit this documentation together with the tender documents will result in disqualification of the bid for the specific item category.

The delivery of the valves should be made to the Central Water Depot situated at 11 Johannes Ramokhoase Street, Tshwane. The contractor will be responsible for the offloading of the valves upon delivery. The City of Tshwane will not accept nor be accountable for any means of damage incurred on the valves during manufacturing, transporting and offloading.

4. VALVE SPECIFICATIONS

ITEM 1 BUTTERFLY VALVES

1. GENERAL

1.1 Tender and evaluation

This part of the tender is for the supply of butterfly valves, as and when required, for a three-year-period effective from the date of appointing the tenderer.

The tenderers will be adjudicated based on what they are able to provide; thus, the tenderers shall tender only on individual items. The adjudication of the different types and pressure classes will be done per group, i.e. butterfly valves class 10 for the sizes specified, butterfly valves class 16 for the sizes specified, etc. Butterfly valves shall be certified in accordance with BS EN 593 /SANS 1849 failure to conform will lead to disqualification. All data sheets to be submitted for prior approval at tender stage.

1.2 Type

Butterfly valves shall be of the doubled flanged, full-bore and “tight shut off” type with the replaceable resilient seal. Flange drilling according to SANS1123, PN 10, 16 and PN25. For pressures up to 25 bar, the valve will be a double eccentric disc type, and for pressures higher than 25 bar a triple eccentric type. Metal seated valve will also be considered. Valves shall be bi-directional sealing.

Gearboxes shall be of the self-locking worm/quadrant type with no backlash.

Operation shall be by means of a pinion shaft driving the quadrant.

Worm shafts shall be fitted with roller bearing thrust bearings to ensure minimal operating effort and smooth rotary action of the input shafts.

End stops shall be of the travelling nut type enabling precise setting of the open/closed positions.

The enclosure shall conform to a minimum of IP67 to prevent the ingress of water and debris into the gearbox housing.

The gearbox to valve mounting flange shall have a groove from the input shaft to the edge of the flange to ensure early detection of any leakage from the valve shaft seals, if the shafts are open to the pipeline medium.

Gearboxes shall be packed with approved water resisting grease to the gearbox supplier's specification.

Gearboxes shall in all instances be sized for fitting of actuators (Hand wheel operated valves included) on site without any additional modification. Actuator mounting flanges shall conform to ISO 5211. Hand wheel sizes will not exceed:

400mm diameter for PN16 valve sizes 300mm to 1000mm and

400mm diameter for PN25 for valve sizes 300mm and 800mm and

500mm diameter for valve sizes 800mm to 1000mm diameter.

Maximum rim pull, to ensure water tightness in the closed position, on the hand wheel may not exceed 300 N-m.

ALL Valves shall be LEFT HAND (counterclockwise) closing.

ALL Valves should be verified by Tests from SABS or other testing authority.

1.3 Flow rates

No cavitation in the fully open position shall be accepted. The maximum permissible flow rate at the maximum differential pressure across the valve and the head loss for the specified flow rate shall be stated in the Technical Schedule.

1.4 Operation

A butterfly valve shall close under the maximum specified head and flow rate and shall be functional in any position without variation of the blade position or flutter. Normal operation shall however be in either the fully open or fully closed position.

There shall be no interference in the water flow pattern through a valve except for the blade.

The blade shall close with a positive action with no possibility of slamming shut during any stage of the closing operation.

A butterfly valve shall be installed in a position allowing the valve to operate along the horizontal axis. The lower portion of the blade shall open towards the downstream side of the valve i.e. in the direction of flow. All valves shall be fitted with a gearbox complete with hand wheel for Left Hand Closing.

2 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

2.1 Body

The hubs for the shaft-bearings and the gearbox mounting flange shall form an integral part of the valve body.

The body of the valve, and the gearbox, will be such that no studs are used to fasten the valve body to the pipe section, but bolts and nuts are to be used on all the flanges. An isolating flange with its isolating tubes can be fixed to the valve. A drawing must be provided as proof. If such drawing is not provided, the valve will not be considered.

2.2 Disc

The disc shall be a single casting or fabrication of optimum hydrofoil section with a smooth continuous surface. The maximum combined stresses in the disc shall not exceed 20% of the yield stress of the material when the design pressure is applied on any of the two sides.

2.3 Seal Retaining Ring/s

The seal retaining ring/s, manufactured from stainless steel material, shall be coated to reduce galvanic corrosion. The recess for the retaining ring/s in the disc or body shall be coated to the specified corrosion protection specification or the seal face shall be assembled with a coat of heat fused epoxy of minimum 250 microns.

2.4 Seat and Seal

2.4.1 Soft seal butterfly valves PN 16 and 25 Bar above PN25 metal seated triple eccentric butterfly valves.

Preference shall be given to a resilient seal arrangement that is removable, replaceable and adjustable in situ from the down-stream side of the valve, without having to remove the valve from the pipeline.

A continuously molded music note or tee type resilient seal is required and shall be fixed without the use of glue.

The resilient seal shall have non-weathering, non-sticking, long life properties and shall be compatible with the quality of potable water.

The seat profile shall be smooth and continuous and shall provide adequate "lead in" for the resilient seal to open and close on the stainless-steel seat only. The mounting flange of the removable seat in the disc shall be stainless steel and machined level with the seat or the seat ring manufactured to cover the seat mounting flange.

The seat and seal shall be of a design preventing them from becoming loose and obviate water seepage under the seals or seats during all conditions of operation and testing.

2.4.2 Metal seated triple eccentric butterfly valves PN 25 Bar and up.

High Performance Triple Eccentric Metal Seated Design Manufactured in accordance with BS 5155/BS EN593 Specification. Materials should be compatible with media and pressure requirements as per Clause 3. Valves shall have replaceable laminated seal in the body and a replaceable seat ring on the disc.

2.5 Mechanical Stops

To prevent over travel of the valve blade in the open or closed position, all valves shall have adjustable mechanical stops incorporated in the gearbox.

2.6 Shafts

Shafts shall either be continuous or of a stub-shaft design configuration. Stub shafts shall extend into the blade hubs for a distance of at least 1.5 shaft diameters and shall not protrude from the hubs i.e. exposing the shaft.

Shafts shall be attached to the blade by means of keys, dowel pins, taper pins or any combination of the three. The connection shall be designed to transmit shaft torque equivalent to at least 75% of the torsional strength of the shaft. Dowel and taper pins shall be mechanically secured.

The idle shaft cover shall be manufactured from stainless steel and secured with stainless steel fasteners.

2.7 Bearings

Self-lubricating sleeve type bearings (bronze backed, Zinc free or PTFE (Polytetrafluoroethylene) backed self-lubricating or bushes shall be fitted in the hubs of the valve body. The bearing length will be a minimum of 1,5x shaft diameter.

Each valve shall be fitted with at least one adjustable thrust bearing or spacer disc set to hold the blade securely concentric with the body or seat if so required.

The valve stem shall be provided with two O ring seals on the shaft to protect the bearing from water seeping from the valve inside.

4. CORROSION PROTECTION

Damage to the corrosion protection or during testing or normal operation will not be acceptable. Valve body and closures shall be heat fused epoxy coated to a minimum of 250 microns internally and externally. Valves shall be packed and transported that no damage to the coating is possible. Any visible damage to the valve at delivery will give the client authority to reject the complete delivery of all valves.

5. COMPLIANCE TO SPECIFICATIONS

If the City of Tshwane suspects that a valve does not comply with the specifications, the contractor will appoint a registered inspector which is acceptable to the City to perform checks to ensure compliance to the specifications. The cost of this inspection will be for the appointed supplier of the valve.

ITEM 2 AIR RELEASE AND VACUUM CONTROL VALVES

1 GENERAL

Tender and evaluation

This part of the tender is for the supply of air release and vacuum control valves, as and when required, for a three- year-period effective from the date of appointing the tenderer.

The tenderers will be adjudicated based on what they are able to provide, thus the tenderers shall tender only on individual items. The adjudication of the different types and pressure classes will be done per group, i.e. air release and vacuum control valves class 10 for the sizes specified, air release and vacuum control valves class 16 for the sizes specified, etc. All data sheets to be submitted for prior approval at tender stage.

2 TYPE

Air valves shall not exhibit the characteristics of dynamic closure in exhaust and vacuum mode. The valves shall be of the triple acting type, firstly allowing large volume air intake under vacuum conditions, secondly large volume of air discharge during filling with an anti-shock surge alleviating mechanism to prevent pipeline damage under controlled filling or surge conditions, and thirdly shall have an efficient small orifice mechanism to allow the exhausting of dis-entrained air under normal pipeline operation to prevent buildup of air in the pipeline.

The large intake and exhaust orifice of air valves shall be equal to the nominal size of the valve e.g. a 200mm valve shall have a 200mm inlet and outlet orifice. The valve shall incorporate an integral anti-shock (non-slam) orifice mechanism which shall operate automatically to limit transient pressure rise or water hammer induced by closure. An inherent feature of the valve design must be to ensure that the ball or float does not close before all the air has been released.

All air valves shall be hydraulically drop tight when full of water and under pressures of between 1 metre (10 kPa) to 1,5 times the maximum operating pressure of the valve.

Valves required to isolate air valves for maintenance shall comply with the Valve Material Specification for the specific category of valve specified.

3 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

3.1 Body

The valve body shall be flanged or threaded and be of a compact single chamber design. The ball or float(s) shall be easily accessible for maintenance purposes.

3.2 Float

The float guides shall be stainless steel designed to have sufficient clearance to ensure free operation and prevent any abrasion when subjected to frequent operation.

Cylindrical floats shall be manufactured from stainless steel. Floats shall not be able to adhere to the orifice sealing arrangement nor be affected by deposits on the float surface.

Floats shall not distort or suffer mechanical damage in any form when subjected to a structural strength test or conditions of frequent use.

3.3 Draining facility

Provision shall be made for the drainage of a valve, by means of a 6mm stainless steel ball valve and stainless-steel nipple, prior to removal or servicing and for the fitting of pressure gauges for testing purposes.

The stainless-steel nipple shall extend through the body to cover all the threads.

3.4 Weather covers

All air valves shall be supplied with robust, easily removable screens that will allow free discharge or intake of air but shall exclude the ingress of objects that may cause damage or malfunction of the valves.

Screens shall be manufactured from stainless steel mesh.

4. CORROSION PROTECTION

Damage to the corrosion protection or during testing or normal operation will not be acceptable. Valve body and closures shall be heat fused epoxy coated to a minimum of 250 microns internally and externally. Valves shall be packed and transported that no damage to the coating is possible. Any visible damage to the valve at delivery will give the client authority to reject the complete delivery of all valves

1.2 Type

All valves shall be doubled flanged and of the resilient seal gate type, the gate of which shall be completely clear of the waterway in the fully open position. The gate valve shall be of the non-rising spindle type, fitted either with a hand wheel or cap top (type will be specified in the Schedule of Quantities). The valve shall be capable of withstanding the nominal pressure (PN) and specified test pressures from both sides. The gate shall operate satisfactorily under the specified conditions and shall be Left Hand closing.

1.3 Specifications

The valve shall be certified in accordance to SANS 664 and carry the SABS mark or be JASWIC listed; failure to conform will lead to disqualification. Flange drilling shall be according to SANS 1123, PN10, PN16 and PN25. The manufacturer/supplier shall have the SANS 3000 cycle test done and provide certified copies to verify that the product passed the test. OEM data sheets to be submitted on delivery.

Valves shall have raised face flanges.

1.4 Body

The body shall be of rigid design to minimize distortion under pressure.

1.5 Operation

The gate valve shall be able to open and close satisfactorily under the specified flow rate and pressure.

1.6 Stem and thrust bearing

Two friction washers (sizes 50mm-200mm) and thrust ball bearings (350mm-600mm) shall be incorporated on the thrust collar to ensure smooth spindle operation as well as to reduce opening and closing torques.

The stem thrust collar shall bear against a ball thrust bearing.

1.7 Corrosion protection

Damage to the corrosion protection or the rubber-coated gate during testing or normal operation will not be acceptable. Valve body and closures shall be heat fused epoxy coated to a minimum of 250 microns internally and externally. Valves shall be packed and transported that no damage to the coating is possible. Any visible damage to the valve at delivery will give the client authority to reject the complete delivery of all valves.

2 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

2.1 Resilient seal gate valves shall be of the maintenance free type with a life span expectancy of at least 30 years.

Body, guides and shoes

The valve body shall incorporate a straight unobstructed body passage without pockets and shall have inclined seats and prominent gate guides to eliminate deposits in the valve body.

The guides shall be as deep and as long as possible, but not protruding into the flow path to offer support in all gate positions.

Gate

The gate shall be completely encapsulated in rubber and accurately molded to ensure drop tightness over the valve pressure range. Bonnet: Bolts and Gaskets

Valves will be certified in accordance to SANS 664/665, the gate of which shall be completely clear of the waterway in the fully open position. The gate valve shall be of the non-rising spindle type, fitted either with a hand wheel or cap top (type will be specified in the Schedule of Quantities). The valve shall be capable of withstanding the nominal pressure (PN) and specified test pressures from both sides. The gate shall operate satisfactorily under the specified conditions and shall be Left Hand closing.

1.3 Specifications

The valve shall be certified in accordance to SANS 664/665 and carry the SABS mark or be JASWIC listed; failure to conform will lead to disqualification. Flange drilling shall be according to SANS 1123, PN16 and PN25.

Valves shall have raised face flanges and flat faced size dependent.

1.4 Body

The body shall be of rigid design to minimize distortion under pressure.

1.5 Operation

The gate valve shall be able to open and close satisfactorily under the specified flow rate and pressure.

1.6 Stem and thrust bearing

Two friction washers (sizes 50mm – 200mm) and thrust ball bearings (350mm – 600mm) shall be incorporated on the thrust collar to ensure smooth spindle operation as well as to reduce opening and closing torques.

The stem thrust collar shall bear against a ball thrust bearing.

1.7 Corrosion protection

Damage to the corrosion protection or the gate during testing or normal operation will not be acceptable. Valve body and closures shall be heat fused epoxy coated to a minimum of 250 microns internally and externally. Valves shall be packed and transported that no damage to the coating is possible. Any visible damage to the valve at delivery will give the client authority to reject the complete delivery of all valves.

2 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

2.1 Wedge gate valves

Gate and Body

Guides

The body and the sides of the gate of a wedge gate valve shall be so fitted with guides that, when the valve is being closed, the guides will, until near the point of closure, prevent the gate seats from touching the body seats.

Documentation to prove that the Material used comply with international health and drinking water standards. Certification will be supplied and submitted with the tender documents, including Toxins taste and odor potable water certificate.

The gate shall be a left-hand closing type.

For valves larger than 100mm the gate nut shall be a replaceable item.

Stem

A corrosion resistant stem seal arrangement shall include a scraper ring to prevent the ingress of foreign matter. A stem thrust collar shall be installed between anti-friction materials to ensure low operating forces. Size dependent, the stem seal arrangement shall be capable of being replaced under pressure.

Bonnet: Bolts and Gaskets

The bonnet S/S (stainless steel) cap screws shall be entirely sunk into the body casing, sealed and protected by reusable wax. Bolts will be stainless steel protected to standards in the material specification.

The valve shall have a preformed NBR (nitrile butadiene rubber) rubber gasket, O ring type, set in a recess between the Bonnet and Body. The gasket must fully encircle each bolt. Sizes DN350 and up braided graphite/EPDM or compressed fiber gaskets.

Sealing faces

Body and gate seals shall be of such design and construction that will prevent seals becoming loose and prevent water passing behind seals under all conditions of operation and test.

ITEM 5 TILTING/SWING DISC NON-RETURN VALVES

1 GENERAL

1.1 Tender and evaluation

This part of the tender is for the supply of tilting/swing disc non-return valves, as and when required, for a three-year-period effective from the date of appointing the tenderer

The tenderers will be adjudicated based on what they are able to provide, thus the tenderers shall tender only on individual items. The adjudication of the different types and pressure classes will be done per group, i.e. tilting/swing disc non-return valves class 10 for the sized specified, tilting/swing disc non-return valves class 16 for the sizes specified, etc. Tilting/swing disc non-return valves shall be in accordance with SANS 1551-2/BS EN 12334 failure to conform will lead to disqualification. All data sheets to be submitted for prior approval at tender stage.

1.2 Type

A non-return valve shall be double flanged (drilling according to SANS 1123, EN 558 PN 10, PN 16 and PN 25) or wafer type.

The valve shall offer minimum hydraulic resistance, not be subject to disc flutter and give a quick non-slam closure on reversal of flow. Preference shall be given to designs which allow inspection and or removal of doors, discs and seals without removal of the valve assembly from the line, hydraulically assisted lever and weight design.

2 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

2.1 Body

The design of the body and body seals shall be such that they are free from pockets which may cause eddies or accumulate debris. Special care shall be taken that foreign

objects, like bolts, cannot lodge in pockets on the downstream side of body seats and thereby prevent doors from closing fully.

Access openings and covers shall be of adequate design and the creation of stress risers shall be prevented.

2.2 Doors and discs

The doors and discs shall be cast (size dependent) as a unit with integral cast hinge lugs allowing free door or disc operation. Their travel shall however be restricted by the provision of substantial stops fitted with rubber facings to prevent wear due to metal contact. The rubber facings shall be vulcanized onto the metal and secured by corrosion resistant countersunk screws. The area of contact on the body shall be stainless steel 304L deposit welded, GGG50 or EPDM where applicable. OEM data sheets to be supplied upon delivery.

The doors or discs shall have continuous stainless-steel hinge shafts which shall be supported at their ends with bearings.

2.3 Sealing faces

Body and door and disc sealing faces shall be EPDM, deposit welded with stainless steel or aluminum bronze where applicable. Corrosion protection of the contact area between steel, ductile iron and stainless steel shall be in accordance with Standard Specification DWS 9900: Corrosion Protection.

2.4 Bearings

Main bearings shall be external. Preference shall be given to a valve with bearings that are accessible without emptying or removal of the valve body from the line.

Bearings shall be designed to take the unbalanced thrust on doors or discs in the structural test.

Bearings shall offer a long life and retain a low coefficient of friction. Bearings shall not become tight during service or due to ageing.

Bearings shall preferably be self-lubricated.

The Tenderer shall provide full particulars of the type and construction of the valve supplied with OEM data sheets.

2.5 Materials

Valve components shall be constructed of the material specified in the following tables unless otherwise specified in the Project specification.

2.6 Corrosion protection

Damage to the corrosion protection or during testing or normal operation will not be acceptable. ITEM 6 CONTROL VALVES

1 GENERAL

1.1 Tender and evaluation

This part of the tender is for the supply of control valves, as and when required, for a three-year-period effective from the date of appointing the tenderer.

The tenderers will be adjudicated based on what they are able to provide, thus the tenderers shall tender only on individual items. The adjudication of the different types and pressure classes will be done per group, i.e. control valves class 10 for the sizes specified, control valves class 16 for the sizes specified, etc. All data sheets to be submitted for prior approval at tender stage.

1.2 Type

The valve shall be a self-acting, hydraulically operated, diaphragm actuated, globe type design.

1.3 Function

The valve shall be hydraulically operated, single diaphragm actuated, globe pattern. The valve shall consist of three major components: the body with seat installed the cover with bearing installed, and the diaphragm assembly. The diaphragm assembly shall be the only moving part and shall form a sealed chamber in the upper portion of the valve, separating pressure from line pressure. Packing glands and/or stuffing boxes are not permitted and there shall be no pistons operating the main valve or pilot controls. Ductile iron is standard, other materials shall be available. No fabrication or welding shall be used in the manufacturing process.

2 CONSTRUCTION AND OPERATIONAL REQUIREMENTS

2.1 Body and Actuator / Main Valve

The valve shall consist of three major components such as the body, cover, and the diaphragm assembly. The diaphragm assembly shall be the only moving component, separating the operating pressure from the line pressure.

The actuator assembly is utilized and is removable from the body. The actuator must include minimum an upper control chamber and might include a lower control chamber. The diaphragm assembly must be center guided. The body must provide a seat area without obstructions.

To ensure proper alignment of the valve stem, the valve body and cover shall be permitted. No "pinned" covers to the valve body shall be permitted. All necessary repairs and/or modifications other than replacement of the main valve body shall be possible without removing the valve from the pipeline. Only full ported valves will be considered.

2.2 Seat and Sealing Disc

The seat will be manufactured of stainless steel, be raised and replaceable in line and on site.

The valve shall contain a resilient, synthetic rubber disc, with a rectangular cross-section supported on all four sides by a disc retainer and disc guide. The disc guide shall be of the contoured type to permit smooth transition of flow and shall hold the disc firmly, preventing the possibility of being dislodged. The disc retainer shall be of a sturdy one-piece design. It shall have straight edge sides and a radius at the top edge to prevent excessive diaphragm wear as the diaphragm flexes across this surface.

The valve seat in 150mm and smaller size valves shall be threaded into the body. Valve seat in 200mm and larger size valves shall be retained by flat head machine screws for ease of maintenance. The seat shall be of the solid, one-piece design and shall have a minimum of a five-degree taper on the seating surface for positive drip-tight shut-off. Pressed-in bearings and/or multi-piece seats shall not be permitted.

2.3 Diaphragm

The flexible, non-wicking diaphragm shall consist of nylon fabric bonded with synthetic rubber compatible with the operating fluid. The center hole for the main valve stem must be sealed by vulcanization. The diaphragm must withstand a Mullins Burst Test of a minimum of 41 bar per layer of nylon fabric and shall be cycle tested 100,000 times to ensure longevity (test certificate to be submitted with tender). The diaphragm shall not be used as the seating surface and shall be fully supported in the valve body and cover by machined surfaces, either in the fully opened or fully closed positions.

2.4 Functions

The valve will perform the following functions, dependent on the pilot system:

- (i) Pressure Reducing
- (ii) Pressure Relief / Sustaining
- (iii) Level Control with Float Pilot
- (iv) Level Control with Altitude Pilot
- (v) Pump Control
- (vi) Surge Anticipating, and
- (vii) Flow Control
- (viii) Basic main valve hytrol without any pilot and/or control system

4 CORROSION PROTECTION

Damage to the corrosion protection or during testing or normal operation will not be acceptable. Valve body and closures shall be heat fused epoxy coated to 250 microns internally and externally. Valves shall be packed and transported that no damage to the coating is possible. Any visible damage to the valve at delivery will give the client authority to reject the complete delivery of all valves.

5 VALVE REDUCTION RATIO

The valve shall be capable of differential pressures of up to 20 Bar, as long as a back pressure of 1.5 Bar is available.

The valve must be able when required to withstand a pressure reduction of up to 85% of the incoming pressure, i.e. 3:1 reduction, without cavitation. This shall be achieved by a modification / installation of the disk on the valve, and not any further modifications. This modification must be a standard to the valve proposed and be available as a later add on to the valve ordered.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 ”Force majeure” means an event beyond the control of the supplier and not involving the supplier’s fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.

- 1.14 “GCC” means the General Conditions of Contract.
- 1.15 “Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 “Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 “Local content” means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 “Manufacture” means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 “Order” means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 “Project site,” where applicable, means the place indicated in bidding documents.
- 1.21 “Purchaser” means the organization purchasing the goods.
- 1.22 “Republic” means the Republic of South Africa.
- 1.23 “SCC” means the Special Conditions of Contract.
- 1.24 “Services” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.

1. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid.
Where applicable a non-refundable fee for documents may be charged.

	3.2	With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za
4. Standards	4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
5. Use of contract documents and information inspection.	5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
	5.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
	5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
	5.4	The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
6. Patent rights	6.1	The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
7. Performance security	7.1	Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
	7.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
	7.3	The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms: <ul style="list-style-type: none"> (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or (b) a cashier's or certified cheque
	7.4	The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.
8. Inspections, tests and analyses	8.1	All pre-bidding testing will be for the account of the bidder.

- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance	11.1	The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
12. Transportation	12.1	Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.
13. Incidental services, services	13.1	<p>The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:</p> <ul style="list-style-type: none"> (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods; (b) furnishing of tools required for assembly and/or maintenance of the supplied goods; (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods; (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
	13.2	Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
14. Spare parts	14.1	<p>As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:</p> <ul style="list-style-type: none"> (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and (b) in the event of termination of production of the spare parts: <ul style="list-style-type: none"> (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
15. Warranty	15.1	The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
	15.2	This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the

final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
 - 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
 - 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
 - 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
 - 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
 - 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract**
- 18.1 No variation in or modification of the terms of the contract shall be made **amendments** except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
 - 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
- 22. Penalties**
- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
- 23. Termination for default**
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the Supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated

fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all

		reasonable alternative means for performance not prevented by the force majeure event.
26. Termination for insolvency	26.1	The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
27. Settlement of Disputes	27.1	If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
	27.2	If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
	27.3	Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
	27.4	Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
	27.5	Notwithstanding any reference to mediation and/or court proceedings herein, (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and (b) the purchaser shall pay the supplier any monies due the supplier.
28. Limitation of liability	28.1	Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6; the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
29. Governing language	29.1	The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1	The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	31.1	Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice

- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
- 32. Taxes and duties**
- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National Industrial Participation (NIP) Programme**
- 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation
- 34. Prohibition of Restrictive practices**
- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

- 1.2 “Business Day” means any day from Monday to Friday excluding Public Holidays as defined in the Public Holidays Act 36 of 1994 (“Public Holidays Act”) as amended from time to time;**
- 1.3 “Business Week” means five consecutive Business Days, excluding Public Holidays as defined in the Public Holidays Act;**
- 1.4 “City” means the City of Tshwane Metropolitan Municipality, a metropolitan municipality established in terms of section 12 of the Local Government: Municipal Structures Act 117 of 1998;**
- 1.5 “Contact Persons” means persons identified by the Parties as persons who are responsible for the execution of the Agreement and whose names are set out in clause 29 and who can be substituted in writing from time to time;**
- 1.6 “Contract Price” shall mean the amount reflected as the contract price in clause 9 below;**
- 1.7 “Contract Period” means the contract period as reflected in clause 6 below;**
- 1.8 “Effective Date” means the date when the last signing party signs the agreement;**
- 1.9 “Intellectual Property” means Patents, Designs, Know-How, Copyright and Trade Marks and all rights having equivalent or similar effect which may exist anywhere in the world, introduced and**

required by either Party to give effect to their obligations under this Agreement, owned in whole or in part by, or licensed to either Party prior to the Commencement Date or developed after the Commencement Date, and includes all further additions and improvements to the Intellectual Property, otherwise pursuant to this Agreement;

- 1.10 **“Month” means a calendar month;**
- 1.11 **“Parties” means the City and the Service Provider and “Party” means either of them as the context requires;**
- 1.12 **“Services” means services to be provided by the Service Provider to the City as stated in clause 8 below and detailed in the terms of reference**
- 1.13 **“Service Provider” means appointed company**
, a company duly incorporated in accordance with the
company laws of the Republic of South Africa with company
registration number:

- 1.14 **“Signature Date” means the date of signature of this Agreement by the Party signing last;**
- 1.15 **“Subcontract” means any contract or agreement or proposed contract between the Service Provider and any third party whereby that third party agrees to provide to the Service Provider the Services or any part thereof;**
- 1.16 **“Subcontractor” means the third party with whom the Service Provider enters into a Subcontract;**
- 1.17 **“Tax Invoice” means the document as required by section 20 of the Value Added Tax Act 89 of 1991, as amended from time to time; and**

- 1.18 **“VAT” means Value Added Tax as defined in terms of the Value Added Tax Act of 1991.**

2 INTERPRETATION

- 2.1 **Headings and sub-headings are inserted for information purposes only and shall not be used in the interpretation of this Agreement.**
- 2.2 **Unless the context clearly indicates a contrary intention, any word connoting:**
- 2.2.1 Any singular shall be deemed to include a reference to the plural and vice versa;
- 2.2.2 Any one gender shall be deemed to include a reference to the other two genders; and
- 2.2.3 A natural person shall be deemed to include a reference to a legal or juristic person.
- 2.3 **The expiry or termination of this Agreement shall not affect provisions of this Agreement which expressly provide that they will operate after any such expiry or termination of this Agreement. Provisions of necessity shall continue to have been effective after such expiry or termination of this Agreement, notwithstanding that the clauses themselves do not expressly provide for this.**
- 2.4 **The rule of interpretation that a written agreement shall be interpreted against the party responsible for the drafting or preparation of that Agreement shall not apply.**
- 2.5 **Where figures are referred to in numerals and in words and there is any conflict between the two, the words shall prevail.**
- 2.6 **Any reference to any legislation is a reference to such legislation as at the Signature Date and as amended or re-enacted, from time to time.**

- 2.7 If any provision in a definition is a substantive provision conferring any rights or imposing any obligations on any party, then notwithstanding that, it is only in this interpretation clause, effect shall be given to it as if it were a substantive provision in this Agreement.**

3 APPOINTMENT

The City hereby appoints the Service Provider, who accepts such appointment as stated in the Appointment letter dated _____, to provide the Services in accordance with the terms and subject to the conditions of this Agreement and the attached Terms of Reference.

4 PURPOSE OF THE AGREEMENT

4.1 The Purpose of this Agreement is to:

- 4.1.1 Formalise and regulate the working relationship between the Parties;
- 4.1.2 Set out the roles and responsibilities of the Parties; and
- 4.1.3 Define process and procedures to be followed by the Parties.

5 RELATIONSHIP

Nothing in this Agreement shall constitute or be deemed to constitute a partnership or joint venture between the Parties. Furthermore the Service Provider acknowledges and agrees that its status under this Agreement is that of an independent service provider and its status shall in no way be deemed to be that of an agent or employee of the City, for any purpose whatsoever, and the Service Provider shall have no authority or power to bind the City or to contract in the name of the City, or create a liability against the City in any way or for any purpose.

6 DURATION

This Agreement shall commence on the Effective Date and shall subsist for a period of 3 (three) years, unless terminated earlier pursuant to clause 26 below.

7 CONTACT PERSON

- 7.1 The work to be performed by the Service Provider hereunder will be supervised by City's Contact Person.**
- 7.2 The Parties shall notify each other, in writing from time to time, of the details of their nominated Contact Person.**
- 7.3 The Contact Persons shall liaise and update each other on the progress of the Services rendered and shall endeavour to resolve and remedy any problems or disputes that may arise in relation to the Services.**

7.4 Either Party may substitute a Contact Person at its discretion provided that each Party shall give the other Party reasonable notice of such substitution and will provide replacement employees of equivalent ability.

7.5 Without derogating from the foregoing, should either Party replace a Contact Person for any reason whatsoever, it shall ensure, to the greatest extent possible in the circumstances, that the suitable period of hand-over and overlap takes place, at its cost, between the new and the encumbered Contact Person.

8 SCOPE OF GENERAL SERVICES

8.1 The Service Provider shall, for the duration of this Agreement Supply and Deliver different valves over a three-year period as and when needed.

9 PRICE AND PAYMENT

The City shall pay to the Service Provider a Contract Price in the sum of (contract price in words).

9.1 The City shall pay to the Service Provider for the work done as indicated in Annexure “C” as and when the item and or the service/s has been delivered and or rendered.

9.2 All payments under this Agreement shall be made by electronic fund transfer or other forms of payment as the Parties may agree from time to time, upon receipt of valid and undisputed Tax Invoices and month-end statements together with the supporting documentation from the Service Provider, once the undisputed Tax Invoices or such portion of the Tax Invoices which are undisputed become due and payable. .

9.3 All amounts and other sums payable in terms of this Agreement and Schedules hereto will be stipulated exclusive of VAT, unless expressly stated otherwise.

- 9.4 Unless otherwise provided in the Schedules, valid Tax Invoices shall be submitted together with a month-end statement. Payment against such month-end statement shall be made by the City within 30 (thirty) days after the date of receipt by the City of the Service Provider's statement together with the relevant valid and undisputed Tax Invoice(s) and supporting documentation, but in any event not later than 90 (ninety) days of receipt of such statement.
- 9.5 Where the payment of any valid and undisputed Tax Invoice, or any part of the said Tax Invoice which is not in dispute, is not made by the due date, the Service Provider shall be entitled to charge interest on the outstanding amount, at a banks prime rate of interest in force, for the period from the due date of payment until the outstanding amount is fully paid.
- 9.6 There shall be no interest levied on a Tax Invoice that is in dispute between the Parties.
- 9.7 The City shall pay the amount reflected on a Tax Invoice once the City's Contact Person has verified that the Services set out in a schedule have been rendered and the Tax Invoice amount has been approved by the City.
- 9.8 All Tax Invoices shall be addressed to the City' Contact Person.
- 9.9 All payments shall be transferred, by the City to the Service Provider electronically into the Service Provider's bank account, the details of which are set out below:

- Branch No:
- 9.10 Failure to comply with the clauses above may result in late payment of the total amount of an invoice by the Service Provider to the City.

The City shall not be liable for any costs or damages suffered by the Service Provider as a result of such late payment.

10 PRICE RESTRUCTURING

The Contract price Adjustment will be according to clause 6.8 of the GCC, *3rd edition 2015*.

The value of each monthly certificate shall be increased or decreased by the amount obtained by multiplying “Ac”, defined in Clause 2 of this schedule, by the Contract Price Adjustment Factor, rounded off to the fourth decimal place, determined according to the formula:

In which the symbols have the following meaning:

“x” is the proportion of “Ac” which is not subject to adjustment. Unless otherwise stated in the Contract Data, this proportion shall be 0,10.

“a”, “b”, “c” and “d” are the coefficients contained in the Contract Data, which are deemed ,irrespective of the actual constituents of the work, to represent the proportionate value of labor, contracts equipment, material (other than “special materials” specified in the Contract Data) and fuel respectively. The arithmetical sum of “a”, “b”, “c” and “d” shall be unity.

a = 0.15

b = 0.10

c = 0.35

d = 0.40

“L” is the “Labor” index and shall be the “Consumer Price Index” for the urban area nearest to the Site as stated in the Contact Data and as published in the statistical news release P0142.1, Table 21 of statistics South Africa

“P” is the “Pant Index” and shall be the “Civil I Engineering Plant Index” as published in the Statistical News Release P0142.1, Table 16 of Statistics South Africa

“M” is the “Materials Index” and shall be the “Civil Engineering Materials Index” as published in the Statistical News Release P0142.1, Table 15 of Statistics South Africa.

“F” is the “Fuel index” and shall be the “Diesel Index” as published in Statical News Release P0142.1, Table 16 of Statistics South Africa.

The suffix “o” denotes the base indices applicable to the base month as stated in the Contract Data.

The suffix “t ”denotes the current indices applicable to the month in which the last day of the period falls to which the relevant monthly statement relates.

10.4.2 For the purpose of calculating the adjustment to the value of the relevant monthly statement, the amount “Ac” shall be determined by the formula:

In which formula the symbols shall have the following meaning:

“T” is the summation of the total value of

- i. General Items
- ii. Work done
- iii. Materials on site

As certified in the monthly statement under consideration without any deduction whatsoever and before any adjustment made in terms of this Schedule.

“S” is the aggregate of (i), (ii), (iii) and (iv) referred to below and included in “T”

- i. The amounts actually expended and substituted for any Prime Cost Sums.
- ii. The value of any work done by Selected Subcontractors.
- iii. The value of any work done against Provisional Sums;
- iv. The value of any extra or additional work.

Where special arrangements for price adjustments in respect of those amounts were made and recorded at the time the work was ordered.

“D” is the value of work included in “T” and done at new fixed rate, where those rates were not based on labor, contractor’s equipment or materials costs in force at the time of tendering. Generally new rates may be based on current costs and de-escalated to the base month of the indices, in which case work done at these rates shall not be included in the value of “D”.

“E” is the amount included in “T” and paid for any daywork executed at cost plus percentage allowances as set out in General Conditions of Contract Clause 37.2.2

“G” is the amount included in “T” for materials classified and dealt with as “Special materials”

“Ap” is the summation of all “Ac” amounts determined in terms of clause 2 of this schedule for all monthly statements preceding in time the monthly statement under consideration.

10.4.3 Save only for additional work or variations ordered to be carried out after the time for completion, the increase or decrease applied to monthly statement in terms of this clause relating to work done or materials supplied after the time for completion shall be half the factor calculated by inserting the formula referred to in clause 1 hereof the indices Lt, Pt, Mt and Ft applicable at the Due Completion Date.

10.4.3.1 The price of each “Special material” specified in the Contract Data shall be increased or decreased by the net amount of any variation incurred after the date of tender on the basis set out in the Contract Data, provided that any claim for adjustment in terms hereof shall be substantiated by the submission of acceptable invoices and any other supporting documents that the Engineer considers necessary for the purpose, and provided also that no further adjustment be permitted to the price of any “Special material” after the time for completion unless such material forms part of any additional work or variation ordered to be carried out after that date.

10.4.3.2 For the purposes of Subclause (i) hereof, “the net amount of any variations “in respect of a particular “Special material” shall be calculated by multiplying the difference between the rate or price entered in the Contract Data by the Contractor for that material by the quantity of the material in question.

10.4.3.3 If more than one month intervenes between the month applicable to any monthly statement and the month applicable to the immediately succeeding monthly statement, then the indices “Lt”, “Pt”, “Mt”, Ft”, applicable to such succeeding monthly statement shall each be the arithmetic mean, rounded off to the second decimal place, of the relevant indices applicable to the month of measurement and to such intervening months.

11 SERVICE LEVELS

11.1 The Service Provider recognises that the City has entered into this Agreement relying specifically on the Service Provider's representations regarding service levels including, *inter alia*:

11.1.1 Capacity allocations in accordance with the Service to be provided.

11.1.2 All work to be performed and Services rendered under this Agreement shall comply with industry norms and best practice acceptable within the Services industry and shall be executed by the Service Provider to the total satisfaction of the City.

11.2 The Service Provider shall provide suitably qualified and trained employees to provide the Services to the City in terms of this Agreement, and shall allocate, in its discretion employee resources in accordance with the technical skill and knowledge required, provided that any exercise of such discretion by the Service Provider shall not negatively impact on the provision of the Services by the Service Provider to the City, and shall allocate employees with the technical skill and knowledge onsite at the City at all times during normal working hours, if the City so requires.

11.3 Amongst others, the Service Provider shall comply with and provide the Services as set out in clause 7 above.

12 WITHHOLDING OF PERFORMANCE

The Service Provider may not under any circumstances, including, without limitation, non-payment by the City, withhold any Services from the City during the currency of this Agreement, unless it validly terminates this Agreement in terms of clause Error! Reference source not found..

13 PENALTY

13.1 Should the Service Provider fail to comply with its obligations in terms of this Agreement, the City may:

13.1.1 Exercise its rights in terms of clause 25 below.

13.1.2 Impose a penalty on the Service Provider

13.2 An election of any of the above by the City shall not mean that the City has waived any other rights which the City might have in law.

13.3 Should the City elect to impose a penalty on the Service Provider with a written notice requiring the Service Provider, the City shall provide the Service Provider with a written notice requiring the Service Provider to remedy the default within 7 (seven) days from the date of delivery of the notice.

13.4 Should the Service Provider fail to remedy the default within 7 (seven) days after receiving the notice, then the City shall be entitled, without prejudice to any alternative or additional right of action or remedy available to the City and without further notice, impose a penalty, which shall be a deduction of 10% of the monthly Contract Price for the monthly Contract Period and for the monies due for payment to the Service Provider monthly in terms of clause 9 above

13.5 Should there be a dispute as to whether the failure to deliver was caused by the City or was the Service Provider's fault such dispute shall be dealt with in accordance to clause 26 below.

14 ACCESS

14.1 The City shall allow the Service Provider reasonable access to its premises, provided that:

14.1.1 Access is related to the Services to be provided by the Service Provider;
and

14.1.2 The Service Provider adheres to all rules, regulations and instructions applicable at the City's premises.

14.2 The City shall grant the Service Provider and/or its employees, to its premises to perform its obligations in terms of this Agreement.

14.3 **The Service Provider and its employees shall at all time when entering the premises and/or Service Areas and/or Delivery Areas of the City comply with all rules, laws, regulations and policies of the City.**

14.4 The service provider is required to notify the City monthly of employees who are to provide Services at the Service Areas and/or Delivery Areas.

15 INSPECTION

15.1 **The City may at any time inspect the Goods and/or Services levels of the Service Provider in terms of this Agreement.**

15.2 **If the City is, at any time, dissatisfied with the service levels then the City shall, within 7 (seven) days, notify the Service Provider in writing of the failure or default.**

15.3 **The Service Provider shall immediately upon receipt of written demand by the City, remedy such failure or default, within 7 (seven) Business Days from the date of receipt of the notice, free of charge.**

15.4 **Should the Service Provider fail to remedy the failure or default referred to above then the City shall have the right to invoke the provisions of clauses and/or clause 25 below.**

15.4.1 To enable the City to determine whether the Goods and/or Services rendered in terms of this Agreement are being complied with the Service Provider shall:

15.4.1.1 Provide the City with such information as it may reasonably require.

15.4.1.2 Allow the City to inspect and take copies of any records of the Service Provider relating to the Goods and/or Services, including all hardware ,software,ata,information,visuals,procedures,event,logs,transaction logs, audit, trails, books,records,contractsand correspondence:

15.4.13 allow the City or its authorised representatives to conduct interviews with any of the Service Provider's employees, subject to reasonable notice being given to the Service Provider.

15.5 Service Provider to Provide Reasonable Assistance

15.5.1 Where any information is required for inspection in terms of this clause and the information is kept in a computer, the Service Provider shall give the City reasonable assistance required to facilitate inspection and obtain copies of the information in a visible and legible form or to inspect and check the operation of any computer and any associated apparatus or material that is or has been in use in connection with the keeping of the information.

15.5.2 Any information required to be provided to the City pursuant to this clause 15 shall be provided by the Service Provider, as the case may be in such form (including a form otherwise than in writing) as the City may reasonably specify.

15.5.3 The cost of any inspection contemplated in terms of this clause 15 shall be for the account of the City unless any material irregularity or failure on the part of the Service Provider is determined by the City in the course of such inspection.

15.6 The inspection contemplated in this Agreement will be conducted:

15.6.1 during normal business hours; and

15.6.2 save where the circumstances justify it, on reasonable notice to the Service Provider, with the minimum interference in the provision of the Services and the Service Provider's other operations.

16 SERVICE PROVIDER'S WARRANTIES AND INDEMNITIES

16.1 Service Warranties

16.1.1 The Service Provider warrants that in relation to each Service provided in terms of this Agreement:

16.1.1.1 *It has full capacity and authority to enter into and perform this Agreement, and that this Agreement is executed by duly authorised representatives of the Service Provider.*

16.1.1.2 *It possesses or has access to the requisite knowledge, skill and experience to provide the Services in an expert manner.*

16.1.1.3 *It will discharge its obligations under this Agreement and any annexure, appendix, or Schedule hereto with all due skill, care and diligence;*

16.1.1.4 *All work performed and Services rendered under this Agreement shall comply with prevailing practice, standards, and specifications within the industry.*

16.1.1.5 *It will be solely responsible for the payment of remuneration and associated benefits, if any of its personnel and for withholding and remitting income tax for its Personnel in conformance with any applicable laws and regulations;*

16.1.1.6 *The use or possession by the City of any Materials will not subject The City to any claim for infringement of any Intellectual Property Rights of any third party;*

16.1.1.7 *With promptness and diligence and in a skilful manner and in accordance with the practices and professional standards of operations while performing Services and/or delivering Goods and/or similar to the Services and/or Goods;*

- 16.1.1.8 *Which Services and/or Goods will in all aspects comply with industry norms and best practice to the satisfaction of the City with regard to materials and workmanship;*
- 16.1.1.9 *Using and adopting any standards, processes and procedures required under this Agreement;*
- 16.1.1.10 *Free from any defects in material and workmanship;*
- 16.1.1.11 *Maintaining and causing to be maintained the highest standard of workmanship and care in undertaking the Services and/or processing the Goods;*
- 16.1.1.12 *maintaining and caused to be maintained the highest standard of care and diligence in providing the Services, maintenance and support.*
- 16.1.1.13 *Ensuring that all applicable laws are observed;*
- 16.1.1.14 *Without derogating from the generality of the foregoing, strictly adhering to any or all laws, regulations and accepted procedures with regard to health and hygiene and the maintaining of the environment in the manufacture, packaging, labelling, identification, storage and transportation of the Goods.*
- 16.1.1.15 *Guaranteeing that the Goods shall be in good working conditions for the warranty and/or maintenance period of the Goods, and that the Service Provider shall be responsible for the costs of repair of the Goods should the Goods require to be repaired to normal use.*

16.1.1.16 warranting that it shall employ suitably qualified and trained employees to provide the Services and/or Goods to the City and it shall allocate employees in accordance with the technical skill and knowledge required.

16.2 Indemnity

16.2.1 The Service Provider hereby indemnifies the City against any claim which may be brought against the City by the Service Provider's personnel or a third party arising from the execution of this Agreement alternatively which arises against the City as a result of the Service Provider's breach of any of the provisions of this Agreement, provided that the City shall notify the Service Provider in writing within a reasonable time, and in any event not less than 14 (fourteen) Business days of the City becoming aware of any such claim to enable the Service Provider to take steps to contest it and shall provide the Service Provider with such reasonable assistance as may be necessary to enable the Service Provider to defend the claim to the extent only that it is in a position to render such assistance. The Service Provider may, within 5 (five) Business Days of receipt of written notice from the City aforesaid, elect in writing to contest such a claim in the name of the City and shall be entitled to control the proceedings in regard thereto, provided that the Service Provider indemnifies the City against all and any costs (including attorney and own client costs) which may be incurred by or awarded against the City as a consequence of the defence of the claim.

17 SERVICE PROVIDER'S PERSONNEL

17.1 Liability for Criminal Acts of Employees

The Service Provider shall be liable to the City for any loss that the City or any third party may suffer as a result of any theft, fraud or other criminal act of any employee of the Service Provider which arises within the course and scope of such employees' employment with the Service Provider.

17.2 Character of Employees

17.2.1 Due to the confidential nature of certain aspects of the Services and the position of trust which the Service Provider's employees will fulfil, the Service Provider hereby undertakes to use its best commercial endeavours to ensure that it only assigns to the City employees who are fit and proper persons and who display the highest standards of personal integrity and honesty and who have not, to their knowledge, being convicted of any crime.

17.2.2 The Service Provider shall, at its own cost, conduct all reasonable background checks into members of its employees prior to utilizing same to provide the Services in terms of this Agreement.

17.3 The City shall conduct all reasonable background checks into the Service Provider's employees from time to time, where it deems it necessary to do so.

18 STATUTORY AND EMPLOYMENT ISSUES

18.1 The Service Provider shall comply with all employment legislation

18.1.1 The service Provider warrants that it has full knowledge of all relevant statutory, collective and other stipulations applicable to the relationship with its personnel and its relationship with the City. This includes, but is not limited to the Labour Relations Act, the Basic Conditions of Employment Act, 1977, the Employment Equity Act, 1988 and any other applicable employment legislation currently in force.

18.1.2 The Service Provider warrants further that it is not and will not in future be in contravention of any of the provisions of any such legislation and in the event of such contravention, the Service Provider of any contravention of such legislation in writing ,the Service Provider shall, within 10 (ten) days after receipt of such notice, take all steps necessary to remedy such contravention. And shall keep the City informed regarding the steps taken and the implementation and the result thereof.

18.2 No employment

The Service Provider warrants that none of its personnel shall be regarded as employees of the City. The Service Provider shall assist to defend and bear all costs in the event that the City is required to defend a claim, whether civil or employment related, instituted against it by the Service Provider's personnel should the City defend the matter, the Service Provider hereby indemnifies the City against all and any costs (including attorney and own client costs) which may be incurred by or awarded against the City as a consequence of the defence of the claim.

18.3 Occupational Health and Safety Act, 1993

The Service Provider shall be responsible for ensuring compliance with all the provisions of the Occupational Health and Safety Act, 1993 and it indemnifies the City against any claim which may arise in respect of such Act by its personnel against the City.

19 SUB-CONTRACTING

- 19.1 The Service Provider may not Subcontract the whole of or any portion of the Services in terms of this Agreement to any third party.**
- 19.2 In the event the Service Provider wishes to Subcontract the whole of or any portion of the Services in terms of this Agreement, it shall apply to the City in writing for consent to do so.**

19.3 In its application, the Service Provider shall give the name of the Subcontractor, the Subcontractor's obligations, the proposed date of commencement of the Subcontract which shall include the fees payable to the Subcontractor, and a report of the background security check on the Subcontractor's suitability, financial and otherwise.

19.4 The City may, in its sole and absolute discretion refuse consent to Subcontract. In the event the City approves the Subcontracting of the whole of or any portion of the Services in terms of this Agreement, then:

19.4.1 the Service Provider shall ensure that the Subcontractor's B-BBEE level is equal or better than that of the Service Provider, their price is competitive, and they have the capacity to provide the Service;

19.4.2 such Subcontracting shall not absolve the Service Provider from responsibility for achieving the Service Levels or complying with its obligations in terms of this Agreement and the Service Provider hereby indemnifies and holds the City harmless against any loss, harm or damage which the City may suffer as a result of such Subcontracting;

19.4.3 the Service Provider shall at all times remain the sole point of contact for the City in respect of the acquisition of Services by the City; and

19.4.4 no such Subcontracting shall have any effect on the Contract Price and charges payable by the City to the Service Provider in terms of this Agreement.

20 CONFIDENTIALITY

20.1 The Service Provider acknowledge that all information relating to the City confidential business and technical information, data, documents or other information necessary or useful for the carrying on by the City of its business which shall include, but shall not be limited to operating procedures, quality control procedures,

approximate operation personnel requirements, descriptions and trade names and trademarks, know how, techniques, technology, information relating to clients, customers, suppliers, relevant authorities, copyright, trade secrets and all goodwill relating to the business and any other intellectual property rights, technical data and documents in whole or in part, used by the City in respect of its business; (“Confidential Information”), shall remain confidential and shall not be made known unless the City has given written consent to do so.

20.2 The information provided by the City in the context of this Agreement is Confidential Information and the Service Provider shall take all reasonable measures to keep the information confidential and will only use the information for the purpose for which it was provided.

20.3 The Service Provider undertakes to not disclose any such Confidential Information. However, there will be no obligation of confidentiality or restriction on use where:

20.3.1 The information is publicly available, or becomes publicly available otherwise than by action of the receiving Party; or

20.3.2 The information was already known to the receiving Party (as evidenced by its written records) prior to its receipt under this or any previous agreement between the Parties or their affiliates; or

20.3.3 The information was received from a third Party not in breach of an obligation of confidentiality.

21 INTELLECTUAL PROPERTY RIGHTS

21.1 All Intellectual Property Rights of the Service Provider and/or third-party vest in the Service Provider and/or third party, as appropriate.

21.2 All rights in the City name and logo remain the absolute property of the City.

- 21.3 The Service Provider warrants that no aspect of the Services provided in terms thereof will infringe any Patent, Design, Copyright, Trademark or trade secret or other proprietary right of any third party.
- 21.4 The Service Provider shall promptly notify the City, in writing, of any infringement or apparent or threatened infringement or any circumstances which may potentially give rise to an infringement, or any actions, claims or demands in relation to any Intellectual Property Rights.
- 21.5 In the event the City becomes aware of any such infringement, the Service Provider shall, at its cost, defend the City against any claim that the Services infringe any such third party Intellectual Property Rights, provided that the City gives notice to the Service Provider of such claim and the Contractor controls the defence thereof. The Service Provider further indemnifies the City against, and undertakes that it will pay all costs, damages and attorney fees, if any, finally awarded against the City in any action which is attributable to such claim and will reimburse the City with all costs reasonably incurred by the City in connection with any such action.
- 21.6 Should any claim be made against the City by any third party in terms of clause 21.1 above, the City shall give the Service Provider written notice thereof within 3 (three) days of becoming aware of such claim to enable the Service Provider to take steps to contest it.
- 21.7 Should any third party succeed in its claim for the infringement of any third-party proprietary rights, the Service Provider shall, at its discretion and within 30 (thirty) days of the Services having been found to infringe, at its own cost:
- 21.7.1 Obtain for the City the right to continue using the subject of infringement or the parts thereof which constitute the infringement;
or

- 21.7.2 replace the subject of infringement or the parts thereof which constitute the infringement with another product or service which does not infringe, and which is materially similar to the subject of infringement; or
- 21.7.3 Alter the subject of infringement in such a way as to render it non-infringing while still in all respects operating in substantially the same manner as the subject of infringement; or
- 21.7.4 Withdraw the subject of infringement.

22 FORCE MAJEURE

- 22.1 **For the purposes hereof, Force Majeure shall mean civil strife, riots, insurrection, sabotage, national emergency, acts of war of public enemy, rationing of supplies, flood, storm, fire or any other like forces of nature beyond the reasonable control of the party claiming Force Majeure and comprehended in the terms thereof.**
- 22.2 **If Force Majeure causes delays in or failure or partial failure of performance by a Party of all or any of its obligations hereunder, this Agreement shall be suspended for the period agreed in writing between the Parties.**
- 22.3 **In the event of circumstances arising which the other Party believes that it constitutes a Force Majeure (“the Affected Party”) then such Affected Party shall send, within 5 (five) days from the interrupting circumstances, a written notice of the interrupting circumstances specifying the nature and date of commencement of the interrupting event to the other Party. The Parties shall agree, in writing, to suspend the implementation of this Agreement for a specific period (“Agreed Period”).**
- 22.4 **In the event that both Parties reasonably believe that the Affected Party shall be unable to continue to perform its obligations after the**

Agreed Period, then either Party shall be entitled to terminate this Agreement without further notice to the other Party.

- 22.5 The Party whose performance is interrupted by the interrupting circumstances shall be entitled, provided that such party shall have given notice to that effect with a written notice of the interrupting circumstances as provided above, to extend the period of this Agreement by a period equal to the time that its performance is so prevented

23 CESSATION

The Service Provider shall not be entitled to cede or assign or transfer in any other way and/or alienate its rights and obligations in terms of this Agreement without the prior written consent of the City.

24 CHANGE OF CONTROL / CIRCUMSTANCE

- 24.1 The Service Provider shall notify the City, in writing, of any change in the Service Provider's shareholding or membership or any change in the Service Provider's subsidiary companies or holding or its affiliates (such change shall be considered a material change in the constitution and identity of the Service Provider. The City may terminate this Agreement upon becoming aware of such material change.
- 24.2 The Parties agree that should there be a change as envisaged in clause 24.1 above, the Service Provider will no longer exist and a new third party/entity shall have been constituted. In this regard, such third party shall not be entitled to inherit any of the Service Provider's rights and obligations in terms of this Agreement, which will only be transferred to the new entity in writing by the City following the City's satisfaction and approval in writing of such new entity.
- 24.3 The Service Provider shall further notify the City of any material changes or circumstance which might have led the City to appoint the Service Provider to Provide the Goods and/or Services. In the event that any material change or circumstance occurs and the Service Provider fails to inform the City of such a change or circumstance, the Service Provider shall be deemed to have

breached a material term of this Agreement and the City shall be entitled to cancel the Agreement on 1 (one) month's prior notice.

25 BREACH

25.1 Subject to clause 24.3 above, should either Party commit a breach of any term of this Agreement ("the Defaulting Party") then the affected party ("Aggrieved Party") shall be entitled to inform the Defaulting Party in writing to remedy such failure or default within 5 (five) Business Days and should the Defaulting Party fail to remedy the breach within 5 (five) Business Days after receipt of the notice the so Aggrieved Party shall be entitled, without prejudice to any of its rights under this Agreement or law to:

25.1.1 Immediately terminate this Agreement without giving written notice and claim damages (which shall include legal costs on an attorney/client scale); or

25.1.2 Request specific performance and claim damages (which shall include legal costs on an attorney/client scale); or

25.1.3 impose penalties as provided for in clause **Error! Reference source not found.**

26 EARLY TERMINATION

The City shall have the right to terminate this Agreement by giving 30 (thirty) days' notice in writing to the Service Provider of its intention to terminate the Agreement.

27 DISPUTES

27.1 Save for clause 25 above or any other clause in this Agreement which provides for its own remedy, should any dispute arise between the Parties in respect of or pursuant to this Agreement, including, without limiting the generality of the foregoing, any dispute relating to:

27.1.1 The interpretation of the Agreement.

- 27.1.2 The performance of any of the terms of the Agreement.
 - 27.1.3 Any of the parties' rights and obligations;
 - 27.1.4 Any procedure to be followed;
 - 27.1.5 The termination or cancellation or breach of this Agreement; or
 - 27.1.6 The rectification or repudiation of this Agreement; then any Party may give the other Party written notice of such dispute, in which event the provisions below shall apply.
- 27.2 Within 7 (seven) days of the declaration of such dispute, the Parties representatives or their nominated persons shall meet in the spirit of goodwill and endeavour to resolve the dispute, failing which (and without prejudice to any other alternative dispute resolution to which the Parties may agree, either prior to or concurrently with arbitration) the provisions of this clause 26 above shall apply.**
- 27.3 If the Parties are unable to resolve the dispute within 14 (fourteen) days of the notice of the dispute (or such longer period as they may have agreed to in writing), then either Party may, on written notice to the other Party, require that the dispute be submitted to and decided by arbitration, in terms of the Arbitration Act, 42 of 1965 of South Africa ("the Arbitration Act").**
- 27.4 The arbitration shall be held under the provisions of the Arbitration Act provided that the arbitration shall be:**
- 27.4.1 At any place which the Parties agree, in writing, to be mutually convenient.
 - 27.4.2 in accordance with such formalities and/or procedures as may be settled by the arbitrator and may be held in an informal and summary manner, on the basis that it shall not be necessary to observe or carry

out the usual formalities of procedure, pleadings and/or discovery or respect rules of evidence.

27.5 If the arbitration is:

27.5.1 A legal matter, then the arbitrator shall be a practicing advocate or a practicing attorney of not less than 10 (ten) years' standing;

27.5.2 An accounting matter, then the arbitrator shall be a practicing-chartered accountant of not less than 10 (ten) years' standing;

27.5.3 Any other matter, then the arbitrator shall be any independent person agreed upon between the parties.

27.6 Should the Parties fail to agree on an arbitrator within 14 (fourteen) days after the arbitration has been demanded, then the arbitrator shall be nominated at the request of either of the Parties, by the president for the time being of the Law Society of the Northern Provinces.

27.7 Should the Parties fail to agree whether the dispute is of a legal, accounting, or other nature within seven (7) days after the arbitration has been demanded, and then it shall be deemed to be a dispute of a legal nature.

27.8 The arbitrator may:

27.8.1 investigate or cause to be investigated any matter, fact or thing which he considers necessary or desirable in connection with the dispute and for that purpose, shall have the widest powers of investigating all documents and records of any party having a bearing on the dispute;

27.8.2 Interview and question under oath the parties or any of their representatives;

27.8.3 Decide the dispute according to what he considers just and equitable in the circumstances; and

27.8.4 Make such award, including an award for specific performance, damages or otherwise, as he in his discretion may deem fit and appropriate. The arbitration shall be held as quickly as possible after it is requested, with a view to it being completed within thirty (30) days after it has been so requested.

27.9 The arbitrator's decision and award shall be in writing with reasons and shall be final and binding upon the Parties.

27.10 The arbitrators award may, on application by either Party to a court of competent jurisdiction and after due notice is given to the other Party, be made an order of court.

27.11 Notwithstanding the provisions of clauses 27.1, 27.2, 27.3, 27.4, 27.5, 27.6, 27.7 above, in the event of either Party having a claim against the other Party for a liquidated amount or an amount which arises from a liquid documents, or for an interdict or other urgent relief, then the other Party having such a claim shall be entitled to institute action therefore in a court of law rather than in terms of the above clauses, notwithstanding the fact that the other Party may dispute the claim.

27.12 The provisions of this clause 27 are severable from the rest of this Agreement and shall remain in effect even where this Agreement is terminated or cancelled for any reason.

28 LAWS AND JURISDICTION

28.1 This Agreement shall be governed by and interpreted according to the Law of the Republic of South Africa.

28.2 Each Party submits to the exclusive jurisdiction of the South African courts in respect of any matter arising from or in connection with this Agreement including its termination. Each Party further

consents to the jurisdiction of the High Court of South Africa (North Gauteng High Court (Pretoria)).

29 NOTICES AND COMMUNICATIONS

29.1 The Parties choose as their respective *domicilium citandi et executandi* (hereinafter referred to as the “*domicilium*”) and for the delivery of any notices arising out of the Agreement or its termination or cancellation, whether in respect of court process, notices or other documents or communications of whatsoever nature (including the exercise of any option), the address set out below:

29.2 Each Party shall be entitled from time to time, by written notice to the other Party, to vary its *domicilium* to any other address which is not a Post Office Box or a Poste Restante.

29.3 Any notice given and any documentation delivered by any Party to another Party (hereinafter referred to as “the addressee”) which:

29.3.1 Is delivered by hand during normal business hours of the addressee at the addressee’s *domicilium*, shall be deemed, until the contrary is proved by the addressee, to have been received by the addressee at the time of delivery;

29.3.2 is posted by prepaid registered post to the addressee at the addressee’s *domicilium* shall be deemed, until the contrary is proved by the addressee, to have been received on the 7th (seventh) day after the date of posting.

29.3.3 is sent by email or facsimile machine shall be deemed, until the contrary is proven by the addressee, to have been received within 1 (one) hour of transmission where it is transmitted during business hours of the receiving instrument and at noon on the following business day (excluding Saturdays) where it is transmitted outside such business hours.

29.4 Any notice or communication required or permitted in terms of this Agreement shall be valid and effective only if in writing, but it shall be competent to give notice by email.

29.5 Notwithstanding anything to the contrary in this Agreement a notice or communication actually received by one Party shall be an adequate notice or communication notwithstanding that it was not sent to or delivered at the chosen *domicilium citandi et executandi*.

30 GENERAL AND MISCELLANEOUS

30.1 SOLE RECORD OF AGREEMENT

This Agreement constitutes the sole record of the agreement between the parties with regard to the subject matter hereof. No party shall be bound by any express or implied term, representation, warranty, promise or the like not recorded herein.

30.2 NO AMENDMENT EXCEPT IN WRITING

No addition to, variation of, or agreed cancellation of, this Agreement shall be of any force or effect unless in writing and signed by or on behalf of the parties. Any alleged waiver of this requirement must itself be reduced to writing and signed by the relevant party to be of any effect.

30.3 WAIVERS

No relaxation or indulgence which any party may grant to any other shall constitute a waiver of the rights of that party and shall not preclude that party from exercising any rights which may have arisen in the past or which might arise in future.

30.4 SURVIVAL OF OBLIGATIONS

Any provision of this Agreement which contemplates performance or observance subsequent to any termination or expiration of this Agreement shall survive any termination or expiration of this Agreement and continue in full force and effect.

30.5 APPROVALS AND CONSENTS

An approval or consent given by a party under this Agreement shall only be valid if in writing and shall not relieve the other party from responsibility for complying with the requirements of this Agreement nor shall it be construed as a waiver of any rights under this Agreement except as and to the extent otherwise expressly provided in such approval or consent, or elsewhere in this Agreement. Any alleged waiver of the requirement that the approval or consent must be in writing must itself be reduced to writing and signed by the relevant party to be of any effect.

31 EXECUTION

31.1 This Agreement may be executed in several counterparts, which shall each be deemed an original, but all of which shall constitute one and the same instrument. A facsimile shall constitute a valid counterpart for all purposes hereunder.

31.2 The signatories to this Agreement by their signature warrant their authority to enter into this Agreement and the capacity of their

principal, if signing in a representative capacity, to enter into this Agreement.
