AMENDMENT TO THE TENDER DOCUMENT: THESE CLARIFICATIONS MUST BE READ TO FORM PART OF THE TENDER.

1. General Statement of the Intent

- a. This tender does not aim to appoint any specific category or discipline, nor does it seek tenderers to submit specific resources or similar
- b. This tender does not seek to appoint JV's - see Tender pg. 4, but seek to appoint built environment professional service providers who has experience in multi-discipline projects, either in its own capacity, or as a JV/ Consortium/ Partnership/ Lead Consultant in previous projects - as long as such can be evidenced with the information required in the tender.
- c. Bidders need to adhere to all tender conditions and evaluation criteria, in view of submission and assessment requirements.
- d. Only those bidders who are successful in this tender process and subsequently added to the panel, will be required to provide any service-related disciplines as defined in that relevant tender process. The method of such service/ resource sourcing remains the responsibility of the bidder, as long as the bidding entity remains exactly as per panel appointment (in other words you cannot then submit a bid as a different entity).

2. Functional Criteria (iii) and (iv)

- a. The score breakdown of these criteria follows a logical score order of 0,1,2,3,4,5. Any numerical order error's within these two criteria sets, therefore follow the order of 0,1,2,3,4,5 and will be applied accordingly.

3. Clarifications

- a. The table provided on the next page, provides a detailed response to the points of enquiry received from tenderers – the DBSA aims to respond to all other enquiries received post this list – kindly remain updated to all Addenda published, as not to duplicate enquiries.

Furthermore, kindly advise whether we are required to submit project experience demonstrating multi-disciplinary services, or if it would be acceptable to submit project experience relevant only to the specific discipline(s) for which we are bidding	Refer to Addendum 01 as published – The tender does not require disciplines to be tendered on.

	The document states that a formal client reference letter must be submitted using the template provided in Annexure A . However, we were unable to locate Annexure A in the tender document.
