The municipality reserves the right to withdraw any invitation to quotation and / or re-advertise or to reject any formal quotation or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this quotation may not materialize.

Formal Quotation will be evaluated and adjudicated in terms of **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2017) and the Municipality's Supply Chain Management Policy. **Further noting that Local Content and Production will form part of evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.**

**The following items are designated sectors with Local Content thresholds:**

- **Cement: 100%**
