SCOPE OF WORK

- Review of the financial records/transactions, preparation of reconciliations and assistance with adjustment journals to ensure accuracy/correctness of the Trial Balance figures;
- Review the asset register to ensure accuracy and completeness. The AFS service provider will have an obligation to advise the Ikhala College on any gaps/discrepancies identified in the Asset Register that can lead to a qualification/disclaimer and assist the Ikhala College to rectify and record properly;
- Compile Annual Financial Statements for the 2024/2025; 2025/2026 & 2026/2027 financial years that fully comply with applicable Generally Recognised Accounting Practice (GRAP) standards for submission to Auditor general each year. Draft set of Annual Financial Statements must be ready annually for submission to Audit Committee; service providers should take note that financial statements submitted to the Audit committee annually to the Auditor General;
- It is compulsory that Annual Financial Statements (including notes, workings and schedules) be compiled/done on Caseware software. Therefore, it is essential that Prospective service providers are in possession –and are well conversant with this software;
- Assess and address matters of prio-years to ensure compliance and improved audit outcomes.
- Compilation of audit files for each of the financial years in line with National Treasury guidelines;
- Addressing audit queries raised by Auditor General during the last three audits of 2021/2022; 2022/2023 and 2023/2024 financial year as well as addressing prior year finding of financial years and adjust accordingly where necessary/ as agreed upon with Auditor General;
