The Abaqulusi Local Municipality hereby invites proposals from all suitable and experienced bidders to **Bids for the management and operate Portion 16 of the Farm Grootgewaacht No.76 in extent of 612 hectares and Leasehold No. 7 over the Remainder of Vryheid Townlands in extent of 167 Hectares**. The intention of the municipality is to award a long term contract to the successful bidder for a period not exceeding 30 years, for the primary use of forestry and associated activities. The proposals submitted will be evaluated on in terms of the following criteria:

- First Stage: Returnable and Completeness then Functionality; 100% (minimum threshold 75%)
- Second Stage: Preferential Point System (90/10); 90 for price and 10 for B-BBEE contribution. Only bidders who pass the first stage with a minimum of 75% will then be evaluated further in the second stage.

Abaqulusi Municipality is the owner of 2 pieces of land situated to the North East of Vryheid Town, with a combined size of 779 Ha and are known as Portion 16 of the Farm Grootgewaacht No.76 in extent of 612 hectares and Leasehold No. 7 over the Remainder of Vryheid Townlands in extent of 167 Hectares.

The properties are currently utilized for agricultural timber production under a lease agreement that expired in 2020. The properties are currently under short term caretaker arrangement.

The amount of timber existing on the properties, as well as its varying age is estimated as follows:

Pine Trees: 350 Ha

Wattle Trees: 308 Ha

Gum Trees: 28 Ha

Please note that these are close estimate figures and the age of each species vary.

It is expected that the successful bidder will enter into a 30-year agreement with Abaqulusi Municipality for the utilization of aforesaid land for agricultural purposes. The property has within itself a clubhouse and a dam which is used for recreational purposes.
