The briefing presentation will also be made available on the National Treasury's e-Tender Publication Portal at www.etenders.gov.za.

2.1 Despite the briefing session being non-compulsory, Transnet nevertheless encourages all Respondents to attend. Transnet will not be held responsible if any Respondent who did not attend the **non-compulsory** session subsequently feels disadvantaged as a result thereof.

2.2 Respondents are encouraged to have a copy of the RFP with them for the RFP briefing.

3 PROPOSAL SUBMISSION

3.1 Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalisation strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

a) The Transnet e-Tender Submission Portal can be accessed as follows:

- Log on to the Transnet eTenders management platform website/ Portal (transnetetenders.azurewebsites.net) Please use **Google Chrome** to access Transnet link/site);
- Click on "ADVERTISED TENDERS" to view advertised tenders;
- Click on "SIGN IN/REGISTER – for bidder to register their information (must fill in all mandatory information);
- Click on "SIGN IN/REGISTER" - to sign in if already registered;
- Toggle (click to switch) the "Log an Intent" button to submit a bid;
- Submit bid documents by uploading them into the system against each tender selected.
- No late submissions will be accepted. The bidder guide can be found on the Transnet Portal transnetetenders.azurewebsites.net

4 RFP INSTRUCTIONS

4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.

- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) as per the B-BBEE Preferential Procurement Regulations, 2017 preference point scoring.

6 PREFERENTIAL PROCUREMENT PREQUALIFICATION CRITERIA

6.1. Minimum B-BBEE level

Transnet has decided to set a minimum B-BBEE threshold for participation in this RFP process. The minimum B-BBEE threshold in this instance is a B-BBEE Level of 1 to 4, and Respondents who do not have at least these B-BBEE status's will be disqualified.

7 COMMUNICATION

- 7.1 For specific queries relating to this RFP, an RFP Clarification Request Form should be submitted onto the system and to [Suellen Du Plessis] before **16h00 on 18 January 2023**, substantially in the form set

out in Section 8 hereto. In the interest of fairness and transparency, Transnet's response to such a query will be published on the e-tender portal and Transnet website.

- 7.2 After the closing date of the RFP, a Respondent may only communicate with Suellen Du Plessis, at email: Suellen.duplessis@transnet.net on any matter relating to its RFP Proposal.
- 7.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 7.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 7.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

8 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

9 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

10 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

11 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 11.1 modify the RFP's Services and request Respondents to re-bid on any such changes;
- 11.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 11.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 11.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 11.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 11.6 split the award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 11.7 cancel the bid process;
- 11.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;

- 11.9 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 11.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 11.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 11.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods/Services at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the next ranked bidder(s) were issued with a Letter of Regret. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods/Services at their quoted price, even after they have been issued with a Letter of Regret.

Note that Transnet will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

12 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

13 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

14 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

For this purpose, the attached SBD 1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.

15 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

1 BACKGROUND

Transnet's strategic intent is to optimise its business processes and to introduce automation to ensure maximum efficiency is obtained in the running of its business operations. To meet these business objectives, the organisation continues to invest in technologies to modernise its business processes.

A core building block for digital acceleration is the ability to be adaptable and agile in meeting end-user demand. Cloud Computing enables IT to be responsive to business demand and remains the core underpinning for digital acceleration. Cloud computing is typically defined in the industry as a style of computing in which scalable and elastic IT-enabled capabilities are delivered as a service using Internet technologies.

Transnet has been using cloud computing as a platform to underpin its digital operations for the last several years and this technology remains core for digitalisation of core business processes. To that extent the organisation adopted and implemented a cloud policy in 2018 which ensures that cloud options will always be considered when new workloads are provisioned.

The need to have adaptive computing environments have grown steadily as the organisation continues to invest in disruptive technologies such as the Internet of Things (IoT), Predictive Analytics and Algorithmic modelling. Cloud computing provides the most appropriate infrastructure to be used for these technologies and unlock many benefits including:

- Scalability – the ability to provide scalable solutions on an as and when needed basis.
- Adaptability – to be responsive to growing business requirements.
- Platform modernisation – Including the ability to provide cost effective solutions such as DR as a service.
- Cost optimisation – Ability to implement consumptive-based computing with the capability to apply cost reduction mechanisms to spun-up environments.
- Disaster recovery modernisation.

2 EXECUTIVE OVERVIEW

Transnet is seeking the services of a Cloud Service Provider (CSP) that can support Transnet in its objective to modernise its infrastructure and digital services landscape. The tender focuses predominantly on the provision of cloud computing Infrastructure (IaaS) services as the organisation seeks to modernise its hybrid computing environment.

The selected CSP must provide Transnet with a fully-fledged and operational cloud platform with the ability to scale based on business demand. As such the CSP will have the necessary certifications in place to be deemed as a fully functional cloud data centre, including having the necessary security protocols in place to ensure that Transnet systems and data is safe and secured.

3 CURRENT ENVIRONMENT

Transnet currently uses a public cloud platform for the provision of public cloud computing services. The Transnet tenant is made up of multiple subscriptions that are allocated and managed by the different operating divisions (OD's) within the organisation.

Infrastructure as a Service (IaaS) is currently made up of but not limited to the consumption of the following services:

- Cloud infrastructure.
- Storage.
- Databases.
- Security
- Networking.
- Operating systems.

These services are consumed by the following Operating Divisions (ODs) within Transnet:

- Transnet Corporate Centre
- Transnet Port Terminals
- Transnet Pipelines
- Transnet Port Authorities
- Transnet Foundation
- Transnet Engineering

Not all of Transnet's operating divisions consume cloud services, however, there is a growing demand to expand the organisation's cloud footprint to offer a fully scalable and adaptable hybrid computing service to meet business demand. Cloud computing will therefore enable ICT functions to be adaptable to growing demand for computing services, however, cost optimisation becomes fundamental to ensure that the services delivered are done at the lowest cost possible.

Infrastructure computing services are used on a consumptive bases with workloads either provisioned on pre-commit agreements or on a pay-as-you consume agreement. Detailed cost management and performance reporting is provided on a real-time basis which is fundamental to achieving performance and cost optimisations.

4 SCOPE OF WORK

1) Cloud Hosting

Transnet's need for hosting services will vary from workload to workload and will be dependent on the level of customization and flexibility required to manage the workload. The following hosting services will be required from the cloud service provider (CSP):

a.) Infrastructure as a Service (IaaS)

Opportunities will exist where applications or services must be re-platformed on the cloud using IaaS models. This could be related to on-premise hardware reaching end of life status or a migration strategy to cloud services.

The Cloud Service Provider is required to create, host and manage IaaS workloads in a fully-fledged cloud platform and provide technical support for IaaS workloads.

b.) Platform as a Service (PaaS)

Platform as a Service offers the opportunities for a more comprehensive management of cloud workloads including underlying operating systems and supporting databases. Where opportunities exist workloads will be re-platformed as PaaS services allowing the organisation to benefit from more optimised cloud environments.

The CSP is required to create, manage and host PaaS workloads in a fully-fledged cloud platform and provide technical support for PaaS workloads.

2) Cloud Security

Cloud Security is of critical importance and CSP's must ensure that security provided is equal to or higher than the security provided by traditional non-cloud IT environments.

The CSP must also provide the following security protocols. The list is not exhaustive but are the minimum requirements to secure Transnet workloads in the cloud.

DDoS Protection

- Distributed denial of service (DDoS) attacks is some of the largest availability and security concerns facing customers that are moving their applications to the cloud. A DDoS attack attempts to exhaust an application's resources, making the application unavailable to legitimate users. DDoS attacks can be targeted at any endpoint that is publicly reachable through the internet.

The CSP must be able to safeguard Transnet workloads from DDoS attacks.

Role Based Access

- RBAC allows for segregation of duties within teams with access provisions applied based on role profiles.

The CSP must implement role-based authorisations on their cloud platform.

Firewall configuration

- Transnet currently makes use of Palo Alto Firewalls and have integrated it with its existing cloud platform. Additional firewall routing has been applied to the firewalls to allow for traffic to flow between the internal Transnet network and the Cloud environment.

The CSP must be able to integrate with existing firewall infrastructure as deployed by Transnet.

Cloud Certifications/Legislation

- In line with the focus on security it is important that the service provider have the appropriate security related certifications in place to ensure security compliance:
 - ISO/IEC 27017 - provides guidelines for information security controls applicable to the use of cloud services.
 - ISO/IEC 27018 - It provides a higher security to customer data and information.
 - TIA-942 - Standard covers the telecommunications infrastructure and all other aspects of a mission-critical data centre.

CSP's will be required to provide these certifications indicating compliance to cloud security standards.

Transnet requires workloads and services that must meet POPIA compliance to be hosted in data centres that are POPIA compliant or higher such as General Data Protection Regulation (GDPR).

The CSP will be required to ensure POPIA compliance or higher such as GDPR.

3) Integration between on-premise and cloud environments

Transnet has adopted a hybrid computing model and will have an on-premise/cloud environment in place for a considerable period in the future.

The CSP must be able to seamlessly integrate between on-premise and cloud environments, including the authentication of user profiles between on-premise and cloud.

4) Cloud elasticity

There will be considerable migration of on-premise environments to cloud as the organisation becomes more mature in its usage of cloud platforms. The dynamic allocation/deallocation of cloud resources therefore becomes fundamental as the organization's resources requirements will vary daily.

The CSP must be able to auto scale based on user demand.

5) Workload optimisations

Optimization of workloads are fundamental to ensure that the cost of cloud computing provisioning remains viable and competitive to on-premise environments. Optimization capabilities will include the following:

- Ability to programmatically start and stop workloads based on demand.
- Ability to size/resize workloads dynamically.
- Ability to identify where workloads are not fully optimized.
- Ability for self-service capabilities to optimize cloud environments.

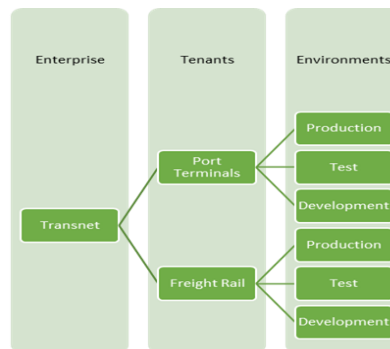
CSP's must be able to fully optimize Transnet's cloud based on the capabilities outlined above.

6) Implementing a hierarchical cloud provisioning model including hierarchical Cost Management structures

The aim of this tender is to source a cloud platform for Transnet and all its operating divisions (OD) (Transnet Corporate Centre, Transnet Freight Rail, Transnet Pipelines, Transnet National Ports Authority, Transnet Port Terminals, Transnet Engineering, Transnet Foundation and Transnet Property).

Workloads will therefore be provisioned per operating division and the consumption of cloud services will be OD specific under one Transnet tenant.

The diagram below typically demonstrates the hierarchical model to be implemented which will then include the allocation of costing per OD tenant under the enterprise agreement.



Based on this operating model the following capabilities are required:

- The CSP must be able to provision multiple tenants (OD's) under a single cloud agreement.
- The CSP must also be able to provide cost management and reporting per operating division as opposed to costing at a consolidated or enterprise level.

7) Performance reporting

Performance reporting is essential to ensure that workloads provisioned are fully optimized.

The CSP must be able to provide Transnet with dashboards where the performance of all cloud workloads can be monitored and managed accordingly. This type of reporting will typically be role-based and profile driven to ensure that the necessary authorizations are enforced.

8) Contract Management

- To ensure compliance with contractual conditions and commitments the CSP must provide evidence of its contract management platform where all administrative matters of the cloud agreement can be managed. This will include cost management, workload management and the ability to dynamically add and delete workloads from tenant subscriptions.
- Under the agreement, Transnet will typically enrol workloads either as pay-as-you-consume or on pre-commit agreements. The CSP's contract management portal must be able to provision workloads either as pay-as-you-consume or based on pre-commit agreements.

9) Training

The CSP must provide Transnet with training to skill up its workforce in the creation, monitoring and management of its workloads in the service provider's cloud platform and provide support to Transnet in ensuring that its staff are certified to support workloads in the service provider's cloud platform.

10) Workload Migrations

Transnet requires a transition period of 3 months to move from one data centre to another. The CSP will be required to migrate existing workloads from the current public platform utilized by Transnet to the new platform which will entail the following:

- Technically preparing the workloads to be migrated from existing platform to the new cloud platform.
- Migration will include databases, data within these databases, application specific configurations and any networking and security protocols to be implemented.

Refer to Annexure D for a list of Virtual Machines (VMs) to be migrated.

The CSP must submit a proposed plan of how it intends to migrate Transnet workloads from the existing cloud platform to the service provider's cloud platform. This plan must include the following:

- The technical mechanisms it will employ to migrate workloads.
- Duration of the migration. Transnet has about 90 workloads in its current cloud platform and requires a maximum 3-month transition plan.
- Training staff to manage workloads in the new tenant.

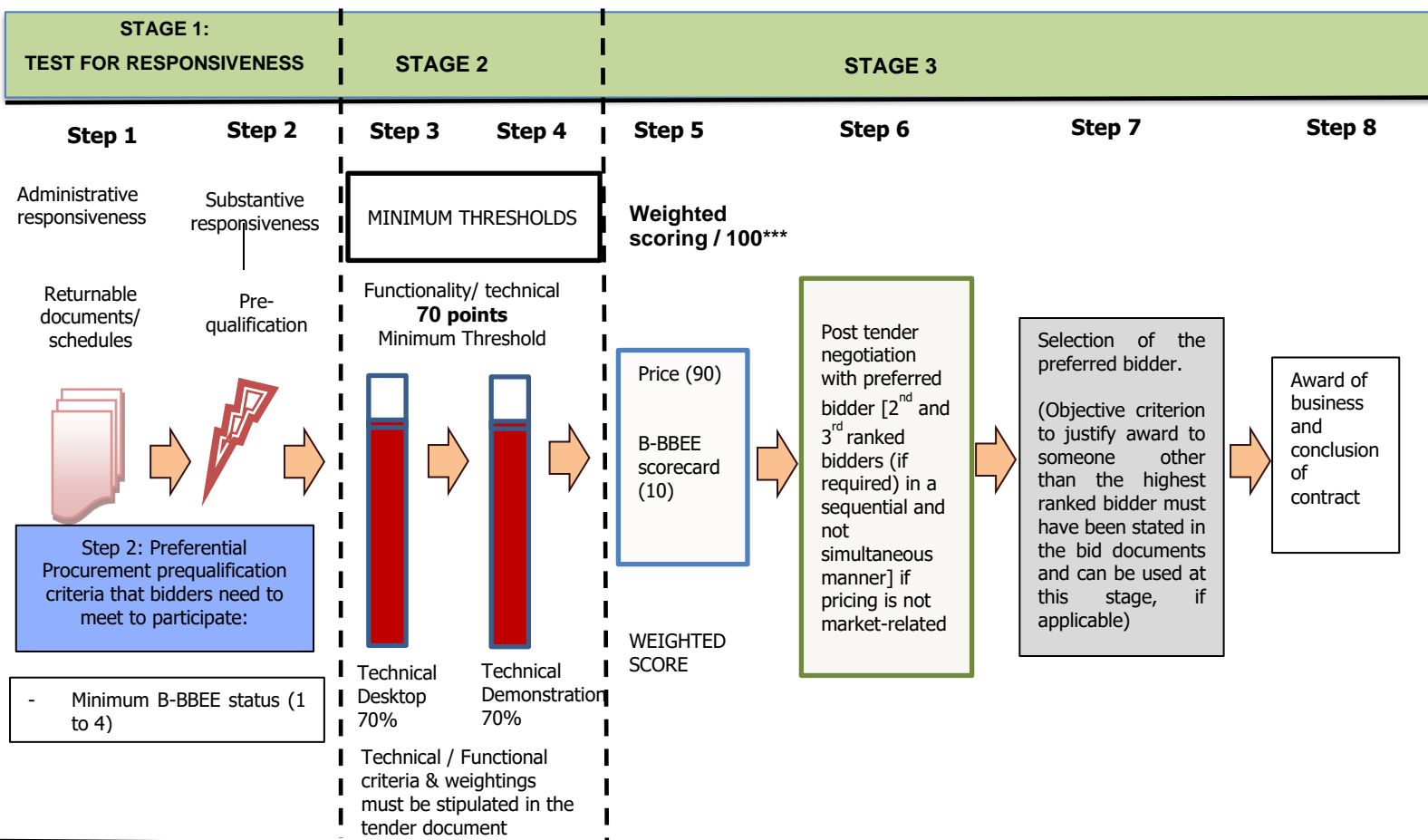

7.7 STEP SIX: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:

- first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.5 Failure on the part of a bidder to submit proof of B-BBEE status level of contributor together with the bid will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (h) **"Price"** includes all applicable taxes less all unconditional discounts.

 - i) the B-BBBEE status level certificate issued by an authorised body or person;
 - ii) a sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or
 - iii) any other requirement prescribed in terms of the B-BBEE Act.
- (j) **"QSE"** means a Qualifying Small EEnterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (k) **"rand value"** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties.

3. POINTS AWARDED FOR PRICE

3.1 THE 90/10 PREFERENCE POINT SYSTEMS

A maximum of 90 points is allocated for price on the following basis:

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME**INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIPP requirements. The Operator must inform Transnet of the breach as soon as it has occurred to allow Transnet to take all necessary remedial steps to mitigate the extent of the loss or compromise of personal information and the information of a third party and to restore the integrity of the affected personal information as quickly as is possible.

10. Transnet may, in writing, request the Operator to confirm and/or make available any personal information and the information of a third party in its possession in relation to Transnet and if such personal information has been accessed by third parties and the identity thereof in terms of the POPIA.
11. Transnet may further request that the Operator correct, delete, destroy, withdraw consent or object to the processing of any personal information and the information of a third party relating to the Transnet or a third party in the Operator's possession in terms of the provision of the POPIA and utilizing Form 2 of the POPIA Regulations.
12. In signing this addendum that is in terms of the POPIA, the Operator hereby agrees that it has adequate measures in place to provide protection of the personal information and the information of a third party given to it by Transnet in line with the 8 conditions of the POPIA and that it will provide to Transnet satisfactory evidence of these measures whenever called upon to do so by Transnet.

The Operator is required to provide confirmation that all measures in terms of the POPIA are in place when processing personal information and the information of a third party received from Transnet:

13. Further, the Operator acknowledges that it will be held liable by Transnet should it fail to process personal information in line with the requirements of the POPIA. The Operator will be subject to any civil or criminal action, administrative fines or other penalty or loss that may arise as a result of the processing of any personal information that Transnet submitted to it.
