

# Scope of Works

Shift -1 is compose of 2X Security guard during the day

Shift - 2 is compose of 2X Security Guards at night.

All Security guards must be of Grade C.

#### <u>Safety and security at Potgietersrus Site:</u>

Shift -1 is compose of 2X Security guard during the day

Shift - 2 is compose of 2X Security Guards at night.

All Security guards must be of grade C.
