Additionally, movement from areas with active FMD outbreaks in KwaZulu-Natal, Eastern Cape, Limpopo, and Mpumalanga is restricted, and no cloven-hoofed animals should be accepted from these regions.

2.14 Animal Health Requirements

Animal health certificate: Animals to be supplied must be of good health and should be accompanied by a Health Certificate issued by a veterinarian or Local State vet authorized by the Department of Agriculture, Forestry and Rural Development. The certificate must carry the names and addresses of the supplier and complete identification of the animals.

Important Health Information that can be included:

- Pulse rate: beats/minute
- Respiratory rate: cycles/minute
- Rectal temperature: °C
- Absence of any sign of infection: coughing, tearing
- Signs of good rumination

A) GOATS OR SHEEP

Shall originate from area in which for the last 12 months, there have been no clinical evidence or positive diagnoses of any of the following diseases:

- Sheep and Goat Pox: A viral disease causing pustular and scabby lesions, transmitted through direct contact or contaminated equipment.
 Vaccination and strict biosecurity measures are recommended.
- Bluetongue: A viral disease transmitted by biting insects, causing fever, oral lesions, and lameness.
 Vaccination is an effective control method.
- Rift Valley Fever (RVF): A zoonotic viral diseasecausing high mortality in young animals and abortions in adults, transmitted by mosquitoes or direct contact. Strict precautions are necessary.
- Botulism: Caused by toxins from Clostridium botulinum, leading to sudden death or paralysis. Proper feed management is critical to prevent outbreaks.
- Heartwater: A tick-borne disease affecting small ruminants, characterized by fever and neurological symptoms. Tick control measures are vital.
- Sheep Scab: A contagious ectoparasite infestation causing severe itching and wool loss. Dipping or treatment with acaricides is essential.
- Enterotoxaemia (Pulpy Kidney): Caused by Clostridium perfringens toxins, often associated with diet changes. Vaccination is key for prevention.
- Foot-and-Mouth Disease (FMD): A severe viral disease affecting cloven-hoofed animals. Testing and guarantine measures are necessary, especially

in areas with recent outbreaks.
Newcastle Disease: This is a notifiable disease in South Africa, and poultry and hatching eggs must come from flocks certified free of Newcastle disease, or be treated to inactivate the virus.
Salmonella: Eggs and poultry products should be free from Salmonella, and products are often subject to pasteurization or other treatments to destroy harmful microorganisms.
Other Notifiable Diseases: According to the Animal Diseases Act and import regulations, poultry must also be free from other prescribed or notifiable diseases, which may include (but are not limited to) avian tuberculosis, fowl typhoid, and Mycoplasma

- 1.1 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.2 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- **(b "price"** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income -generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
