### EVALUATION CRITERIA

The bid for Panel of Service Provider for Legal Services for a period of **36 (Thirty-six) months** to the Legislature will be evaluated on Functionality and Preferential points scoring system of **80/20**.

### 1. FUNCTIONALITY

For bidders to be evaluated further on preferential points scoring system of 80/20 a bidder must obtain at least the minimum qualifying score of 70% on Functionality, failure to obtain at least the minimum qualifying score, the bidder will be disqualified.
