4. CONFIRMATION OF SUBMISSION OF INFORMATION / DOCUMENTATION

There was an error on Page 56,57 and 58 on the confirmation of submission of information/ documentation whereby Proof of Sub – Contract Agreement (If experience was gained as a sub-contractor) was mistakenly added, please see attached amended page which excludes the subcontracting requirement. *(See attached annexure D)*
