**BID NO: NKO 28/2023 Re-Advert for Panel of Contractors for Re-Gravelling of Roads in Nkomazi West and East Villages for a period of three (3) year in Nkomazi Local Municipality**

The Nkomazi Municipality invites interested parties who are registered as CIDB Grading 3CE or Higher on the CIDB register of contractors to tender/ bid for the: **PANEL OF CONTRACTORS FOR RE-GRAVELLING OF ROADS IN NKOMAZI WEST and EAST VILLAGES AT NKOMAZI MUNICIPLAITY**. Tender documentation with complete details is available upon payment of a non-refundable amount of R 1 425.73 on each tender document or can be downloaded for free on e-Tender portal. Tender document(s) will be available as from **25/05/2023** and to be obtained at Nkomazi Local Municipality: Budget and Treasury (old Malalane Taxi Rank) Impala Street from the Cashiers Desk from 07h45 to 15h30 (Monday to Friday).

A non-compulsory tenderer briefing session will be held on **30/05/2023** at **10H00** at the Municipal Town Hall Malalane (Kobwa Hall) at Fish Eagle. It is advisable that Service Providers attend the briefing session though it is non-compulsory. For explanation and clarity service providers are encouraged to attend. Those who will not make it to the briefing will not be penalized.

Bidders are advised not to commit fraudulent activities or forge documents, all abusers of the SCM System, including faking of returnable documents, may be reported to SAPS or restricted from doing business with any Public Institution for a period not exceeding 10 years in line with section 28 and 29 of the prevention and combating of corrupt activities Act 12 of 2004.

A preferential system shall apply whereby this contract will be allocated to a bidder in accordance with the Preferential Procurement Framework Act, no 5 of 2000 and as defined in the bid document, read in conjunction with the Preferential Regulation, 2022 where 80 points are allocated in respect of price and 20 points in respect of targeted goals. Complete bid documentation must be deposited on/before **12H00** on **07/06/2023** in the Tender Box at the municipality's main entrance (Civic Centre (9, Park Street Malalane).

Tenders/Bids must be submitted in a sealed envelope or container on which the tender/bid number and the addressee is clearly marked. No bids transmitted by fax or email will be accepted. It must be noted that the municipality is not bound to accept the lowest or any other tender, Tender/Bid documentation which is incomplete or filled incorrectly, not filled in on the official bud documentation or which is received after the close of the bids, will be ignored. It must also be noted that enders submitted in the wrong tender box will not be considered.
