- 2.3 Tenderers may not contact any other NWDPWR employee besides contact person mentioned on Paragraph 2.1 above on any matter pertaining to the Tender from the time when Tender is advertised to the time the Tender is awarded. Any effort by a Tenderer to influence Tender evaluation, Tender comparisons, or Tender award decisions in any manner, may result in rejection of the Tender concerned.



- Seasonal preparations of lawn: apply fertilizer and lawn dressing
- Seasonal preparations of plant beds: planting new plants, apply fertilizer and compost
- Pruning of plants

3.2 LANDSCAPING SERVICES

Landscape architect shall advise on the plan, design and oversee the creation, regeneration and development of external land areas such as gardens and recreational areas, as well as residential and government facilities and buildings. Essentially, they combine artistic skills with knowledge of human activity and the natural environment – and can help to protect and conserve the environment. The work must include but not limited the following:

- creating plans, designs and drawings using computer-aided design programs
- surveying sites to obtain the exact extent of the area
- advising on matters to do with environmental conservation
- discussing requirements with clients
- writing reports and capacitating internal work teams (interns)
- producing contracts and estimated costs
- presenting proposals to clients for approval and agreeing time-scales
- overseeing projects as they progress
- seeking the opinions of locals, business and others who use the site
- liaising with other professionals such as architects, surveyors, town planners and civil Engineers.

The landscape contractor shall be responsible for familiarizing themselves with existing conditions and, if any concerns the Landscaper must in writing report to the Department and, with landscape architects or landscape designers retaining responsibility for the designs, overseeing the project and

monitoring progress. The landscape contractor must take precautions to protect all existing site roads, parking lots, curbs and utilities from damage. This applies not only to the area within the limits of work but also along any local access roads or roadways internal to the project.

The Landscaping Architect shall include the provision of all labour, material, plants, cutting of trees, removing of all alien plants and equipment required to complete all tasks associated with the landscaping and irrigation installation. The landscape contractor is responsible for the agronomic evaluation of soil characteristics. Evaluation must include chemical analysis by a qualified agricultural soils testing laboratory. Soils sample should be taken immediately following completion of rough grading activities and should be collected at a rate of one sample for each 10,000 square feet of impacted area, or a total of six, whichever is greater. At a minimum the chemical analysis of the soil should consider the following:

- A. Percentage of organic matter
- B. Salinity
- C. ph
- D. Lime content
- E. Mineral nutrients including concentrations of nitrogen, phosphorous, potassium, calcium, magnesium, iron, zinc, manganese, copper, sulfur and molybdenum.
- F. Potential hazards or impediments for plant growth including salinity, sodium chloride, boron, impaired soil structure or drainage.
- G. Sand fraction analysis as a percent passing through 1", 1-1/4" and no. 200 sieves.
- H. Percolation rate in inches per hour. The analysis should also include specific recommendations to UCF Landscape and Natural Resources for any amendments and backfill mixes for optimal plant growth to be made to the soils prior to planting.

The contractor should include the cost of this soil testing in their base bid as well as the basic backfill mixes specified herein but should include any anticipated cost for soil amendment. The contractor is to provide The Department with copies of all soil testing results prior to any work commencing. Submittal documentation must also contain a graphic site plan depicting locations and depth from which each sample was drawn. Al mechanical equipment and machinery used must be either petrol of diesel operating as connection to departmental existing power supply is prohibited.
