 - 3.2.3 Failure to adhere to the above i.e. 3.2.1 & 3.2.2 shall invalidate/ disqualify a bid.
 - 3.2.4 Memory stick (Flash Drive) must contain a soft copy of a proposal (Envelope 1 & 2), Failure to submit the memory stick shall disqualify a bid.
