**REQUEST FOR QUOTATIONS FOR  
TOUR GUIDE PARTNER PROGRAM**

## 1. Purpose

---

- 1.1. The Railway Safety Regulator (RSR) requires the services of a suitable service provider to assist with tour guide partner program.

## 2. Considerations/background

---

- 2.1. The RSR will host an International Rail Safety Council (IRSC) from 01-06 October 2023 at the Century City Conference Centre in Cape Town, South Africa. The IRSC is an international forum that brings together railway safety professionals from all over the world to exchange information, experiences, and lessons for improving railway safety. We are expecting close to 200 delegates from abroad who will be travelling with their partners or families even. It is, therefore, common practice that when the conference proceeds on the one end, we also have a Partner Program on the other, which is mostly tourism activities for a period of four days for the partners and kids.

## **6. Evaluation 80/20 Preference Point System**

The price quotations will be evaluated in accordance with the pre-scripts of the Preferential Procurement Policy Framework Act (PPPFA) and its regulations, in particular Preference Procurement Regulation 2022 which stipulate **80/20 preference point system for acquisition of goods or services with Rand value equal to or below R50 million (inclusive of all applicable tax).**
- 6.2. **A maximum of 80 points for price and 20 points for the specific goal specified on the request for quotation may be awarded to a Service Provider.**
