### **1. INTRODUCTION AND PURPOSE**

Quotation for the supply, delivery, and installation of irrigation systems at city of Tshwane Municipal Nursery, Nic van Vuuren place, Phillip Nel Park

### **2. BACKGROUND**

The installation of irrigation is required by Nursery Operations of the Environmental Management and Parks Division. An efficient irrigation system will promote more effective plant propagation leading to an improved output of ornamental plants for the beautification and greening of the city.

Whereas the facility is managed by the Environmental Management and Parks Division, all City departments benefit from the plant material produced from this nursery.

### **3. PROJECT SCOPE**

The following irrigation systems require installation at the new nursery site:

#### **3.1 Install a control panel and connect irrigation system at the crematorium gardens:**

This item will include items to be supplied by the bidder and items that the CoT has already procured and will supply.

The City of Tshwane will supply the following:

- Control box.
- Cables, white and red, from the solenoids to the control panel.
- Solenoids.

The bidder will be required to carry out the following work and supply the following items for installation:

### **3.6 Maintenance:**

- The bidder will be required to carry out maintenance on the control panel work done for 6 months after commissioning during the period of its guarantee.

### **3.7 Conditions**

- A one-year guarantee must be provided on the equipment supplied by the Bidder.
- If any of the irrigation systems that are installed leaks or sprayers do not work within 6 months of the installation date, then the bidder must undertake to do the repairs. Repairs required due to workmanship must be honored at the installers cost.

## **4 DELIVERABLES**

The deliverables for this project will be as per the project scope above. Within 10 working days of receiving the official Purchase Order, the Bidder must be on site and on busy with installation. All work on site, as per the specifications of the QAR must be completed within 30 working days after commencement of the project.

There will be a COMPULSORY briefing session to be held at the City of Tshwane Nursery, Nic van Vuuren place, Phillip Nel Park to allow the bidders to see the site and/or ask technical and site-specific questions.

  - Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
  - a. take all reasonable steps to prevent such abuse;
  - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
  - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

<sup>2</sup> Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

<sup>3</sup> Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
