Note:-

1. All system changes requiring downtime, including patching activities, must be scheduled during designated ICT Maintenance Slot periods.
2. All Emergency changes must adhere to the Emergency Change Advisory Board (eCAB) procedure.
3. Emergency Changes should only be performed as a result of critical system failures, address security vulnerabilities, compliance requirements or prevention of significant Business Impact
4. Adherence to the Emergency Change Procedure is mandatory
5. Consultation with Business Stakeholders where necessary is required for Emergency Changes
- 6. Changes Freeze Policy:**
The following periods are designated as change restriction windows during which no non-emergency changes may be implemented:
 - **Financial Processing Periods** (Monthly payroll processing, Month-end, Quarter-end and Year-end Financial close/reporting/reconciliations)
 - **Year-end Freeze Period** (15/12/2025 to 16/01/2026)
 - **Financial Year End Freeze Period** (16/03/26 to 23/04/2026)
