TERMS OF REFERENCE

RENEWAL OF THE STANDARD MAINTENANCE CONTRACT AND SPECIFIC REPAIR CONTRACT FOR THE DSI OUTDOOR BILLBOARD

1. BACKGROUND

The Department of Science and Innovation has a solar and wind powered billboard on their premises that needs to be maintained and repaired.

2. THE MAINTENANCE SPECIFICATION

- 2.1 The contract period will be for a period of 36 months.
- 2.2 A full maintenance test will be performed on the screen every three months from the commencement date of the Maintenance Agreement.
- 2.3 The supplier will supply all resources, supervision and management, and in all respects, render the services in accordance with acceptable professional standards and agreed service levels.
- 2.4 If the rendering of any part of the services does not meet the specifications and/or the service levels, the supplier will redo that part of the services to ensure that they conform to the specifications and/or service levels, at no additional cost to the DSI.
- 2.5 Specific maintenance services required on:
- a) 8 m x 6 m LED day/night, high-definition billboard screen
 - b) erected steel and concrete structure, including waterproofing
 - c) all paintwork
 - d) electrical fittings and connection
 - e) standard operating computer
 - f) small parts replacement
 - g) call-out services regarding screen problems and black spots **within 24 hours**
 - h) response times to problems with loading or posting images **within 24 hours**
 - i) quarterly cleaning of the solar panels every 90 days
 - j) quarterly thorough checking of the screen

- k) system upgrades, if required
- l) regular maintenance and diagnostics of the system
- m) remote and online maintenance

2.6 The supplier will submit monthly and quarterly reports and invoices to the DSI.

3. THE REPAIR CONTRACT:

3.1 The contract period for this agreement will be for services, as and when required, for a period of 36 months.

3.2 Additional items for the repair of the screen not covered by the standard maintenance contract, include items damaged by:

- a) Power surges
- b) Extreme weather conditions
- c) Lightning storms
- d) Any other damage caused by the wind and/or solar panel system
- e) Physical and/or wilful damage of the system

3.3 These items will be charged for separately and will not form part of the standard maintenance agreement. Where any items and/or components are found to be in need of replacement, a separate quotation and invoice will be issued for these items on the order number issued for repairs to the billboard. (This includes both Hardware and Software upgrades).

4. ADDITIONAL INFORMATION:

4.1 The system shall be maintained, serviced and repaired by the Contractor to a functional state, however the Department will be required to supply and maintain the required electrical supply, access and security for the installation.

- 4.2 If the Contractor becomes aware of a delay, event or activity beyond his control, the Contractor will need to report the delay to the Department. The Department will consider the Contractor's claim and will report back to the Contractor.

5. MANDATORY AND ADMINISTRATIVE REQUIREMENTS:

- 5.1 The following documents are compulsory and should be submitted together with the proposal; *failure to submit the following will result in disqualification:*

- a. Proof of registration to the Centralized Supplier Database held by National Treasury.
- b. Valid tax clearance certificate.
- c. Completed and signed SBD 1, SBD 4, and SBD 6.1.
- d. Certified or original B-BBEE certificate to claim Specific Goal Points, failure to submit will not invalid your proposal but will score 0 points for SG points.
- e. Submit a proposal addressing the tasks specified in this document.
- f. Detailed company profile, which clearly spells out the relevant experience, knowledge and accreditation of the company as well as directorship.

6. PRICE AND SPECIFIC GOALS EVALUATION

Price inclusive of VAT will be evaluated as indicated below.

- a) In terms of regulation 4 of the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000), responsive bids will be adjudicated by the DSI on the 80/20 preference point system in terms of which points are awarded to service providers on the basis of:
 - The bid price (maximum 80 points)
 - Specific Goals mentioned below in Table1 (maximum 20 points)

Service providers can only claim specific goal credentials, by providing a detailed company ownership certificate.

- b) The following formula will be used to calculate the points for price in respect of service providers with a rand value equal to or above R30 000.00 up to R50 000 000.00:

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for price of tender under consideration;

P_t = Price of tender under consideration;

P_{\min} = Price of lowest acceptable tender.

- c) A maximum of 20 points will be awarded to a tenderer for the specific goal (at least 51% ownership) specified for the tender, as per the table below:

- i. A bidder must submit proof of its Specific goals' status.
- ii. Bidder to claim points if their specific goal(s) ownership is at least 51 %.
- iii. A bidder failing to submit proof of Specific goals' status or failing to meet the Specific goals, may not be disqualified, but (a) may only score points out of 80 for price; and (b) score 0 points out of 20 for Specific goals.
- iv. The points scored by a bidder for Specific goals in accordance with the preceding paragraphs 6.4(c) must be added to the points scored for price under paragraph 6.4(b).
- v. The points scored must be rounded off to the nearest two decimal places.
- vi. If the price offered by a tenderer scoring the highest points is not market-related, the Department may not award the bid to that tenderer.
 - The Department may negotiate a market-related price with the tenderer scoring the highest points or cancel the tender.
 - If the tenderer does not agree to a market-related price, the Department may negotiate a market-related price with the tenderer scoring the second highest points or cancel the tender.
 - If the tenderer scoring the second highest points does not agree to a market-related price, the Department may negotiate a market-related price with the tenderer scoring the third highest points or cancel the tender.
 - If a market-related price is not agreed in all the aforementioned respects, the Department must cancel the tender.
- vii. In the event that two or more tenderers score an equal total number of points, the contract must be awarded to the tenderer that scored the highest points for specific goals. (2) If two or more tenderers score equal

total points in all respects, the award must be decided by the drawing of lots.

- viii. A contract may, on reasonable and justifiable grounds, be awarded to a bid that did not score the highest number of points.

NB: All costs that the service provider may incur due to the preparation of the project for the DSI shall be the sole responsibility of the service provider.

7. SUBMISSION OF PROPOSALS

7.1 The closing date for submission of quotations is 25 March 2024.

7.2 The proposals should be sent to the relevant SCM Practitioner who sourced quotations using the details provided through the email used to source.

1.2 To be completed by the organ of state

- (a) The applicable preference point system for this tender is the 80/20 preference point system.
- (b) The 80/20 preference point system will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10

preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

In order to give effect to this right, the DSI is under a duty to provide you with a number of details pertaining to the use of and subsequent processing of your Personal Information, before such information is used or processed. In accordance with this requirement, the DSI sets out under the attached document known as the "DSI section 18 informed consent document for Security Access" the reasons why your Personal Information is required and how the Department of Science and Innovation will use and handle this information.
