TDR287/2021/2022: REPLACEMENT OF SEWER PIPELINES BETWEEN MOSSEL BAY AND HARTENBOS

Tenders are hereby invited from Contractors with a CIDB grading of 5 CE or higher for the Replacement of Sewer Pipelines Between Mossel Bay and Hartenbos. The successful contractor is to sub-contract all minor engineering work on the contract to a local EME, QSE or Level 1 B-BBEE registered contractor with a CIDB grading of 1CE or higher. Contractor to use local labourers according to the EPWP method and regulations. This is a multi-year project with completion on or before 30 June 2023.

A set of fully completed tender documents must be submitted of the original documents and remain valid for 90 days after the closing date of the tender. A set of tender documents can be obtained on the Mossel Bay Municipality's website at www.mosselbay.gov.za/procurement/tenders-available, free of charge, which must be printed, submitted and complete by the bidder **OR** Alternatively, a set of tender documents can be obtained at a non-refundable cost of R766.61 including VAT at the **compulsory site and information meeting**.

A **compulsory site and information meeting** will take place at 11h00 on **Thursday, 17 February 2022 at the Mossel Bay Town Hall, 101 Marsh Street, Mossel Bay**. Wearing of a mask and social distancing to be followed during the information session.

PLEASE ENSURE THAT ALL PARTNERS OF A JOINT VENTURE ARE CIDB REGISTERED AND ATTEND THIS COMPULSORY MEETING. FAILURE TO ATTEND THE MEETING WILL RESULT IN THE BID BEING NON-RESPONSIVE.

Please note: The Municipality prefer that Senior Company Staff members or Contract Managers attend the compulsory site meeting as the Scope of Works, the Design and the Tender Specifications will be discussed in detail along with the Execution phase expectations and possible amendments. It remains the Bidder's responsibility to familiarise themselves with and fully understand the tender specifications to be able to submit a responsive tender.

Prospective bidders that arrive 15 minutes or more after the advertised time the meeting started will not be allowed to attend the meeting or to sign the attendance register. If a prospective bidder is delayed, he/she must inform the contact person before the meeting commence and will only be allowed to attend the meeting if the chairperson of the meeting, as well as all the other bidders attending the meeting, give permission to do so.

Fully completed tender documents must be placed in a sealed envelope and placed in the **tender box at the Entrance of the Mossel Bay Town Hall, 101 Marsh Street, Mossel Bay by not later than 12:00 on Friday, 11 March 2022** or be mailed to reach the **Tender Box, Mossel Bay Municipality, PO Box 25, Mossel Bay, 6500** before the specified closing date and time. The envelopes must be endorsed clearly with the number, title and closing date of the tender as above.

The tender is subject to functionality criteria.

Bids will be pre-evaluated on the following functionality criteria and bids that score less than 80 out of 100 points will be considered as non-responsive:

Functionality criteria and weight:

1. Company (or JV) Experience carrying a weight of 30 points.
2. References related to experience carrying a weight of 15 points.

3. Site Staff and Personnel allocated for this tender carrying a weight of 25 points.
4. Plant, Equipment, Tools & Machinery allocated/reserved for this Tender carrying a weight of 30 points.

This tender is subject to Regulation 8 "Local Production and Content" of the Preferential Procurement Policy Framework Act, 2017: Preferential Procurement Regulations, 2017 submitting of MBD 6.2 is compulsory. The following local content thresholds apply:

- Steel Power Pylons, Monopole Pylons, Steel Substation Structures, Powerline Hardware, Street Light Steel Poles, Steel Lattice Towers have been designated with a minimum threshold of 100%;
 - Pumps, Medium Voltage (MV) Motors and Associated Accessories has been designated with a minimum threshold, 70%;
 - Steel products and Components for Construction has been designated with a minimum threshold of 100% for local content;
 - Valves Products and Actuators has been designated with a minimum threshold of 70%;
 - Electrical and Telecom Cable Products have been designated with a minimum threshold of 90% for local content;
 - Residential Electricity and Water Meters have been designated with a minimum threshold of 50%;
 - Transformers, Shunt Reactors and Associated Equipment has been designated with a minimum threshold of 70 - 100% for local content;
 - Plastic Pipes have been designated with a minimum threshold of 100%;
 - Cement Sector have been designated with a minimum threshold of 100%;
1. The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on Friday, 04 February 2022.
 2. Only the South African Bureau of Standards (SANS) approved technical specification number SATS 1286:2011 must be used to calculate local content.

Responsive bids will then be evaluated on the 80/20 or 90/10 Preference Points system as prescribed by the Preferential Procurement Regulations, 2017.

Receipts will be issued on request only for tenders handed in during office hours from Mondays to Fridays. Receipts will not be issued for tenders placed in the tender box after hours or which are received by mail.

The tender box will be emptied just after 12:00 on the closing date as above, hereafter all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

It is expected of all Bidders who are not yet registered on the Central Supplier Database to register without delay on the prescribed form. The Municipality reserves the right not to award tenders to Bidders who are not registered on the Database.
