- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

REQUEST FOR QUOTATION FOR:

This contract is for a maximum of 80hours active micro-preparation per month for a period of 12 months from January-December 2024.

Specifications for micro-preparator services

- Karoo vertebrate fossils are a valuable heritage resource protected by the Heritage Resources
 Act, which stipulates that all south African fossils must be protected from theft, illegal export,
 wanton destruction and un-professional handing.
- Iziko researchers have collected numerous 250-million-year-old micro-vertebrate fossils from the Karoo. These need to be mechanically prepared by delicate manipulation of a compressordriven air scribe under high magnification to remove the enclosing rock thus revealing the fossil bone surface. Precise hand to eye-co-ordination and patience are skills necessary for this task, and most importantly, a proven ability to prepare micro-vertebrate fossils without damaging them.
- The contracted incumbent will also need knowledge and experience of:
- Personal health and safety requirements for a fossil preparation laboratory,
- Mixing and application of palaeontological consolidants,
- Supply and maintenance of mechanical pneumatic micro-scribe equipment microscopes and compressor.
- Providing a competent digital photographic record of preparation progress.
- The service provider thus needs not only to prove competence but to also have a well-equipped fossil preparation facility which must be inspected by the Iziko Collections Manager before the contract is awarded.
