# 1. Background to the National Museum

## 2. Purpose and Background

#### Background

The Florisbad perimeter fence is constructed of brickwork, purposely made palisade fence and barbed wire, where the property is easily accessible the fence is constructed of palisade fence busing raw bolted to brickwork columns.

On the 7<sup>th</sup> March 2023 during a thunderstorm two (02) trees were stricken by lightning, whereby one of the trees was near the perimeter fence. The tree fell on top of the palisade fence breaking the column constructed of brickwork. This has resulted in the security of the property being exposed, currently there is no security systems in place and the site manager is not at the property on Wednesdays and on the weekends.


Florisbad houses museum properties which includes collections, vehicles and trailers. The road is used by both pedestrians and vehicles passing the property and people visiting the rehab centre next to the research station. The damage was reported by the HOD and Site Manager to SCM.


### The Scope of Work:


- Replace purposely made damaged palisade fence slats 2400mm high made of 30 x 30 x 3mm angle section pickets with top end split and sharpened, welded to top and bottom rails including painting on both sides. Four times bolted on each side to brickwork.
- Construct a brick column in faced English bond including a concrete capping at the top, including one layer in Header course, brick force/ iron hopes included in the brickwork.

All works should comply with emergency works and completed within 24Hours.

# 4 Compulsory requirements

A bidder will score more points on technical assessment with more than the required number of years of experience as indicated above. Contactable written reference letter(s) must be attached to support the number of years' claimed by the bidder.
- **4.1.2** a valid copy or copies of relevant professional registration with a professional body or professional bodies must be attached.
- 4.1.3 completed, signed and witnessed SBD forms 4, 8 and 9 must be attached.
- **4.1.4** a copy of a detailed CV(s) and qualification(s) of the technician or expert to be used on this project must also accompany the quote.
- 4.1.5 the bidder must be tax compliant and a tax pin issued by SARS must be attached.
- 4.1.6 the must be registered on CSD and CSD supplier report must be attached.
- **4.1.7** the bidder must be an active company registered in the Republic of South Africa and a copy of CIPC registration documents must be attached.
- 4.1.8 Compulsory registration with CIBD 1 GB PE or higher.

#### **Matters for noting**

 Non-compliance to the above compulsory requirements will lead to a disqualification of the bidder, except for non-tax compliant with tax matter which is subject to grace period of at least 7 days that will be provided to a preferred service provider should that service provider is not compliant following bid evaluation.

- 2. Failure by this preferred service provider to rectify its tax matters to a compliant status within the grace period provided will lead to an automatic disqualification.
- 3. Validity period for bids or formal written quotations submitted shall be valid for a minimum period of thirty (30) days. The formal written price quotations received from the service provider/supplier will be regarded as valid for 30 days despite expiry date less than 30 days indicated on a quote.
