1 EMPLOYER'S OBJECTIVES

This invitation is for the appointment of a service provider for the testing and equipping of a borehole at Portion 35,36 and 59 of Doornkloof no. 393 Magaliesburg in Mogale City local municipality within the West Rand District Municipality.

2.1 SCOPE OF WORK

The Department of Land Reform and Rural Development: Provincial Shared Services Centre Gauteng, wishes to appoint a suitably qualified Service Provider for testing and equipping an existing borehole at Portion 35 of Doornkloof no.393 Magaliesburg in Mogale City Local Municipality within the West Rand District Municipality.

2.2 INTRODUCTION

2.2.1 The main purpose of this document is to outline the detailed design specifications and Bills of quantities (BOQ) required for the testing and equipping of a borehole for the farm. The farm occupies about 31,9 hectares of with households and other farm buildings. The borehole has been recently drilled by DALRRD Infrastructure Support (IS). The farmer is currently farming and livestock and vegetables with the intention of expanding into other commodities. The borehole is therefore for human consumption, crop irrigation and livestock drinking.

2.3 SAFETY PRECAUTIONS FOR SITE WORKERS

- 2.3.1 It is the responsibility of the contractor that the team on site is aware of all health and safety procedures and policies. The construction site must have an updated set of policies and procedures regarding health and safety. Contractors and personnel without the required Personnel Protective Equipment (PPE) must not be allowed on site. Specifications mentioned in the SABS 1200 series must be complied with. The following regulations must be strictly adhered to in order to ensure worker safety:
 - Minimum wearing apparel All site workers involved in the Drilling and Equipping of the borehole must wear as a minimum protection the following: full length pants and short sleeve shirt or t-shirt. Cutoffs, tank tops, or modified shirts, etc., are not acceptable wearing apparel.
 - Foot protection All site workers must wear safety boots to protect their feet and ankles.
 - Eye protection Workers must wear protective goggles or protective spectacles.
 - Skin protection Workers must wear protective gloves.
 - Ear protection Heavy duty ear plugs.
 - A basic medical kit must be available on site.

2.4 BOREHOLE SPECIFICATIONS

APPLICABLE STANDARDS AND PARTICULAR SPECIFICATIONS

All construction notes, instructions, references, requirements, and preparations of works are detailed in the Quantity Schedule provided below. The detailed required works are as detailed in the following subsections of this chapter. It is essential that quality products be used on the Borehole, thus all material must comply with specifications set by the South African National Standards institute. In the event of any discrepancy between the "Model Preambles for Trades" and the SABS 1200 Standardised Specifications or Project Specifications, the SABS 1200 Standardised and Project Specifications shall take precedence.

2.5. WORKS SPECIFICATION

2.5.1. Temporary Works

Contractor's offices, storage sheds, latrines, barricading of Works shall be located in an approved position and subject to the approval of all authorities concerned. Safety & Security of the contractor's temporary works shall be to his own discretion. The safety of the Employer and Employer's staff will also be the responsibility of the Main Contractor. All reasonable steps should be taken to ensure the safety of all persons on site. The Contractor shall make his own

arrangements with the necessary authorities for the supply of water, electricity and telephones.

2.5.2. Site Activities

- Establishment of site
- Testing of existing boreholes, Providing a Report
- Installation of a submersible pump, including all cabling and electrical Connections.
- Excavation for HDPE pipe and Electrical, 400mm deep, 500 meters from the Borehole to water storage/tank.
- Supply and Lay 50 mm class 10 HDPE pipe, 500 metres from the borehole to the water tank.
- Supply and Install 10000 litres water tank and tank stand
- Backfill for pipes and provide concrete pipe marking.
- Supply and Install stand pipe.
- Provision of a 3-phase 8 KVA generator and all the necessary electrical connections.
- Provision of stand pipe closer to house.

2.5.3. Detailed Project Specification

a) Earthworks

Trenches are necessary so that the pipes do not run on the ground level hence, interrupting agricultural operations happening in the farm.

- Allow for clearing of all grass, weeds, shrubs, trees with trunks and debris, including grubbing up all roots, removing as required along the pipeline position, and cut away all vegetation and debris.
- For pipe trenches, clearing should be at a width of 1 m where the trenches will be dug.
- Pipe line Maximum 500 m (I) x 0,4 m (w) x 0,5 m (d).
- All excavated soil to be used for backfilling after pipes have been installed.
- Excavate 400mm deep for the manhole around the borehole.
- If a trench cannot be dug due to rocks, the pipe must be laid above the ground and covered with soil.

b) Concrete, Formwork and Reinforcement

- 25 Mpa/19mm Concrete stand footings to be cast for water stand columns with mesh ref 395 for each footing and testing of concrete cubes as per regulations
 - Supply and install 3m high steel tank stand, refer to the attached drawing for details
- Pre-cast concrete manhole must be Ø 1000 mm x1000 mm high lockable and complete with accessories. Manhole must be 500mm deep into the ground.

c) Water storage

 Supply, install and commission 10 000L water tank (Auto fill) with float valve. Including water supply connections. All on tank stand anchored to 800mm x 800mm x 700mm deep 25 Mpa reinforced concrete. footings. Reinforced with Y12 bars @ 250mm c/c along the length and width of the

d) Borehole, Pipe Works and Pipe Fittings

e) Pump selection:

- Select a suitable submersible pump.
- A licensed electrician to perform the wiring, all wiring must be done in accordance with applicable national and local electrical codes and include a CoC.
- Mount the control box in an area protected from rain, snow, direct sunlight or other temperatures as this may cause tripping of the overload protector.
- 8.5kva, 3phase generator

f) Pipe works and fittings:

- Reducer to fit 50 mm diameter pipe to a 40 mm diameter submersible pump outlet
- Elbow compression fittings (90 deg) to connect 40 mm diameter pipe coming out of the borehole to the reservoir.
- Supply and install HDPE pipes as per schematic diagrams and BOQ provided.

g) Testing and commissioning of boreholes.

- A complete operational test will be performed on the borehole pump and all associated pipes and fittings.
- The hydro-geological consultant together with client representatives will be required to be present on site to verify proper functioning of the boreholes and to commission each project.

4 EVALUATION CRITERIA

Tenders will be evaluated in terms of the evaluation criteria stipulated below:

- (a) Evaluation for mandatory criteria
- (b) Evaluation in terms of 80/20 preference point system as prescribed in the Preferential Procurement Regulations 2022.

(a) EVALUATION FOR MANDATORY CRITERIA

- i) Only those Tenderers who are registered with the CIDB in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a 1CE or Higher Class of construction work, are eligible to submit tenders.
- ii) Attendance of the Compulsory Tender Clarification meeting as stipulated above.
- iii) Correction in terms of price must not be made by means of a correction fluid such as Tippex or similar product. If correction fluid has been used on any specific item price, such item will not be considered. No correction fluid must be used in a Bill of Quantities where prices are calculated to arrive at a total amount. If correction fluid has been used the task order as a whole will not be considered.
- iv) In the event of mistakes having been made on the Form of Offer it must be crossed out in ink and be accompanied by an initial at each and every price alteration.
- v) Form of offer must be completed and signed by duly authorized person.
- vi) Attach a Compensation for Occupational Injuries and Diseases Act (COIDA) for Building and Construction, with Department of Labour or with a licensed compensation insurer. A Tenderer who presently do not have any labour in their employ must submit a Tender Letter obtainable from the Department of Labour.

NOTE: Additional Required Documents (Not for elimination/disqualification) a) Valid Tax Clearance Certificate and/or SARS issued pin code.

TAX COMPLIANCE STATUS

Bids received from bidders with a non- compliant tax status may be disqualified with failure to update the Tax Status within 7 days.

(b) EVALUATION IN TERMS OF 80/20 PREFERENCE POINT SYSTEM AS PRESCRIBED IN THE PREFERENTIAL PROCUREMENT REGULATIONS 2022.

Guidance Document for the Calculation of Local Content

1. DEFINITIONS

Unless explicitly provided in this guideline, the definitions given in SATS 1286:2011 apply.

2. GENERAL

2.1. Introduction

This guideline provides tenderers with a detailed description of how to calculate local content of products (goods, services and works) by components/material/services and enables them to keep an updated record for verification requirements as per the SATS 1286:2011

Annexure A and B.

The guideline consists of two parts, namely:
□ a written guideline; and□ three declarations that must be completed:
□ Declaration C: "Local Content Declaration – Summary Schedule" (see Annexure C);
□ Declaration D: "Imported Content Declaration – Supporting Schedule to Annex C" (see Annexure D); and
□ Declaration E: "Local Content Declaration – Supporting Schedule to Annex C" (see Annexure E).

The guidelines and declarations should be used by tenderers when preparing a tender. A tenderer must complete Declarations D and E, and consolidate the information on Declaration C.

Annexure C must be submitted with the tender by the closing date and time as determined by the Tender Authority. The Tender Authority reserves the right to request that Declarations D and E also be submitted. If the tender is successful, the tenderer must continuously update Declarations C, D and E with actual values for the duration of the contract.

NOTE:

Annexure A is a note to the purchaser in SATS 1286:2011; and Annexure B is the Local Content Declaration IN SATS 1286:2011.

2.2. What is local content?

According to SATS 1286:2011, the local content of a product is the tender price less the value of imported content, expressed as a percentage. It is, therefore, necessary to first compute the imported value of a product to determine the local content of a product.

2.3. Categories: Imported and Local Content

by components/material/services is separated into two categories, namely:
□ products imported directly by the tenderer; and
□ products imported by a third party and supplied to the tenderer.
2.3.1. Imported Content

The tenderer must differentiate between imported content and local content. Imported content of a product

Identify the imported content, if any, by value for products by component/material/services. In the case of components/materials/services sourced from a South African manufacturer, agent, supplier or subcontractor (i.e. third party), obtain that information and Declaration D from the third party.

Calculate the imported content of components/materials/services to be used in the manufacture of the total quantity of the products for which the tender is to be submitted.

As stated in clause 3.2.4 of SATS 1286:2011: "If information on the origin of components, parts or materials is not available, it will be deemed to be imported content." 2.3.1.1. Imported directly by the tenderer:

When the tenderer imports products directly, the onus is on the tenderer to provide evidence of any components/materials/services that were procured from a non-domestic source. The evidence should be verifiable and pertain to the tender as a whole. Typical evidence will include commercial invoices, bills of entry, etc.

When the tenderer procures imported services such as project management, design, testing, marketing, etc and makes royalty and lease payments, such payments relating to the tender must be included when calculating imported content.

2.3.1.2. Imported by a third party and supplied to the tenderer: When the tenderer supplies components/material/services that are imported by any third party (for example, a domestic manufacturer, agent, supplier or subcontractor in the supply chain), the onus is on the tenderer to obtain verifiable evidence from the third party.

The tenderer must obtain Declaration D from all third parties for the related tender. The third party must be requested by the tenderer to continuously update Declaration D. Typical evidence of imported content will include commercial invoices, bills of entry etc.

When a third party procures imported services such as project management, design, testing, marketing etc. and makes royalty and lease payments, such payments relating to the tender must be included when calculating imported content.

2.3.1.3. Exempt Imported Content:

Exemptions, if any, are granted by the Department of Trade and Industry (the DTI). Evidence of the exemptions must be provided and included in

Annexure D.

2.3.2. Local Content

Identify and calculate the local content, by value for products by components/materials/services to be used in the manufacture of the total quantity of the products.

ANNEXURE C

3.1. Guidelines for completing Annexure C: Local Content Declaration – Summary Schedule

Note: The paragraph numbers correspond to the numbers in Annexure C.

C1. Tender Number

Supply the tender number that is specified on the specific tender documentation.

C2. Tender description

Supply the tender description that is specified on the specific tender documentation.

C3. Designated products

Supply the details of the products that are designated in terms of this tender (i.e. buses).

C4. Tender Authority

Supply the name of the tender authority.

C5. Tendering Entity name

Provide the tendering entity name (for example, Unibody Bus Builders (Pty) Ltd).

C6. Tender Exchange Rate

Provide the exchange rate used for this tender, as per the Standard Bidding Document (SBD) and Municipal Bidding Document (MBD) 6.2.

C7. Specified local content %

Provide the specified minimum local content requirement for the tender (i.e. 80%), as per the Standard Bidding Document (SBD) and Municipal

C13. Imported value

Provide the ZAR value of the items' imported content.

C14. Local value

Provide the local value of the item by deducting the Imported value (C13) from the net tender value (C12).

C15. Local content percentage (per item)

Provide the local content percentage of the item(s) by dividing the local value (C14) by the net tender value (C12) as per the local content formula in SATS 1286.

Tender Summary

C16. Tender quantity

Provide the tender quantity for each item number as per the tender specification.

C17. Total tender value

Provide the total tender value by multiplying the tender quantity (C16) by the tender price (C10).

C18. Total exempted imported content

Provide the total exempted imported content by multiplying the tender quantity (C16) by the exempted imported content (C11). These values must correspond with the values of column D18 on Annexure D.

C19. Total imported content

Provide the total imported content of each item by multiplying the tender quantity (C16) by the imported value (C13).

C20. Total tender value

Total tender value is the sum of the values in column C17.

C21. Total exempted imported content

Total exempted imported content is the sum of the values in column

C18. This value must correspond with the value of D19 on Annexure D.

C22. Total tender value net of exempted imported content

The total tender value net of exempt imported content is the total tender value (C20) less the total exempted imported content (C21).

C23. Total imported content

Total imported content is the sum of the values in column C19. This value must correspond with the value of D53 on Annexure D.

Total local content is the total tender value net of exempted imported content (C22) less the total imported content (C23). This value must correspond with the value of E13 on Annexure E.




