# Specifications

- Old grease must be removed from the shafts and bearings and the right standard new grease which must function for up to one year must be applied.
- The Carousel must also be checked to see that all parts are fine and in working order.
- The African Carousel forms pari of the Oliewenhuis Permanent Collection and service providers will be held accountable for any damage to the African Carousel, including the sculptures.
- Local engineers are the preferable suppliers

- The service provider to do the work must have completed Engineering Studies

- **4.1.2** a valid copy or copies of relevant professional registration with a professional body or professional bodies must be attached.
- 4.1.3 The attached SBD form 4 must be completed, signed and witnessed and attached.
- **4.1.4** a copy of a detailed CV(s) and qualification(s) of the technician or expert to be used on this project must also accompany the quote.
- **4.1.5** the bidder must be tax compliant and a tax pin issued by SARS must be attached.
- **4.1.6** a valid copy of BBBEE certificate or completed and signed BBBEE declaration is not compulsory but may be provided to score points on bid evaluation.
- **4.1.7** the must be registered on CSD and CSD supplier report must be attached.
- **4.1.8** the bidder must be an active company registered in the Republic of South Africa and a copy of CIPC registration documents must be attached.
