Bids are hereby invited from Original Equipment Manufacturers (OEM) franchises and other capable services providers registered with RMI or equivalent for maintenance of HEAVY COMMERCIAL VEHICLES (HDVs) and roadside assistance (breakdown) for the City of Mbombela for a period of 36 months as and when required.

The project entails maintenance, service and roadside assistance of all HDVs and all other vehicles above three (3) tons. Bidders are advised not to commit fraudulent activities or forge documents. All abusers of the SCM system, including forging or faking of returnable documents, may be reported to SAPS and restricted from doing business with any Public Institutions for a period NOT exceeding 10 years which is in line with section 28 and 29 of the Prevention and Combating of Corrupt Activities Act 12 of 2004.

## **SPECIAL CONDITIONS OF THE BID**

### **1. SUBMISSION OF TENDERS**

The tender is to be made out on the tender form attached hereto, which must not be detached from this document, and the completed document, fully priced, extended and totalled, completed in all respects, signed and is to be sealed in an envelope which is to be enclosed and delivered in accordance with the instructions contained on the Invitation to Tender.

Proof of posting of a tender will not be accepted as proof of delivery to the appropriate place for the receipt of tender.

Tenders will be opened in public immediately after the advertised closing date.

The information to be submitted by prospective bidders will only be used for tender purposes taking into consideration the Protection of Personal Information Act (POPI Act).

### **2. TENDER DEPOSIT**

### **3. ADJUDICATION OF TENDER**

The City of Mbombela will not be bound to accept the lowest or any tender and also reserves the right to cancel the tender when deemed necessary.

The tender will be adjudicated by City of Mbombela in terms of the Preferential Procurement Policy Framework Act, no. 5 of 2000 and as defined in the conditions of bid in the bid document, read in conjunction with the preferential procurement regulations, 2022, where 80 points will be allocated in respect of price and 20 points in respect of targeted goals

Prospective service providers may not make any alterations or additions to the Bid document, except to comply with instructions issued by the employer. The tender document must be furnished with non-erasable black ink and all corrections made by the service provider should be dated and signed by the authorised signatory. Erasures and the use of masking fluid, tippex, pencil or erasable ink are prohibited and failure to adhere to this condition will render your submission non responsive.

Certified copy of B-BBEE Certificate OR Original Sworn Affidavit for B-BBEE / certified copy of a Sworn Affidavit for B-BBEE. Failure to adhere will lead in non-claiming on preferential points.

A bid that does not comply with the mandatory requirements stated in the bid document will be regarded as non-responsive and will therefore be rejected. If a bid has not been properly signed by a person authorised to do so, in accordance with the "Authority for Signatory" requirements, it will be rejected. This condition does not apply to companies with a single director/member or to sole proprietorships, provided that the director, member, or sole proprietor is the authorised signatory for the bid.

A bid will be rejected if any municipal rates and taxes or municipal service charges owed by the bidder or any of its directors to the municipality, or to any other municipality or municipal entity, are in arrears for more than three months. Similarly, none submission of proof of valid and up-to-date rates and taxes statement will render the submission non-responsive.

Bids will be rejected if the bidders or any of the directors are listed on the Register of Bid Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector. Bids will be rejected if the bidder has abused the CoM's Supply Chain Management System or SCM Processes of any state institutions.

MBD 1 will be regarded as a FORM OF OFFER and if the form is not completed in full and signed by the authorised signatory, the submission will be regarded as non-responsive.

#### **4. COMPLETION OF TENDER DOCUMENTS**

Tenders shall only be considered if this tender document is fully and correctly completed, with all required information inserted in black ink and duly signed.

##### **4.1. Compulsory documentation to be submitted**

The following compulsory documents must be attached to ensure that the bid is considered:

- A valid Tax Compliance Status (TCS) Pin.
- Proof of company registration.
- Certified copies of the Business Director(s)' identity documents.
- A full Central Supplier Database (CSD) registration report not older than 30 days from the closing date. Summary reports will not be accepted.
- Certified proof of accreditation as an OEM / Franchise / RMI or equivalent.

##### **4.2. Municipal rates and taxes requirements**

- The bidder must submit a valid and current municipal rates and taxes statement from the relevant local authority, or proof of residence from a recognised tribal authority (where applicable), or a valid lease agreement accompanied by the lessor's up-to-date municipal rates and taxes statement for the business premises.
- Bidders must ensure that the physical address details reflected on the Central Supplier Database (CSD) correspond with those on the company registration certificate.
- The Municipality reserves the right to verify municipal rates and taxes information linked to both CSD and company registration details.
- It remains the responsibility of bidders to ensure that municipal accounts are fully compliant and not in arrears.

##### **4.3. Director(s) municipal compliance**

- The bidder must submit valid and current municipal rates and taxes statements for all director(s), including consortium or joint venture partners or proof of residence from a recognised tribal authority (where applicable), or lease agreements accompanied by up-to-date municipal rates and taxes statements.
- The Municipality may verify, using directors' identity numbers, whether any municipal rates and taxes are outstanding.
- It is the responsibility of bidders to ensure that all directors are fully compliant with municipal rates and taxes obligations.

#### 4.4. General note

- For all key personnel whose CV is submitted, certified copies of qualifications and certified copies of identity documents must be submitted with the bid (if applicable).
- Certified copies must not be older than three (3) months to be considered valid.
- Copies of certified copies will not be accepted; only certified copies of original documents will be recognised.
- Failure to comply with the above requirements will result in immediate disqualification.

### **5. COMPULSORY BRIEFING SESSION**

### **6. WITHDRAWAL OF TENDER**

In the event of the awarded bidder fails to execute the services in terms of this tender, the Municipality shall be entitled to cancel the contract summarily, in which event the Bidder shall be liable for any additional expense incurred by reason of the Municipality having to call for fresh tenders or having to accept any less favourable tender. The Municipality will without prejudice consider listing the service provider in the National Treasury restricted bidders register.

### **7. NOTICE OF BIDDERS**

Should any additions or alterations to the document as issued to Bidders be deemed necessary prior to the date for submission of tenders, these will be issued to Bidders in the form of Notices to Bidders and will form part of the tender document.

The Notices to Bidders shall be completed where applicable by Bidders, signed, dated and returned with the tender documents.

### **8. PERIOD OF VALIDITY OF TENDERS**

The bids submitted by the service providers will be valid for a period of hundred and twenty (120) days and the validity period may be extended for further period of thirty (30) days. The following procedures and processes shall be followed in extension of the validity date.

- (a) Requests for the extension of validity dates must be extended to all service providers.
- (b) Proof should be provided that all services providers shown interests in the bid have been contacted.
- (c) Service providers have consented on the extension.
- (d) Bidders that have not responded or rejected the request for the extension of the validity will be eliminated from the processes.
- (e) That any prices changes resulting from the extension of the validity date shall be taken into considerations when evaluating bids.
- (f) The request for the extension of the validity date extended to interested service providers shall have a (seven) 7 working dates respond period.
- (g) Every case will be treated on its own merit, however, non-response from the services providers does not render the entire project null and void.

### **9. CESSION OF ASSIGNMENT**

The appointed bidders shall not cede or assign a contract for more than R30 000.00 including VAT to third parties / specialists without having obtained written permission from the Council.

Should a service be performed by an external service provider (specialist) other than the contracted service provider, an invoice from specialist shall accompany the invoice from the contracted service provider provided it is above R30 000.00 including VAT. The conditions stated above shall not be applicable to service providers classified as Original Equipment Manufacturer (OEM) / certified dealership / franchise.

## **10. BID PRICE**

All prices must include VAT where applicable.

All prices must be stated in South African currency (ZAR) and will be regarded firm.

The total bid price in the bill of quantities is meant for evaluation purposes only. This contract shall be rates based due to its nature. In light of this, the total bid price will not be reflected on the appointment letter.

## **11. PRODUCT/SERVICE QUALITY, DELIVERY PERIOD AND PENALTIES**

All spare parts to be installed in a municipal vehicle must be original SANS approved. No counterfeit parts will be acceptable. All parts installed in the municipal vehicle must carry at least a minimum guarantee / warranty period of 90 days. All workmanship must carry a warranty of not less than 90 days. Where practical, the worn-out parts shall be traded in for discount which shall be stated on the invoice.

All vehicles referred for repairs and services must be returned for operation within 14 working days. Should the service provider deems it necessary to extend the 14 day period, such extension must be requested in writing from the Municipality. Penalties for late delivery will be 5% of the total value of works.

All the job cards, warranty information and any other report on the status of the vehicle must be submitted together with the invoice.

All value of the ex-stock / consumables must be clearly stated on the invoice.

## **12. CONTRACT DURATION**

The contract duration will be 36 months on an ad-hoc basis.
