- Municipal Statement not older than three (3) months or Lease agreement if renting premises.
- Compulsory registration with the Construction Industry Development Board (CIDB) database as 2GB or Higher

Tenders will be evaluated using the 80/20 principles of the Preferential Procurement Policy Framework Act, No. 5, 2000 with its 2017 Regulations and functionality – Tenderers Experience (30 points), Key Personnel 1 – General Foreman/ Site Technician/ Engineer (26 points), Key Personnel 2 – Electrician (26 points), Preliminary Project Plan (10 points), Locality (8 points).

Proposals that fail to achieve a minimum score of 75% will not qualify for further evaluation.
