Therefore, no bid will be disqualified for not submitting SAHPRA certificate for tender DIDMR03/11/2025 to DIDMR16/11/2025.

Kindly confirm whether the required returnables should be attached directly under each corresponding page in the tender document	It is preferable to attach directly under each corresponding page for easy reference and evaluation purposes. However, any clear sorting and clear referencing with the table of content preferred by bidder is acceptable
