1. BACKGROUND

Postbank SOC Ltd invites suitably qualified and experienced Audiovisual and Multimedia Production Agencies to submit quotations for the provision of high-quality content for television, radio, and digital multimedia platforms in support of card replacement and deposit growth campaign or until the scope of work is concluded, whichever occurs first.

2. OBJECTIVE OF THE RFQ

The procurement of the audiovisual and multimedia production services is motivated by the following strategic and operational necessities:

- Maintain consistent brand presence across channels and digital platforms
- Execute critical campaigns within required timelines
- Support immediate media and communication needs
- Mitigate operational and reputational risks associated with delayed or interrupted campaign delivery.

3. SCOPE OF WORK

The appointed agency is expected to deliver the following services over the three-month period in relation to the card replacement and deposit growth campaigns but not limited to:

1. Provide end-to-end production of:

- TV: 30 – 45 second TV commercial,
- Radio: radio recordings in ALS
- **Translation services** of all 11 languages, across multiple campaign elements not limited to Audio Visual
- **Digital multimedia assets:** Gifs, videos for different digital platforms
- Video and still cuts for social media.
- Voice over recordings by an artist appointed by the provider and voice agreed on with Postbank.
- Talent, model fees and usage right fees
- Provide raw material of recordings (video and voice over) and stills.

2. Provide broadcast-ready and digital-ready materials: final masters and editable project files; compliance with broadcast and digital platform standards.

Bidders will be evaluated on their functional capability to deliver the required audiovisual production services. Functional capability will be assessed through the following sub-components:

- a. Technical Production Capability, based on demonstrated portfolio evidence of prior work; and
- b. Production Execution based on examples of previous production work completed.

Only Bidders scoring 70 points and above out of 100 points on functionality are eligible for further evaluation

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
