2. INTRODUCTION

2.1.MANDATE

The AIDC is the dedicated developmental agency of the Gauteng Growth and Development Agency (GGDA) in relation to the specific industrial, infrastructure and training needs required by the automotive and allied sector - those based in the Gauteng province. 4. RFQ SCOPE

Due to the nature and persistent AIDC's business setup in both sites (AIDC ASP Rosslyn Site and AIDC AIC Silverton Site), emptying, desludging, and deep cleaning of the existing grease traps is constantly a need to restore and maintain the functionality of existing wastewater treatment tanks.

For this purpose, AIDC intends to appoint an experienced company with adequate resources for emptying, cleaning and desludging of oil and grease trap in wastewater treatment tank at AIDC ASP Rosslyn Site and AIDC AIC Silverton Site, Pretoria. and the grease trap cleaning and pumping service shall be carried in strict accordance with the specification provided but not limited to the following:

- a) Removal of Food Solids and excessive fat from the grease trap.
- b) The food & solids to be removed from the strainers & pumped into holding tanks for disposal.
- c) Excess fat, grease, oil, and solids in the grease trap must be pumped out into holding tanks.
- d) Fat, grease, and solids must be removed from site and disposed of in a responsible manner at the verified wastewater treatment works in accordance with legislation.
- e) To remove all grease sludge from the intake and outtake outlets (pipes) in the tank where possible.
- f) Ensure the area surrounding the grease trap is cleaned with a broom and a degreasing agent and if necessary, a high-pressure washer is used.
- g) A Service certificate of disposal is issued on every disposal.

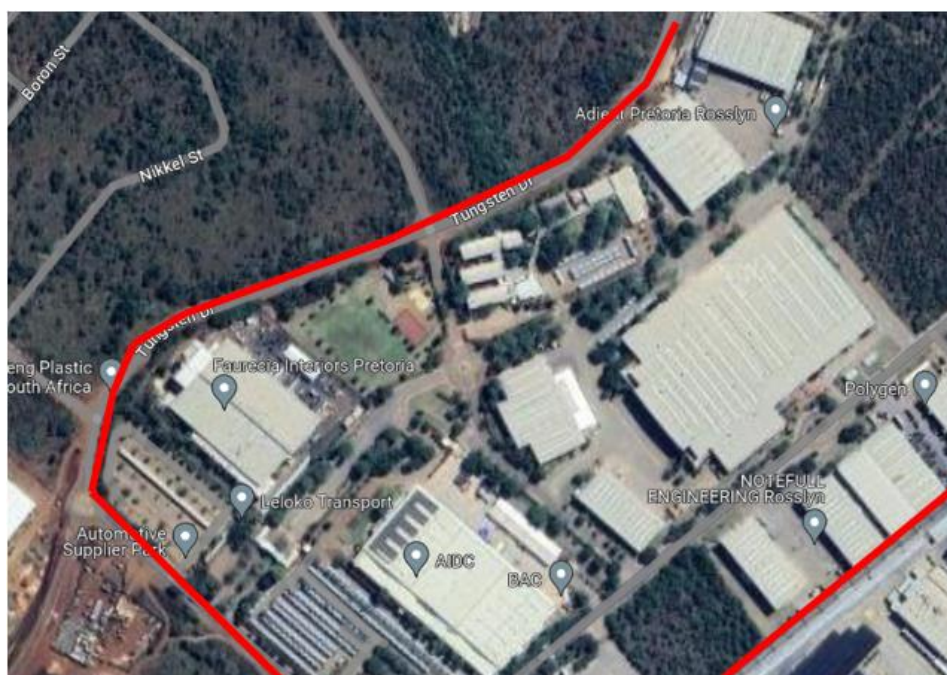
