Successful qualifying service providers would be appointed as panellist service providers. The bid will be evaluated based on administrative compliance and functionality. Preferential scoring system would only be effected when sourcing quotations from successful bidders. Bids will be adjudicated in terms of the Preferential Procurement Policy Framework Act 5 of 2000; Preferential Procurement Regulations of 2022; uThukela Water SCM Policy and other applicable legal framework, and will be based on 80/20-point system.

**Special Condition:** Preference will be given to service providers who have established their businesses within uThukela Water area of jurisdiction which covers Newcastle Local Municipality, uMzinyathi District Municipality and Amajuba District Municipality.

**Minimum functional score:** Service providers submitting acceptable tenders and scoring at least 70% on functionality will qualify to be on the panel, and the utilization will be based on as and when required basis by seeking quotes.


