INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Conservation Unit within the Mountain Zebra National Park falls under Parks Division (Frontier Region) with its mandate of conserving, protecting, controlling and managing the protected areas and biodiversity.

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal for the provision of security service and gate access control in Mountain Zebra National Park for a period of five (5) years.

CONTRACT PERIOD

The contract will be for a period of Five (05) years

SPECIFICATIONS/SCOPE OF WORK

SANParks seeks to appoint a security company for provision of security services and gate access control within the Mountain Zebra National Park.

Mountain Zebra National Park requires Grade B and C security guards to provide security service on a 24-hour basis on its entrance gate within the park. Guards will be expected to administer, control, and search incoming and outgoing persons and vehicles. The guard on duty will also be required to patrol the gate area every hour to ensure there are no incursions and that all gates and other infrastructure is functional. The security company appointed should have the capability of increasing its guard numbers at the request of SANParks.

The security company will be expected to transport the guards to and from the gate in a well-maintained vehicle. It should be noted that no accommodation is available within SANParks property.

REQUIRED PERSONEEL – Total number of 2 security guards are required, 1 x C unarmed and 1XB unarmed as shown in the table below.

RESPONSIBILITIES OF SANPARKS

SANParks shall:

- Monitor the professional security services that SANParks receives from the Service Provider.
- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Review the received monthly report and provide feedback.
- Effect payment within 30 days from the date of receipt of original tax invoices for services rendered.
- Tax invoices submitted by the service provider will not be processed with respect to any non-compliance until credit notes are received.
- In terms of the costs incurred by SANParks for non-compliance by the service provider, SANParks to submit invoice together with attendance register to the service provider with respect non-compliance.

RESPONSIBILITIES OF THE BIDDER

- The purpose of the security service is to prevent the unauthorised access of persons and vehicles and the bringing in of any dangerous objects into the Premises
- Whilst conducting access control, the security personnel provided must ensure that:
 - a) No property (including official vehicles) of SANParks is removed from the Premises without a proper letter of authorization issued and signed by a person authorised to do so; and

- b) All firearms (brought into the Premises) are declared, recorded into the appropriate register and sealed according to SANParks instructions.
- On the date of commencement of the Agreement, the Parties shall each nominate one or more persons in their respective employ as the person responsible for security and shall provide each other with the names, telephone numbers or other means of contact with such persons in the event of an emergency.
- Provide the management and expertise to manage security at the listed site in Mountain Zebra National Park (main gate area)
- Operate 365 days per annum and 366 days in leap years without interruption.
- Adhere to health and safety regulations as well as labour related laws at all times.
- The Service Provider will provide within 7 working days of commencement of
 the contract the personal details of the security staff for the site as well as
 certificates showing theory grading as registered with PSIRA and police
 clearance certificates including specialised certified training with respect to the
 guards.
- Ensure that its security personnel are always at the post at the required time per the service level agreement.
- Ensure that off-sick security personnel are replaced without interruption of the services;
- Keeps the record of daily occurrences as well as the attendance register of the security personnel on duty. Attendance Register to be signed when reporting in for duty and when leaving for the day. Register to be signed and maintained by the supervisor for monitoring;
- Ensures that the occurrence book on each site is provided, maintained and accurately filled in during the shift and scrutinized and signed off by a designated security services supervisor weekly.
- Ensure that supervisors conduct regular site inspections to ensure staff site compliance, maintain standards and check on the operation of equipment.
- Ensure that security personnel are always in full uniform and tidy;
- Ensure that staff are conversant in English given the high number of

international tourists visiting the parks facilities.

- Ensure that security personnel are well mannered and respectful at all times when on duty;
- Ensure that security personnel do not report on duty drunk or under the influence of intoxicating substances, nor drink intoxicating substances when on duty.
- Ensure that security personnel do not sleep on duty.
- Ensure that security personnel keep all relevant records (entry record, movable property record and exit record register).
- Ensure that security personnel are always available to assist in any form of emergency at the main gate.
- Ensure that management is always available to respond to any complaints from either visitors or SANParks related to security services.
- Ensure that all complaints are addressed and a formal report afforded to SANParks on how the complaint was resolved and how such will be prevented in future within 7 working days from the day of occurrence;
- Maintenance of security services standards that SANParks receives from the Service Provider; and
- Submit invoice together with the attendance register on every last day of the month to SANParks as well as credit notes for late coming and patrolling as recorded by the security monitoring system.
- Effect payment within 30 days from date of receipt of original SANParks tax invoice for non-compliance e.g. late coming and non-compliance.
- Sign off SANParks Standard Operating Procedure within 30 days after submission by SANParks
- Service provider will be required to transport guards to all sites to ensure punctual commencement of shifts
- Provide transport for their own security personnel

COMPETENCIES OF THE SERVICE PROVIDER

- The service provider shall act in good faith in fulfilling its obligations in terms of these operational requirements.
- Mountain Zebra National Park (SANParks) shall be entitled to use the findings of customer satisfaction surveys, spot-checks and audit reports or complaints to determine the level of compliance by the service provider with regard to the service standards and responsibilities stipulated in this document.

 member of the service provider's personnel is failing to comply with their
 operational requirements as described in this document, such person may be
 denied access by Mountain Zebra National Park (SANParks) to the relevant

 without delay.

GENERAL REQUIREMENTS

- All security guards must have a security clearance and must be registered as required by the Private Security Industry Regulatory Act, Act 57 of 2001 and to have a Grade C level.
- All security staff used at the site must be able to read and write and be able to communicate clearly and efficiently in English.
- A company ID card reflecting inter alia the name and training status of a particular individual is to be worn at all times.
- Security guards on duty at the site are expected to be in the complete uniform of the appointed company and must present a neat and clean appearance at all times.
- Guards are expected to present an alert and efficient image to all clients who imply that they may not publicly sit, lounge about, smoke and eat or drink while attending to people.
- Guards shall at all times present a dedicated approach to security and ensure that there are no unnecessary arguments or discourteous behaviour towards both park visitors and staff.
- Guards must be supplied with a cell phone (with paid up airtime) to ensure direct communication at any time with the control room of the service provider.

- Additional equipment provided must include a pocket book and pen as well as a baton/pepper spray and handcuffs.
- Security guards may not be younger than 18 years of age.
- The security service provider will be responsible for the staff complement at the site making sure that site is covered with agreed staff complement at all times.

OCCUPATIONAL HEALTH AND SAFETY

The service provider acknowledges that he is fully aware of the provisions of the OHS Act 85 of 1993 and that he is an employer in his own right with duties and responsibilities as prescribed in the Act.

MEETINGS AND/OR REPORTING

SANParks would require monthly meetings with the service provider as well as the monthly reports of all occurrences to follow-up of the progress of all identified factors in need of correction or improvement.

TERMINATION OF SERVICE

| | 34.1. | In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging). |

- 34.2. If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has/have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3. If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

Contracted Party Due Diligence

SANParks reserves the right to conduct supply chain due diligence including site visits and inspections at any time during the contract period.

Jigs, Tools, and Templates, where applicable

Unless otherwise agreed, all jigs, tools, templates, and similar equipment necessary for the execution of this contract is property of SANParks, if SANParks has paid for these. On completion or cancellation of the contract, the contractor delivers all SANParks property to SANParks premises, properly marked with the contract and the relevant code number as supplied by SANParks.

Copyright and Intellectual Property

All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contributing party to this contract and/or the contracted discloses the same to SANParks at the commencement of this contract. The contracted supplier grants SANParks a fully paid up, irrevocable, non-exclusive, and transferable licence to use its background intellectual property including the right to sub-licence to third parties in perpetuity and to the extent that SANParks requires for the exploitation of the contract intellectual property and to enable SANParks to obtain the full benefit of the contract intellectual property.

The parties agree that all right, title, and interest in the contract intellectual property rightly invests in SANParks and to give effect to the foregoing:

- (a) The contracted supplier hereby assigns all rights, titles, and interests in and to the contract intellectual property that it may own to SANParks and SANParks hereby accepts such assignment, and
- (b) The contracted supplier undertakes to assign in writing to SANParks all contract intellectual property and which may invest in the contracted supplier.

The contracted supplier shall keep the contract intellectual property confidential and shall fulfil its confidentiality obligations as set out in this document.

The contracted supplier shall assist SANParks in obtaining statutory protection for the contract intellectual property at the expense of SANParks wherever SANParks may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause.

The rights and obligations set out in this clause shall service termination of this contract indefinitely.

Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.
- (b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

- (a) Disclose the confidential information to any third party, or
- (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in

documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
