Tenders must be placed in the Municipal Tender Box before **11h00 on 17 May 2024** situated at the Supply Chain Management Offices, 11 Lind Street, Swellendam after which tenders will be opened in public. Tenders may only be submitted on the prescribed tender documents and must include the Tax Compliance Status **PIN** as issued by **SARS**.

Late tenders and tenders received by E-Mail or Facsimile will not be considered. Tenders will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and it's Supply Chain Management Policy. The **80/20**-point system will be applicable. The Council does not bind itself to accept the lowest or any bid and reserves the right to accept a tender in full or a part thereof. Subject to the sole discretion of the Municipality, failure to supply all supplementary information and documentation may result in the tender being rendered non-responsive

**Special Conditions of tender:**

- Bidders to have at least **three years appropriate experience** in the printing and distribution industry – proof of which must be submitted with the tender document. Provide **3 contactable references**.
- The bidder must be in possession of **a license** from the Postal Services to distribute bulk accounts (postage) – proof of which must be submitted with the tender document. The Municipality will pay the postage direct to South African Post Office
