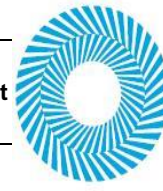

This cost to include traveling costs but to exclude material, which has previously been dealt with in this contract.	PER ARTISAN/ HR	R
6	The contractor is to tender his total cost per hour per artisan and labourer to perform Air conditioning (HVAC) Repairs work on a <b>Sunday and public holiday</b> described as (Sundays 00:00 to 23:59). This cost shall be averaged between the furthest and the closest building covered in terms of this contract this cost to include traveling costs but to exclude material.
