TERMS OF REFERENCE FOR THE PROVISION OF AVIATION FUEL SUPPLY AND DISPATCH AT POLOKWANE INTERNATIONAL AIRPORT.

1. SCOPE OF WORK:

GAAL seeks to appoint a company with excellent track record on provision of supply and dispatch of the aviation fuel to the aircrafts on behalf of Polokwane International Airport.

1.1. The services required are as follows:

- a) The service provider must be able to perform refuelling services to all aircraft that need either AVGAS or JET A1 fuel.
- b) Provide the AVGAS mobile tank of 10 000 L minimum.
- c) Be able to provide and store JET A1 for a minimum of 30 000 L.
- d) Be able to store and refuel the aircraft within the appropriate and compliance aviation standard and regulations.
- e) Develop and implement refuelling procedure in line with South African Civil Aviation Technical Standard (SACATS) PART139.01.23(2) for approval by airport authority.
- f) Develop and implement procedure for handling of fuel spillages.
- g) Demonstrate how the airport will be benefiting per every litre sold.
- h) Provide monthly billing report and supporting invoices to the airline for verification by airport management.
- i) Service provider must conduct environmental impact and continue performing Environmental Assessment to the area and the systems and provide the report to airport authority.

1.2. The following are to be provided by the service provider:

- a) Trained refuelling personnel
- b) Mobile tank for AVGAS of minimum 10 000 L
- c) Provide a fuel bowser of minimum capacity 30 000 L for JET A1

- d) Roadworthy Tractor/ truck to be used for towing JET A1
- e) Serviceable Fire extinguishers
- f) Service level agreement for servicing, maintenance and calibration of the refuelling system
- g) Liability Insurance cover for a minimum of 100 million
- h) Monthly billing report and copies of invoices to the airport authority.
- i) Payment according to the agreed terms to be done 7 days after month end.
- j) Procedure for Handling of Fuel Spillages.
- k) Procedure for refuelling in line with South African Civil Aviation Technical Standard
- l) Providing Airside Vehicle Operators Permit (AVOP) for the personnel.

Space to operate administrative services where the service provider will bring their own mobile office.
