4 Authorised Signatory

1. SCOPE OF WORK, ACTIVITY SCHEDULES AND FORM OF OFFER

DESCRIPTION OF WORKS (SERVICES)

1.1 INTRODUCTION

The JB Marks Local Municipality is the owner of three regional waste disposal facilities. These waste disposal facilities are:

- Felophepa Landfill Site: Potchefstroom
- Ventersdorp Landfill Site: Ventersdorp
- Garden Refuse Transfer Station: Potchefstroom

Private contractors who presently operate above-mentioned facilities are appointed by the municipality for a period of three years. The disposal facilities handle a total waste load per month In order to ensure that these facilities are operated in an environmentally sound manner and that these facilities have the least possible impact on surrounding communities.

The waste management section does the collection, transportation and disposal of waste according to the applicable legislation and license conditions.

1.2. SCOPE OF WORK

It is expected that the successful service provider must be able to render the following services:

1.2.1 Provide waste trucks, rear end refuse compactor trucks with bin lifters and skip loaders trucks, with an operator, as specified in the specifications for the collection, transportation and disposal of waste of general waste in the Potchefstroom region.

1.2.2 The trucks must be roadworthy and comply with the applicable legislation at all times.

1.2.3 Must comply with the Occupational Health and Safety Act at all times.

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
