Bidders are not required to submit any information or documentation for this requirement. The bid evaluation committee will apply this requirement during the bid evaluation process by checking if the bidder has a valid contract with the RAF in respect of Cloud Migration Services. If the bidder has a valid contract in cloud migration and support, the bidder will be disqualified.
