Work specification (and Technical specification s)	<p>1. Project Background</p> <p>The Greening of the selected Early Childhood Development Centre is a SANEDI-funded project sponsored by the National Development Agency (NDA) under a partnership agreement between the two organisations. The objective of the partnership is to SANEDI to demonstrate the benefits of integrating clean energy technologies in the social development initiatives supported by the Department of Social Development under the banner of the National Development Agency (NDA).</p> <p>In this regard, a number of institutions which fitted the criteria set out were identified by the NDA to SANEDI, from which the Thusanang ECDC was selected in the Gauteng Province. In respect of Thusanang, and in order to operationalise the project on the ground, SANEDI entered into a Project Agreement with Thusanang Early Childhood Development Centre (the Centre) for the procurement of service providers to implement the project on its behalf at the centre. To date the project has delivered the following green technologies:</p> <ul style="list-style-type: none"> • 2 x 200 Liter low pressure SWH's • 15m3 Biogas digester System • Water Purification System for the lime filled groundwater

- Energy efficient lighting (indoor and outdoors)
- Rainwater Harvesting Tanks and systems
- Cools surfaces on the main building with the rest of the buildings as control / reference sites.

The project was completed and was launched during Mandela Day Celebrations in 2015. This was the first of its kind projects implemented in the ECDC and a lot of improvement came about in subsequent projects where the quality, specifications and training were done better as SANEDI's Working for Energy Programme evolved.

During the operation of the project a number of installed technologies have since failed whilst others are operating well below expected performance specifications. These challenges are due to various factors such as failure to follow strict operational and maintenance procedures by the management of the centre.

The first repairs were achieved in 2018 and SANEDI managed to resuscitate the systems to their full operational state. However, in 2021 SANEDI received a complaint that the technologies installed had once more failed and urgently required maintenance and repair. The failure of installed technologies has compromised ability of the Centre to execute its mandate since the systems are interlinked with services necessary to render education to the children. There is therefore a need to take stock of the lessons learned and resuscitate the systems to their fully operational state as a matter of urgency. SANEDI has the social responsibility to do a second and last resuscitation of the systems installed and removal of the damaged systems will compromise the center in rendering services.

2. Scope of Works

Site assessment was conducted by SANEDI project managers, and the following conditions were discovered, and recommendations were made accordingly. The below table outlines the current situation of the site and the rehabilitation measure proposed for implementation.

1.2 Preference Points applicable:

1.3 Points for this tender shall be awarded for:

(a) Price; and

(b) Specific Goals.

1.4 The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 SANEDI reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the SANEDI.

2. DEFINITIONS

- (a) “tender” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “price” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “rand value” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “tender for income-generating contracts” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
- (f) “B-BBEE” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (g) “B-BBEE status level of contributor” means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
