1. INTRODUCTION AND PURPOSE

Procurement of Supply and delivery of Maintenance and gardening tools equipment for council managed Early Childhood Development centres in Region 3&6.

The need for the procurement of garden tools and maintenance equipment arises from the ongoing responsibility to ensure that Early Childhood Development (ECD) centres are maintained in a safe, clean, and child-friendly condition. Special workmen play a critical role in maintaining the physical environment of the centres, which directly impacts the health, safety, and wellbeing of children and staff.

Currently, several centres experience challenges such as overgrown grass, unmaintained gardens, broken or poorly maintained infrastructure, and inadequate cleaning of outdoor areas, mainly due to a lack of appropriate tools and equipment. Without the necessary resources, routine maintenance tasks such as grass cutting, waste removal, minor repairs, and upkeep of play areas cannot be effectively carried out.

2. BACKGROUND

The Department, Community and Social Development Services carries the responsibility of providing required resources to Eight Council managed Early Childhood Development Centres in Region 3 and 6.

The procurement is therefore required to:

Ensure compliance with health and safety standards applicable to ECD facilities.

Support the creation of a safe outdoor environment, free from hazards such as sharp objects, overgrown vegetation, and unsafe play equipment.

Enable Special workmen to perform daily maintenance, gardening, and minor repair functions efficiently and effectively.

Promote environmental sustainability initiatives, such as food gardens and proper waste management.

Improve the overall appearance and functionality of ECD centres, creating a conducive environment for learning and development.

Furthermore, the availability of appropriate tools will reduce reliance on external service providers for minor maintenance, resulting in cost savings and improved turnaround time for addressing maintenance issues.

In summary, this procurement is essential to ensure that all ECD centres operate in a compliant, safe, and well-maintained environment, thereby supporting quality service delivery and positive developmental outcomes for children.

3. PROJECT SCOPE

The scope of this project is for the supply, delivery, and off-loading of maintenance and gardening tools for Council-managed Early Childhood Development (ECD) Centers.

The required tools will be utilized by Special Workmen and authorized personnel to carry out routine maintenance, minor repairs, cleaning of external areas, landscaping, gardening, and general upkeep of ECD facilities. The procurement is aimed at ensuring that all centers are maintained in a safe, clean, functional, and child-friendly condition.

- Provision of warranty/guarantee where applicable for mechanical or power tools.
- Compliance with applicable occupational health and safety standards.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
