INTRODUCTION TO THE NRF

The National Research Foundation ("NRF") is a Schedule 3A statutory entity established in terms of the Public Finance Management Act, No. 1 of 1999, as well as the National Research Foundation Act, No. 19 of 2018, as amended. The National Research Foundation will contract with the appointed bidder, through its business unit, the South African Radio Astronomy Observatory (SARAO), described below. Visit the NRF website (https://www.nrf.ac.za) for more information.

BACKGROUND TO SARAO

SARAO is a business unit of the NRF, incorporating South Africa's radio astronomy instruments and programmes such as the MeerKAT and KAT-7 telescopes in the Karoo in the Northern Cape, the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng, the African Very Long Baseline Interferometry (AVN) programme in nine African countries as well as the associated human capital development and commercialisation endeavours. BACKGROUND TO THE BID

There are two interrelated bids that are advertised. One bid is to find a client management service provider that market and sell radio devices, and also complete the installation. The other bid is to find a supplier of Low Band Radio devices that must also configure the radios.




Figure 1: Relationship between two bids advertised

The installation will be done in the vehicle of the farm owner after the radio configuration. The configuration will be done based on the onsite radio infrastructure.

PART A – THE TENDER

CONTEXT OF THE PROCUREMENT NEED

The Square Kilometre Array (SKA) project is an international effort to build the world's largest radio telescope. The SKA is not a single dish telescope, but a collection of telescope stations called an array, to be spread over long distances. The Astronomy Management Authority (AMA) is a directorate of the Department of Science & Innovation. AMA is designated by the Minister to be responsible for the management of the declared Karoo Central Astronomy Advantage Areas (KCAAAs) in terms of the Astronomy Geographic Advantage Act, 2007 (the AGA Act). The KCAAAs are protected by means of KCAAA Regulations for the purpose of radio astronomy and related scientific activities. More information about the AMA, AGA Act and KCAAA Regulations is available on www.dst.gov.za/ama/ or https://ama.dst.gov.za/.

The Regulations are limited to what is reasonably necessary to protect the scientific integrity of the SKA telescope as a priority, while other fundamental rights are also protected in so far as it is reasonably possible. The financial cost which directly results from the need to protect the SKA telescope is paid back by the Minister responsible for Science and Innovation. The Regulations protect scientific activities from radio frequency interference (RFI) emitted by radio communication services such as cellular phones or WiFi over long distances, and electromagnetic interference (EMI) of electrical equipment emissions over a shorter distance.

DIGITAL MOBILE RADIO

The Karoo community has been using a mobile trunk radio system since 2017. A new radio network has been deployed that can be used by the Karoo community. The high site infrastructure consists of Digital Mobile Radio (DMR) repeater of Phase 1 and Phase 2A.




Figure 2: DMR high site infrastructure

Phase 1 is for use by SKAO/SARAO/Contractors for operations and safety. Phase 2A is for local community use with the same coverage as for Phase 1. High sites are connected via 26GHz microwave link. Three high sites are powered via solar system. The SKAO installed new high mast in areas that previously did not have high mast. Community members near the high sites will receive the mobile radio signal for communication.

SERVICE SPECIFICATIONS

The service specification is for end-user devices that will function with the high site infrastructure that is already deployed. The radio communication will not happen if the end-user devices are different from what has been specified.

- 1. Bidders must supply mobile radio devices that operate on the eDMR networks.
- 2. DM3G Modem shall operate on the eDMR networks.
- 3. DM3G Modem shall operate in the low frequency bands from 33 to 50 MHz.
- 4. Speaker and Microphone for Two Way Radios shall be connected to DM3G modem.
- 5. DM3G Modem shall connect to the 40MHz Mobile Antenna.



- 6. A mobile radio shall make open channel calls.
- 7. A mobile radio shall make individual and private calls.
- 8. A mobile radio shall make group calls.

- 9. A mobile radio shall make PSTN incoming and outgoing calls.
- 10. A mobile radio shall transmit SMS (Short data messages).
- 11. A mobile radio shall be powered by a rechargeable polymer lithium battery rechargeable when mounted on its support.

BID SELECTION

STAGE 1 – SUBMISSION OF RETURNABLE DOCUMENTS AND SCHEDULES

Bids which meet the minimum requirements in Stage 2, will be ranked on price and preference in the following manner -

- (ii) Preference specific goals as claimed in the preference claim form (SBD 6.1) are added to the price scores. Bidders' BBBEE level as evidenced by their BBBEE certificates/sworn affidavits, will represent 'specific goals'.

PART A.1 – BID PREPARATION

	BIDDING INSTRUCTIONS
1.	Late Bids
1.1	Bids received after the closing time and/or date will not be considered.
2.	Authority of Bid Signatory
2.1	The bid must be signed by a person duly authorised to do so.
3.	Clarification of the Bid Document
3.1	Clarification of any aspect of this bid document may be directed to the SARAO representatives listed on the cover page of this bid document.
3.2	Responses to bid clarifications will be provided in writing, and where relevant to other prospective bidders, will be shared with all such bidders, provided they are identifiable, i.e. bidders who have attended a tender briefing session.
3.3	The last date for the submission clarification questions shall be three (3) working days from the closing date of the tender.
4.	Bid Preparation Costs
4.1	Bidders will be responsible for all costs associated with the preparation and submissions of their bids.
5.	Tender Briefing Sessions and Site Visits
5.1	Where applicable, the arrangements for a compulsory / non-compulsory tender briefing session and / or site visit are as stated on the Invitation to Bid.
5.2	Bidders should be represented by a person or persons who are suitably qualified and experienced to comprehend the aspects of the work involved.
5.3	Where the briefing session or site visit is compulsory, bidders not represented at such briefing session or site visit will be precluded from submitting a bid.
6.	Counter Proposals
6.1	No counter proposals will be accepted.
7.	Alterations to the Bid Document
7.1	Bidders may not make any alterations or additions to the content of this bid document, except to comply with instructions issued by SARAO. Any alterations made to the content of this bid document other than those mandated by SARAO will invalidate a bidder's submission.
8.	Submitting a Tender Offer
8.1	Bidders may submit one tender offer only, either as a single tendering entity or as a member of a joint venture or consortium, unless otherwise stated in this bid document.
8.2	Bidders must return all returnable documents and schedules (refer to Bid Selection Process – Stage 1), after completing them in their entirety, preferably electronically, or by writing legibly in non-erasable ink.
8.3	Each party to a joint venture or consortium must complete and submit the SBD returnable forms included in this bid document, and submit each returnable document required.

8.4	The bid document must be submitted in its entirety.
9.	Alternative Tender Offers
9.1	Unless otherwise stated in this bid document, alternative tenders offers may only be submitted if a main tender offer, strictly in accordance with all the requirements of the bid documents is also submitted, as well as a schedule that compares the requirements of the bid document with the alternative requirements proposed.
9.2	An alternative tender offer must be based only on the criteria stated in this bid document, or criteria otherwise acceptable to SARAO.
9.3	An alternative tender offer will only be considered if the main tender offer is the winning tender.
9.4	For the purposes of this Tender (Reference No NRF/SARAO SAGA/82/2024-25) no alternative bid offers will be accepted.
10.	Clarification of Bid Submissions
10.1	During the bid evaluation or adjudication stages, SARAO may, in writing, require bidders to clarify any aspect of their bid submission. This may include providing a breakdown of rates or prices.
10.2	No change in the competitive position of bidders or substance of the tender offer may be sought, offered, or permitted.
10.3	A bid will be considered non-responsive where a bidder fails to respond, within such time frame granted by SARAO, to any written request for clarification, and such failure renders it impossible for SARAO to clarify any ambiguities in the bid submission and evaluate the bid submission any further.
11.	Two Envelope System
11.1	SARAO utilises the two-envelope system to minimise any form of price bias in the functionality evaluation stage of bid selection.
11.2	Bid responses must be submitted in two sealed envelopes, alternatively two electronic folders (if submissions are required to be electronic); the first envelope/folder shall contain the technical and compliance response and the second shall contain the pricing response.
11.3	Bidders must package their bid as follows:

11.4	Bidders must ensure that they do not include any pricing details in the first envelope/folder, as SARAO reserves the right to disqualify such bids.
12.	Central Supplier Database Registration
12.1	No award may be made to a bidder who is not registered with the National Treasury Central Supplier Database (CSD).
12.2	Bidders not registered with CSD are not precluded from submitting bids, but must be registered prior to award of the bid.
13.	<u>Tax Compliance</u>

13.1	No award will be made to a bidder who has a non-compliant tax status with the South African Revenue Services (SARS).

13.3	In the event that a bidder has a non-compliant tax status, SARAO will grant such bidder seven (7) working days within which to rectify its tax matters with SARS so that it is compliant, failing which its bid will be disqualified. not be in order, and the bidder fails to ensure that its tax matters are in order within a minimum of 7 days, or within such extended timeframe as may be granted by SARAO in writing.
13.4	SARAO may extend the 7-day period referred to in clause 13.3 above, where reasonable and at its discretion.
14.	Due Diligence during Bid Evaluation
14.1	During the evaluation stage, SARAO reserves the right carry out such due diligence on shortlisted bidders as it may deem necessary, which due diligence may include requiring shortlisted bidders to submit reference letters from clients for whom similar services have been provided.
14.2	Where reference letters are requested, they must comply with performance indicators specified by SARAO, specific to the bid under consideration.
14.3	SARAO reserves the right to disqualify a bid where reference letters provided do not satisfy the performance indicators specified; or where the outcome of any other due diligence exercise presents a substantial risk to SARAO should the bidder be appointed.
15.	<u>Invalid Bids</u>
15.1	Tenders shall be invalid if –
15.1.1	In a two-envelope system, a bidder fails to submit both a technical proposal and a separate financial offer.
15.1.2	The bidder is listed on the National Treasury's Register for Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, or has been listed on the National Treasury's List of Restricted Suppliers and who is therefore prohibited from doing business with the public sector.
15.3	The bidder has been restricted from doing business with any Organ of state.
16.	Imbalance in Tendered Rates
16.1	In the event SARAO declares tendered rates or lump sums to be unacceptable because they are either excessively low or high (in comparison to the SARAO market price range determination), or not in proper balance with other rates or lump sums, the Bidder may be required to produce evidence and advance arguments in support of the tendered rates or lump sums objected to. If, after submission of such evidence and any further evidence requested, SARAO is still not satisfied with the tendered rates or lump sums objected to, it may request the Bidder to amend these rates and lump sums along the lines indicated by it.
	The Bidder will then have the option to alter and/or amend the rates and lump sums objected to and such other related amounts as are agreed on by SARAO, but this shall be done without altering the Contract Amount.
	Should the Bidder fail to amend the Tender in a manner acceptable to SARAO, SARAO may reject the Tender.
17.	Price Negotiations Prior to Award
17.1	The award of the tender may be subject to price negotiations with the preferred bidder or bidders, where there are opportunities to realise cost savings, or where bid prices are not considered reasonable or market related.

18.	Cancellation of the bid prior to award
18.1	SARAO reserves the right to cancel this bid at any time before award, where -
18.1.1	Due to changed circumstances there is no longer a need for the services specified in this bid.
18.1.2	Funds are no longer available to cover the total envisaged expenditure for the project.
18.1.3	No bids meet the required specifications.
18.1.4	There is a material irregularity in the bid process.
19.	Bid Award
19.1	The tender will be awarded to the bidder with the highest combined score for Price and Preference, unless other objective criteria, specified in the bid document, applies.
19.2	The award will be subject to final verification of the bidder's tax compliance status.
19.2	The award will be subject to the outcome of any due diligence review of the recommended bidder.
20.	Collusion, fraud and corruption
20.1	Any effort by a bidder to influence the evaluation of bids or the award decision in any manner will result in the disqualification of that bidder's bid.
20.2	The NRF/SARAO would never offer payment or any other consideration in return for the favourable consideration of a bid. Please report any suspected acts of fraud or corruption to the following toll-free number - 0800 701 701 or SMS 39772.
21.	<u>Fronting</u>

7.2	The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
