1. INTRODUCTION

The Council for Geoscience (CGS) is a schedule 3A public entity organization as defined by the Public Finance Management Act (Act 1 of 1999). The CGS derives its mandate from the Geoscience Act 100 of 1993. The objectives of the CGS under the Act, is to produce world-class geoscience knowledge products and to render geoscience-related services to the South African public and industry. The strategic position of the CGS is to ensure that its activities contribute to the national imperatives, namely, to free the potential of individuals by improving the quality of life of all citizens, assisting in the growth and wealth of the country and eradicating poverty especially in the rural areas of South Africa. It does this through the mandate of the Geoscience Act, which includes the following activities:

- 1.1. To systematically document and compile the geology of the earth's surface and continental crust, including offshore areas within the territory of South Africa.

CSG seeks to appoint of a service provider to supply and deliver two (2) new Gravity Meters. These two (2) new gravities meters, also known as “Gravimeters”, as part of its asset recapitalization plan, which seeks to replace critical equipment, to fulfil the organization’s mandate and help it to achieve its strategic objectives. A gravimeter is a geophysical measuring instrument used to measure the gravitational field of the earth at specific locations. As part of the Council for Geoscience’s ground geophysics team’s resources, gravimeters are an essential and very specialized equipment types that needs to be available and in good working order. Gravimeters are in high demand for the Council for Geoscience in both its internal programs and commercial projects. Currently, the Council for Geoscience is running several dolomite stability assessment projects, as well as the usual adhoc geotechnical assessment studies, and other projects which are fully based on gravimetric surveys. Successful completion of these projects depends on the availability of resources such as gravity meters and competent personnel. As such, it is highly important for the organization to ensure that these goods are procured and delivered so that its programs are not severely impacted

25. FORCE MAJEURE

- 25.1.
