The South African Postbank SOC Limited has adopted the International Financial Reporting Framework and it is required to prepare annual financial statement as required by the companies Act and PFMA. In order to comply with the adopted framework and meet the National Treasury reporting deadlines, the use of consultants is required to prepare 2025/26 financial statements due to capacity constraints.

2. OBJECTIVE OF THE BID

The objective of the bid is to appoint a suitable service provider to prepare annual financial statements for Postbank for the 2025/6 financial year. The approved service provider will be engaged by Postbank to provide prepare annual financial statements for Postbank for the year ended 31 March 2026 and preparation of the National Treasury GRAP AFS template for 31 March 2026, this will be once off project. The performance of the service providers will be monitored on a regular basis and in cases of non-performance, will be subject to termination of services. The required services providers should have extensive experience in financial statements preparation.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
