THE MECHANICAL REFURBISHMENT OF THE DEMINERALISATION AND CONDENSATE POLISHING REGENERATION PLANTS IN THE KENDAL WATER TREATMENT PLANT (WTP) FOR A PERIOD OF 3 YEARS.

You are hereby notified that invitation to tender as well as other documents related to tender number E1005GXMPKEN will be discussed and clarified during the **compulsory clarification meeting** with representatives of Eskom as follows:

A **non-compulsory site visit** with representatives of Eskom will take place after the clarification meeting as follows:

Tenderers must confirm their intention to attend the clarification meeting and site visit with the Eskom Representative by **Wednesday 05 March 2025 at 12h00 midday**, stating the name, position and contact details of each proposed attendee. There will be a short safety induction that will take place prior to the site visit.

**Please note that attendance at the clarification meeting is compulsory. Suppliers who do not attend the compulsory meeting will be disqualified and will not be evaluated further.**

Suppliers are encouraged to re-visit the Tender Bulleting and National Treasury e-Portal regularly for any additional information pertaining to the enquiry.

### **Access to Kendal Power Stations**

Kendal Power Station is recognised as a national key point. To ensure operations are not disrupted, only authorised personnel will be allowed access to Kendal Power Station. This is in the form of a Kendal access permit or a visitors form appointment, sent in advance to reception.

Upon arrival at site kindly submit your proof of identification (South African ID, Passport or Valid Driver's License. Eskom employees may provide their Eskom ID).

The guest will be required to declare any equipment that will be taken into the station by means of populating the equipment sheet.

Once access is granted to enter the Power station, a one-day permit sticker will be issued to the guest to keep visible for the duration of their visit.

Upon entering the station passengers will need to exit their vehicle and enter through the turnstiles. Drivers will proceed to the boom gates. Prior to access being granted, the following will take place:

1. Permit will be requested and validity confirmed
2. Bag search and bodily search using a handheld metal detector will take place.
3. Alcohol screening will be conducted
4. Vehicles will be searched

Once the guest has been searched and alcohol screening is negative, will they be given access into the station

Upon exiting the station, the guest will need to submit their temporary permit and be subjected to the same searches mentioned when entering the station.

Guests attending the site visit must ensure that they have the appropriate personal protective equipment (PPE) to enter the water treatment plant work area. Please take note that attendees will need to bring their own PPE and will not be granted access to the plant without the prescribed PPE, this may include but not be limited to:

1. Hard hat
2. Ear plugs/ Earmuffs
3. Safety shoes
4. Overalls
5. Goggles
