# **TERMS OF REFERENCE:**

## SUPPORT CONTRACT TO THE ARC HEWLETT PACKARD ENTERPRISE EQUIPMENT FOR A PERIOD OF TWELVE (12) MONTHS

#### 1. OVERVIEW

The Agricultural Research Act 86 of 1990 (as amended) established the ARC, a premier agricultural research institution in South Africa. It is a schedule 3A public entity in terms of the Public Finance Management Act 1 of 1999, amended by Act 29 of 1999.

#### 2. INTRODUCTION

In 2013 the ARC renewed its ICT server & data storage infrastructure. Included in the initial procurement requirements was a three-year support contract. The support agreement was for three years and has come to an end in February 2016.

#### 3. REQUEST FOR QUOTATION

The purpose of this TOR is to appoint a qualified service provider with experienced specialists in supporting the ARC's Hewlett Packard Enterprise (HPE) equipment. This support contract will be for a period of twelve (12) months on a time and material basis.

#### 4. BACKGROUND TO THE BUSINESS SPECIFICATIONS

The ARC needs support and maintenance of the HPE infrastructure environment on a time and material basis. The ARC has adopted VMware as its virtualization platform. The majority of the virtual servers is being deployed under VMware. The deployed VMware versions is 6.0. An experienced partner is therefore required to support the ARC HPE infrastructure environment.

The hardware technologies that needs to be supported under the contract are listed below :

- Tape libraries
