We are seeking information on the metal alloy self-support (MASS) fibre for exiting transmission lines. Currently in Eskom the fibre optic cable network constitutes an integral component of the Eskom telecommunications network and thereby supports the provision of bandwidth and reliable telecommunications services as required by Eskom's business systems. Over 3000 km of the network is ADLashTM cable which has reached end of life and the optical performance has deteriorated. This fibre cable needs to be replaced.

The scope of work will entail further investigation into the MASS fibre more so from a line-line installation perspective. Below is a list of questions to the market which will cover any further uncertainty regarding MASS fibre deployment. The questions are categorised into three parts, general questions, supplier profile details and Eskom's requirements.

The tenderer must submit the tender as a complete original tender, plus one (1) **hard copy** of the original tender at tender submission deadline. Eskom may also require that one (1) additional complete soft copy of the original tender is required in electronic format.

Where a Tenderer does not submit 1 hard copy of the original tender at tender submission deadline, the tenderer will be disqualified.
