GRADING CLARIFICATION

All tenderers must be registered with CIDB with a minimum grade of **6GB or higher class** of construction work, and the CRS number must be submitted with the tender. A **5GB class** of construction work will not be considered as erroneously advertised on the CIDB portal.

RESPONSIVENESS EVALUATION ON PRE-QUALIFIERS

Tenderer must have successfully completed a minimum of **3 Heritage Restoration Projects of similar nature** in the last 10 years, each with a value greater than R10m.

As proof of the above the tenderer is required to submit letter(s) of appointment on the client's letterhead, showing the appointment value and corresponding practical completion certificate(s) of the same project(s).

Is Replaced by

Tenderer must have successfully completed a minimum of 3 Restoration Projects of which 1 is a Heritage Restoration Project of similar nature in the last 10 years, all with a combined of value greater than R10m.

As proof of the above the tenderer is required to submit letter(s) of appointment on the client's letterhead, showing the appointment value and corresponding practical completion certificate(s) of the same project(s).
