INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by excelling in the management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

This BID will be led by the Table Mountain National Park Management team. Table Mountain National Park was proclaimed in 1998 (then the Cape Peninsula National Park), managed by South African National Parks. The Park is located in the City of Cape Town in the Western Cape Province in the Republic of South Africa.

CONTEXT OF THIS PROCUREMENT

CONTRACT PERIOD

The contract will be for a period of **18 months (1.5) years**.

SPECIFICATIONS/SCOPE OF WORK

South African National Park seeks a service provider to run a 1.5-year communications advocacy campaign focused on Table Mountain National Park ending March 2026. The focus areas of the campaign are:

- 1) “Positive Relationship” Campaign design (integrated activations) and implementation: Based on the stakeholder analysis and broader Public Relations Strategy / thought leadership informants, propose a communications advocacy campaign (integrated activations) that will deliver a positive working relationship between these stakeholders and SANPARKS. The expectation is that this is not advertising. The expectation is a campaign that sets up a positive relationship building space for SANParks leaders and the stakeholders to build their relationship over the 2025 – 2035 period. This may include internal capacity building recommendations as well. There is an expectation of meaningful engagement with stakeholders. This campaign is to be informed by:
 - 1.1. Stakeholder mapping and analysis: Work with SANPARKS leaders to identify priority stakeholders with whom they would like to build positive working relationships critical for the success of their 2025 – 2035 Management Plan. The expectation is a stakeholder framework baseline, including a relationship map indicating degree of significance and importance for “Positive Relations” between the SANPARKS and the respective stakeholder groups. This analysis is to be underpin the rationales used in the campaign proposal. The identified groups will be the focus of relationship building in 2025 – 2035.
 - 1.2. Review of existing Public Relations, positive relationship building, Strategies for SANPARKS. The expectation is to review the existing strategies (what must stop, what must start, what must continue) to inform the campaign design.

1.3. Post campaign comms collateral production, per thematic focus area, for use in SANPARKS Comms strategy 2025 – 2035: Produce content, stories, social media content, videos, pictures, graphics. The expectation is the production of pictures, videos and graphics based on the content produced for the campaign activations.

1.4. Project specific, on the ground, interpretation solutions: Develop on the ground interpretation solutions as directed by the individual project plans. There are 15 projects being implemented, with some of them requiring site specific, on the ground, interpretation. The expectation is consistency in content, messaging, look and feel per activation, using the SANParks Brand and Interpretation guidelines.

2) The solution and implementation of a proposed solution must be aligned to SANParks overall approach. In addition, SANParks protocols in relation to accountability lines and approvals will apply throughout the implementation of an approved solution and approach.

RESPONSIBILITIES OF SANPARKS

SANParks shall:

- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Review the monthly report and provide feedback.
- Effecting payment within 30 days from date of receipt of original tax invoices.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

1. Definitions - The following terms shall be interpreted as indicated:
