4 BUSINESS REQUIREMENT SPECIFICATION

Background:

We would like to have the employee information as well as the performance and 360 reviews on one system, that is also able to give us different reports with the help of its modules on learning management, performance reviews and leave, so that we are able to optimize our HR procedures and make informed decisions regarding our employees.

Information needed:

Interfront is seeking an HR platform to minimize manual administration.

Essential modules should include Personnel information, performance management, 360 employee review, and reporting.

Optional modules for future integration: Personal development plans, career succession planning, training, recruitment, on and off-boarding, reporting on payroll, salary and leave, rewards recognition, and e-learning.

Provide information about SLA's (tiers) and response times related to support hours.

Demo to be provided of the recommended system featuring integration of the system between modules, as well as automation features.
