SPECIFICATIONS

iThemba LABS is seeking for a service provider to supply video conferencing hardware and installation of it in a boardroom.

Boardroom:

The size of the boardroom is 4220mm (width) x 9800mm (length) x 2650mm (height).

However, the area of the front wall where the screens needs to be installed is 3800mm (width) x 2650mm (height) i.e. from wall to the metal strip next to the door -see picture 1.

The front wall is a dry wall and correct fixers are needed to fix the screen brackets and screens to it and all other components.

The camera needs to be fixed below the screens at 1100mm from the floor.

The NUC computer that will be supplied, the network POE switch, roomcast wireless projection device and HDMI splitter must be installed behind the screens.

A network point will be supplied on the front wall.

One ceiling microphone will be fixed to a ceiling panel in one half of the room and the other microphone in the other half of the room.

Both soundbars will be fixed on the front wall.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
